Evans's Estate and disallowed by the Ex<sup>rs</sup> of Ebenezer Howell therefore for the final Adjustment of the foregoing demand by the said Executors of the Estate of John Evans and to prevent further or future dispute or controversy thereon or respecting any parts thereof It hath

been agreed by Whosoever the Subscribers to pay the balance at any time the Estate of John Evans due to the Estate of Ebenezer Howell due at this day to Fifty pounds five which John Evans as one of the Exors of the Estate of John Evans hath given his obligation this 2<sup>d</sup> day of April 1791 - Witness our hands
