Suddenly there was a shot. Hipkins, followed by the screaming Mrs. Decker, rushed upstairs to find Decker on the floor. A 12-gauge shotgun was by his aide. At the time Decker was still alive but unconscious. He was taken to the hospital and died shortly after 11 oʻclock.




