VETO MESSAGE

April 4, 1941

The Honorable, the House of Representatives, The 108th General Assembly of the State of Delaware, Dover, Delaware.

Gentlemen:

I return to you herewith, without my approval, House Bill No. 333, entitled:

An Act making Appropriations for the Payment of Certain School Bonds Maturing during the Fiscal Years beginning July 1, 1941, and ending June 30, 1943.

My intention was to veto only the portion of this bill applying to the second year, July 1, 1942, and ending June 30, 1943. However, by Section 5 of the bill, it is provided that no tax shall be "levied or collected for the purpose of paying the principal of the bonds" becoming due in the next two fiscal years in the various school districts mentioned in this bill. Thus, should I disapprove only the items of appropriations for the fiscal year beginning July 1, 1942, and ending June 30, 1943, the affected districts could not provide the funds necessary to pay the principal of their bonds maturing during said year.

There is another reason for the return of this bill unapproved. I am reliably informed that the revenue of the State is diminishing even beyond estimates most recently furnished. Obviously some provision must be made to meet this unexpected loss of revenue. Redemption of bonds such as contained in this bill by the State Government is little different from the payment of improvements by direct appropriations.

However, because of the precedent which has been established during the past years, I believe that the appropriation suggested for the redemption of school bonds for the next ensuing fiscal year beginning July 1, 1941 and ending June 30, 1942, should be paid, as heretofore, in order to be fair with the affected school communities and by so doing give them ample time to make the necessary readjustments for the payment of the second year's redemption of bonds.

Delaware achieved one of the big goals of American Education when it adopted a State-wide financing unit for its educational system, but there is grave fear that the trend can be carried too far. To my mind this is the proper time to place the responsibility where it belongs and at the same time serve notice that no future similar issues will be assumed by the State.
