According to this Report and the accompanying chart, the Commission has since its organization, surveyed, plotted, and secured, definite title to over 5000 acres of Public Lands.

Those acquainted with the work accomplished and the mass of details involved, commend very highly the labors of the Commission.

In the present Report they ask for an appropriation of \$500.00 and authority to continue their investigations. I would recommend that this power be granted. With an appropriation not to exceed \$500.00, it seems reasonable to expect that they can complete the survey and plotting of the State's Public Lands.

Your Commission sold the haying privileges owned by the State at Public Auction in 1915 for One Hundred and thirty-nine Dollars (\$139.00). and in 1916 for One Hundred and thirty-one Dollars and seventy cents (\$131.70)._

Your Commission had plotted a portion of the State Lands, lying on the Atlantic Ocean just South of the Rehoboth Life Saving Station, and after fully advertising the same by posters, sold on Saturday, August 19, 1915:

The purchase price of all the lots has been paid to the President, with the exception of 80% of the purchases made by L. W. Wicks, he having so far only paid the 20% requested on the day of the sale.

A condition of the sale was, that when any owner of any lot or lots had improved each lot so purchased by him, to the amount of Four Hundred Dollars (\$400.00) that a deed would be given for said lots. The Pennsylvania Railroad Company through the kindness of its officers presented to the Commission a deed conveying to the State Fifty (50) Acres of land, lying between the Atlantic Ocean and the Rehoboth Bay, which was granted to the Junction and Breakwater Railroad Company by the State, by an Act of the General Assembly dated March 22, 1877.

The total receipts from sale of lots and from the sale of haying privileges amounts to Sixteen Hundred and One Dollars and Forty-two cents, which has been deposited by the President of the Commission, with the Fidelity Trust and Savings Bank of Lewes, Delaware, to the credit of the Commission, at 4% from January 1, 1917.

Your Commission particularly refers to its report made to the General Assembly in Februaty 1915. The map of the entire survey from Fenwick Island to the Delaware Capes has been lodged in the office of Secretary of State and the map or plot of "Indian Beach" is herewith submitted.

Your Commission also suggests that the fund of Sixteen Hundred and One Dollars and Forty-two cents, which is now on deposit in the savings fund of the Fidelity Trust and Savings Bank of Lewes, Delaware, remaining there for the present and until such time as the General Assembly may decide the best use thereof.

Your Commission further calls to your attention that there are two (2) valuable tracts of land, one North and one South of the Town of Rehoboth, that belongs to the Public Lands of the State, and that the Commission intends, during the coming season to take up the investigation of the titles thereto.

We would most respectfully recommend an appropriation of Five Hundred Dollars to be used during the years 1917 and 1918, to further investigate the titles of the two tracts of land, and to properly carry on the work of the Commission.

We hope that this report, together with our report of 1915, and together with the maps and plots made by your Commission will fully advise your Honorable Bodies of the value of the Public lands of this State, and of the faithful work of the Commission in conserving this property of the State.

STATE OF DELAWARE HOUSE OF REPRESENTATIVES

Dover, Del.

To the Members of the Delaware General Assembly:

Gentlemen:

We the undersigned committee appointed by the two Houses of the Ninety-Sixth General Assembly to visit the Delaware State Hospital at Farnhurst, having performed that duty on Saturday last, herewith submit our report as follows:

We met at the Institution Saturday morning where we were cordially received by Dr. Hancker the Superintendent and also George S. Capelle, President of the Board of Trustees and Mr. Charles C. Kurtz, another one of the trustees, both of Wilmington.

Mr. Capelle and Mr. Kurtz both explained in detail, with the assistance of Dr. Hancker, the complete workings of the Institution, the manner of keeping the books, the care of the patients, the moneys received from all sources including State appropriations as well as revenue from pay patients and the expenditure of the same.

The needs of the Institution as to repairs, upkeep and completion of the new building were also gone into very thoroughly, and an investigation of the buildings, grounds, etc., fully demonstrated to the Committee, the necessity of granting to the Board of Trustees of the Institution, sufficient appropriation to carry on the work as mapped out and without which they will be unable to properly care for the unfortunates placed in their charge.

The Committee were escorted over the entire Institution including the quarters for the most violent as well as the less

violent patients and the crowded condition of the halls and sleeping apartments fully convinced the committee that more room was needed to separate the inmates, not only for their good, but for the good of the Institution.

One instance of a crowded condition was shown in the amusement hall where four rows of beds, two on either side of the room, the full length of the hall were placed, there being no other quarters sufficiently large enough to accommodate them. This was in the woman's department. Conditions in the men's department were practically the same.

We were also impressed with the necessity of separating the feeble-minded from the really insane patients, of which there are between 30 and 40.

In the basement we found need of many improvements especially in the cooking room where a new range, new cookers and a new refrigerator are badly needed. These will have to be provided for during the next two years, as the work in that department not only warrants it, but demands it for the protection of the institution.

We found the Hospital was kept in a most sanitary condition, no offensive odor of any kind being detected in any of the buildings. The inmates were well cared for and as far as their mental condition would warrant, they apparently were as happy and contented as it was possible for them to be.

It was with some surprise if not chagrin, that the Committee learned from the attendants, both men and women, that their monthly salaries were most ridiculously small, compared with the work of other laborers whose responsibilities in no wise compared with the responsibilities of the attendants of this Institution. When it is realized that these attendants practically take their lives in their own hands while on duty among the insane, the compensation they receive does not, we think, fairly compensate them.

The necessity of the new building now in construction, completed with the exception of the interior work and grading on the outside, is most apparent and the appropriation asked for to complete this building will be money well spent. The building is absolutely fire-proof and when completed will not only relieve

the congestion of the other buildings, but be a valuable asset to the State.

At the conclusion of the inspection of the Institution, Mr. Capelle, the venerable President of the Board of Trustees, expressed his sincere thanks to the Committee for the deep interest they had manifested, especially in making inquiries as to the workings of the institution, its needs, etc.

This Committee unhesitatingly and cheerfully recommends that every dollar of the appropriation asked for from this General Assembly by the Trustees of the State Hospital for the upkeep, repairs and completion of the new building, be granted.
