Proposed Wawa draws criticism

Residents, business owners pack meeting to voice opposition

Calling it a "bright gaudy place" and a "cancer in the community," more than 100 people crowded into city council chambers last week to voice opposition to the proposed Wawa on South Main Street.

Most of those who spoke at the nearly two-hour-long meeting Feb. 6 said the convenience store chain would bring an increase in traffic, contribute to noise and light pollution and drive out existing businesses.

"I'm worried about changing the character of the community," one man in the crowd said.

Wawa has not yet filed formal plans with the city, but the initial proposal

shared Wednesday calls for building a 4,999-square-foot store and 12 gas pumps in the Park N Shop center on South Main Street, across from the Newark Municipal Building.

The store would be built at the corner of Apple Road and South Main

Street, at the site of the vacant M&T Bank building.

Susan Bratton, real estate manager for Wawa, said the proposed store is smaller than most Wawas in the area

Custody battle leads to courthouse shooting

Police: Newark woman, friend killed by former father-in-law

A years-long custody battle involving a former Newark eye doctor led to a shooting at the New Castle County Courthouse in Wilmington Monday morning, police have confirmed.

Thomas S. Matusiewicz, 68, of Edcouch, Texas, opened fire in the lobby of the courthouse, killing two people and injuring two Capitol Police officers, said Sgt. Paul Shavack, a spokesman for the Delaware State Police.

Matusiewicz is the father of optometrist David Matusiewicz, who recently served time in prison for kidnapping his three children

from his ex-wife, Christine Belford.

Belford, a 39-year-old Newark resident, was killed in Monday's shooting, along with her friend, Laura Mulford, 47, also from Newark.

After shooting the two women, Thomas Matusiewicz exchanged gunfire with police and ultimately died of a self-inflicted gunshot wound to the head, Shavack said.

Dispute dates back to 2007

The bizarre and tragic saga began in August 2007 when David Matusiewicz, now 45,

UD graduate student named city secretary

Renee Bensley, a graduate student at the University of Delaware and a legislative aide to a county councilwoman, has been named Newark's city secretary.

City council made the appointment official Monday night, unanimously approving Bensley for the position.

"Often it's not council that is the first contact for the public; it's the city secretary," Councilman Jerry Clifton said. "We wanted someone poised and ready to lead the city."

Bensley, who lives in the Cherry Hill Manor neighborhood, will replace Pat Fogg, who is retiring this spring. Fogg has served in

Tip from public leads to arrest of burglary suspect

Police are crediting a tip from the public with helping locate a man suspected of burglarizing a Newark apartment building last month.

The burglary occurred on Jan. 25 between 11:15 p.m. and 1:15 a.m.


Two men entered an

unlocked apartment at the Continental Court Apartments located at 65 South Chapel St. and took personal property belonging to the residents, said police spokesman Lt. Mark A. Farrall.

After police disseminated surveillance photos of the two men, a citizen helped officers identify one as Ian S. Allston, 24, of Wilmington, Farrall said.

Allston was arrested Feb. 8 and charged with second-degree burglary, second-degree conspiracy and theft. He was committed to the Howard R. Young Correctional Facility on \$13,000 bail.

Police are still searching for the second suspect, described as a white man, between 18 and 22 years old and wearing a red hooded sweatshirt.

Newark-area man killed in Rt. 4 crash

An 88-year-old Newark-area man was killed in a single-car crash Sunday morning, police said.

Charles Yenkevich was driving his 2004 Chrysler PT Cruiser west on Ogletown-Stanton Road (Del. Route 4) just before 9 a.m., when the vehicle inexplicably veered off the roadway, said Cpl. John Day, a spokesman for the Delaware State Police.

The accident occurred

near the intersection with Cheswold Boulevard, east of Newark.

Yenkevich's vehicle hopped a curb and ended up in some bushes more than 30 feet to the right of the roadway, Day said.

Yenkevich was taken to nearby Christiana Hospital, where he died.

Police were continuing to investigate the cause of the crash Sunday night. Yenkevich was wearing a seatbelt at the time of the crash.

the role since 2008 and before that, had been deputy city secretary since 1984.

The city secretary reports to the mayor and council and is responsible for keeping the city's records, filing all official documents and compiling agendas and minutes for meetings.

"I'm excited. I really enjoy the city and the people who work here,"

Bensley said Monday. "I hope I can carry on the excellent tradition Pat has done, and I hope I can be part of the effort to make the city leaner and more efficient."

Bensley, 30, grew up in Baltimore and Cecil County, Md., but moved to Delaware to get her undergraduate degree from Wesley College. She later enrolled in graduate school at the University of Delaware's School of Public Policy and Administration. She

will earn her master's degree in May.

For the past four years, she has worked as a legislative aide to County Councilwoman Lisa Diller, a Democrat who represents the Newark area.

Bensley said she is looking forward to learning more about the city she has called home for four years.

"I love being in an area where I can walk if I want to, and I love being in a city that has a sense of

community," she said.

Bensley will start March 4 and work alongside Fogg for approximately a month before taking on the position herself. She will draw an annual salary of \$64,000, plus benefits.

"She's got incredible administrative skills with a very outgoing personality that will help her perform her duties," Mayor Vance A. Funk III said. "She's the real deal."

Newarkers react to end of Saturday mail delivery

Due to the agency's loss of billions of dollars, the United States Postal Service announced last week it will stop delivering letters on Saturdays.

Freda Sauter, from the USPS regional office in Baltimore, said the changes will go into effect during the week of Aug. 5. She said the changes are an effort to close the Postal Service's large gap in finances.

Sauter said first-class mail will be delivered only on weekdays, but Saturday delivery will continue for customers with P.O. boxes. Post offices currently open on Saturdays will remain open.

"Package delivery will continue Monday through Saturday," Sauter said. "Package deliveries have gone up 14 percent."

Express-mail delivery will also continue being

delivered on Saturday and Sunday.


Under this new plan, USPS officials expect to save approximately \$2 billion annually after it is fully administered.

"We developed this approach by working with our customers to understand their delivery needs and by identifying creative ways to generate significant cost savings," Postmaster General Patrick R. Donahoe said in a statement.

Local residents patronizing the Newark Post Office Thursday had mixed reaction to the changes.

Jackie Baldwin, who noted that she often forgets to check her mailbox on Saturday, said she thinks most customers will not be inconvenienced by the new delivery schedule.

"Unless they have something urgent what's another day going to make?" Baldwin said.

Carolyn Rander, too, said her mail schedule would be undisturbed.

"I don't think they (the Newark Post Office) did a

lot of business on Saturday any way as far as mail delivery goes," Rander said.

However, she said, customers who cannot leave

work on weekdays might find the changes problematic.

"But they could always just go to FedEx," she said.

Blue Hens announce this year's class of recruits

New Delaware football coach Dave Brock said his first recruiting experience as a head coach "couldn't have worked out any better in my opinion."

In an afternoon press conference on National Signing Day (Feb. 6), Brock announced the 13 recruits who earlier in the day had signed NCAA National Letters of Intent to attend Delaware.

In addition to the 13 recruits, Brock also announced the addition of transfers Jordan

Thomas from Rutgers University and linebacker Kennedy Ogbonna from ASA Community College in New York. The group also includes Eric Patton, a first-team All-State player at St. Elizabeth who sat out the 2012 season as a greyshirt. Thomas and Ogbonna will each have junior eligibility while Patton will have freshman eligibility.

"This is an exciting day for the Delaware football family," Brock said. "Any time there are additions to your family it is something special. It will always be important for us to bring in the right people and I think today we

have brought in quality people and quality players."

The list of newcomers includes five linebackers, three defensive backs, three offensive linemen, two running backs, two defensive linemen, one quarterback, and one wide receiver. Eight players from the group earned All-State honors, while many of them served as team co-captains and earned academic awards.

Brock thanked former coach K.C. Keeler and his staff for "building relationships" with the recruits, and reiterated he was excited about all of them.

"[I told each of them] to

come here for the right reasons," he explained. "Want to come here. [Be sure] it's the right place for you and your family. Be committed to the total experience."

Brock said the first recruit he met with after his hiring was Diante Cherry, a 5-9, 170-pound wide receiver from McCaskey High in Lancaster, Pa.

"He is really good with the ball in his hands," Brock explained. "And I think he can have an impact on the return game."

Kyle Yocum might eventually be the one getting the ball into Cherry's hands. The 6-2 quarterback from Exeter High School (Reading, Pa.) was one of the first players to re-commit after Brock was hired.

"He helped hold the recruiting class together," Brock said. "He's a terrific young man with a dynamic personality and a terrific arm."

Brock said Yocum has the ability to run and throw, which is why Keeler was so



New coffee truck rolls into Newark

Three years ago, Mary Tipping and Karla Fleshman came up with a way to blend their love for coffee with a burgeoning food trend.

"It seemed like the craze across the nation is food trucks, so we tried to bring that to Delaware," Tipping said.

Their idea finally fell into place when they found someone to design the truck, and last week, "Java Puppy," their coffee-

and-pastry truck rolled into Newark.

The two women, both from Wilmington, park the truck adjacent to La Tonalteca on North College Avenue and sell locally roasted Fair Trade coffee, espresso, tea, chai and hot chocolate as well as pre-packaged organic brownies, biscotti and scones. They also offer gluten-free brownies and cookies.

The truck is open Monday through Friday from 7:30 a.m. to 12:30 p.m.

Tipping said they

launched the mobile coffee business eight months ago and have mostly operated at charity events, wedding receptions, corporate office events, birthday parties and events at the Wilmington Riverfront.

Recently, they decided to bring it to Newark.

"We wanted to see if the students like us," Tipping said.

The women say they also use their business profits to give back to the Delaware community, donating a percentage of their profits to local,

non-profit organizations.

Tipping said she is thrilled about the truck's new location.

She said students, many of whom pass the truck on

the way to class from the University of Delaware's Laird Campus housing, seem excited to see the Java Puppy truck, and many have stopped to take pictures of it

on their cell phones.

"We still have to get into people's coffee habits," she said. "I know it takes a while. We are a new concept."

Some nearby businesses, worried about competition, start petition drive

and is designed to cater to pedestrians.

"This is a very different type of Wawa," Bratton said. "It's meant to be a community Wawa."

The store would employ 40 to 45 people, she said.

Owners of the property see the Wawa as the first step in the process of bringing life back to the aging center.

"The key to all of this is to revitalize and rejuvenate the shopping center," said Larry Tarabicos, an attorney representing DelleDonne and Associates.

Ed Grant, owner of the Newark Barber Shop located in the Park N Shop, agreed with that sentiment, saying that the customers Wawa would attract would also benefit his business.

"(The shopping center) needs more traffic and flow,

and Wawa would provide that," he said.

However, most business owners in attendance worried that competition from the well-known chain would put them out of business.

"I think we would hang in there as long as we can, but then may have to shut our doors," said Sean Ruohonen, whose family owns the Sunoco gas station adjacent to the Park N Shop. "Everything about it is wrong."

Ruohonen has spent the last month rallying opposition and at last week's meeting presented a binder containing letters from local businesses and a petition signed by several hundred residents.

He said the proposal goes against the city's goal of developing South Main Street as an extension of East Main Street's shopping district.

"We want mixed-use

buildings that supply us with unique retail," Ruohonen said.

In a fiery speech at the meeting, state Rep. John Kowalko (D-Newark South) compared Wawa to big-box retailers that are detrimental to competitors.

"Wawa is a contributor to the Walmart syndrome," Kowalko said. "Notoriously, they drive out existing, longtime businesses owned by local residents."

Wawa officials are planning a second public meeting about the plan, though the date has not yet been announced. After that, they will officially submit the plans, which would have to be approved by the planning commission and city council.

Councilmen David Athey and Doug Tuttle, who organized the meeting at Wawa's request, declined to comment on the merit of the proposal.






"I'm totally impartial at this point," Athey said. "We'd be foolish to judge before it's submitted."

If approved, the store would become the seventh Wawa within a five-mile radius.

"I love Wawa," one woman in the crowd remarked. "I just don't want another one."


Legends of Negro Leagues honored at Newark Library

Local history of the Negro Leagues was in the spotlight Sunday afternoon as the Newark Library hosted a presentation on Delaware native William "Judy" Johnson.

Through a first-person interpretation of the Baseball-Hall-of-Famer's career, attendees learned about the history of the Negro Leagues, which flourished until Jackie Robinson broke the color barrier in the major league in 1947.

The Delaware Humanities Forum sponsored the event, and Ron Whittington, from the DHF



Speakers Bureau, gave the presentation dressed in period garb.

"People that love baseball came," Whittington said. "I'm always impressed that they really love it. Newark has a great baseball tradition."

John Henry "Pop" Lloyd, a former shortstop and manager in the Negro League, discovered Johnson when Johnson was 14 years old.

Johnson took the nickname "Judy" because he resembled Judy Gans of the Chicago Giants.

Whittington called the players "heroes that should never be forgotten."

He used pictures from the Baseball Hall of Fame in Cooperstown, N.Y. for his presentation.

Attendees said they enjoyed hearing Whittington's accounts of the Negro baseball leagues.

Anita Lohinecz, of Newark, said Whittington's personal stories were her favorite part of the event.

"He has a lot of enthusiasm, and I think that's what everyone here was looking for," she said. "He had a lot of information I didn't already know."

Lohinecz said she decided to attend the event after seeing a flyer at the library the day before.

"I lucked out," Lohinecz said. "I'm glad I didn't miss it."

Out of the Attic

Boy Scouts Chartered 103 Years Ago (1910)

This week's Out of the Attic item is an illustration titled "Forward America" by the renowned American artist Norman Rockwell. For decades, Rockwell did an annual work about scouting. One hundred three years ago this month, the United States Congress granted a charter to the Boy Scouts of America.

Over the years, more than 110 million children and adults have been BSA members and leaders.

Scouting started in England when soldiers returning from the Boar War in South Africa in the late 1890's brought their outdoor life skills training activities home to the London streets. Neighborhood lads found them to be a new focus for their spare time. With the help of returned war veterans, scouting caught on. An American businessman saw this on his frequent trips to London and in 1908 brought scouting to the United States.

Local organizations such as service clubs and churches make scouting available in their communities. The Scout troop soon became a popular activity for Newark-area young teens. Then came Cub Scout packs for children and Explorer Posts, Sea Scout Ships, and Air Scout Squadrons for high schoolers and young adults.

By 1950 Newark had two Boy Scout troops - 55 and



56 - and Sea Scout Ship 55. By 1970, the post war population explosion in the area caused not only the schools to double in enrollment every seven years, but also explosive growth to Scouting. Newark area Cub pack, Scout troop and Explorer unit numbers have included at least 17, 55, 56, 70, 75, 203, 205, 215, 252, 255, 601, and 603. Gunman died from self-inflicted wounds

told Belford he was taking the children to Disney World but instead took them to South America.

In March 2009, federal law enforcement officials located Matusiewicz and deter-

mined he had been living in a mobile home in Nicaragua with his mother and the children, after having briefly resided in Mexico, Costa Rica and Panama.

Matusiewicz was taken into custody by the United States Marshals Service and

was returned to Delaware to face the federal charges against him. The children were returned to Belford.

Matusiewicz served time in prison and a halfway house before being released in September, according to the state attorney general's office.

Lenore Matusiewicz, mother of David and wife of Thomas, also served 18 months in jail for her role in the kidnapping.

A barrage of gunfire

Monday's deadly attack began approximately 7:40 a.m. when Thomas and David Matusiewicz arrived at the courthouse, according to a timeline released by state police Tuesday.

David Matusiewicz went through a security checkpoint and proceeded into a scheduled child support hearing involving Belford and their children.

Meanwhile, his father stayed in the lobby, avoiding the security checkpoint.

At approximately 8:15 a.m., Belford and Mulford entered the lobby on their way to the hearing. Thomas Matusiewicz approached the two women, pulled out a .45-caliber semiautomatic handgun and opened fire at close range, Shavack said.

He fired multiple rounds, striking both women in the upper body. The victims were rushed to Christiana Hospital, where they died.

As he turned to leave, Thomas Matusiewicz engaged in a "gun battle" with officers from the Capital Police, a state agency charged with protecting courthouses and other state buildings, Shavack said.

Two officers – identified as Michael E. Manley, 42, and Steven D. Rinehart, 50

– were struck, but Shavack credited their bulletproof vests for protecting them from serious harm. Both were treated at Christiana Hospital and released the same day.

During the gun battle, Thomas Matusiewicz was fatally hit.

"Matusiewicz suffered two gunshot wounds, one in the upper body and a second, a self-inflicted gunshot wound to the head," Shavack said. "He was pronounced dead at the scene."

The medical examiner ruled his death a suicide.

As dozens of police responded to the courthouse, detectives located David Matusiewicz inside and inter-

viewed him about the incident. He was taken into custody for an alleged violation of his federal probation.

On Tuesday, the state obtained a court order forbidding Lenore Matusiewicz from contacting her three grandchildren, who were the focus of the custody battle.

"The children are safe," Attorney General Beau Biden said in a statement. "We sought this no-contact order because we believe Lenore Matusiewicz is a danger to the children and should not have any contact with them. Her actions over the past five years have given us serious concern that she poses a risk to the children's safety."

high on him.

"There's no question he can run and throw," Brock said. "What he does here remains to be seen. Nothing hinders a guy's development more than high expectations."

Patton is the only former Delaware high school player who will suit up for the first time in the fall. The first-team All-State player from St. Elizabeth is currently enrolled at UD and will take part in spring drills. Brock said he had the opportunity to meet Patton while recruiting his brother, Andre, at Rutgers.

"I actually had the chance to go out to dinner with him at Buffalo Wild Wings,"

Brock said, smiling.

Only two players who verbally committed prior to Brock's hiring did not sign Letters of Intent. Brock would not name or comment further on either of them. The Post later learned the two were wide receiver Andre Dessenberg (Towson) and defensive back Tyrice Beverette (Stony Brook).

Brock added that he didn't try to recruit any additional players or take away verbal offers made by the previous coaching staff.

"In 17 days it's hard to recruit new players or rule others out," he said. "We are not a quick-fix business. We want to recruit the right people, the right player."

Brock said that since his hiring, his complete attention has been on the recruits, and now his focus will turn to spending time with the players already at Delaware and assembling his coaching staff, which is "a work in progress," he admitted.

The common theme throughout the press conference was focusing on recruiting the "right" players, and in turn, players choosing Delaware for the "right reasons."

"We want achievers," Brock emphasized. "We want them to come to Delaware for the right reasons. ... It should be the education, it should be the environment, it should be the people."



Strawberry Fritters

The French have been making strawberry fritters for centuries. In fact Menon, in his 1793 French cookbook titled The French Family Cook, gives us this strawberry fritter recipe for the first time in print that I am able to find.

"Make a paste with some flour, a spoonful of brandy, half a glass of white wine, the whites of two eggs beat and green lemon shred fine. Mix it well, neither too thick nor too thin. It should rope in falling from a spoon. Dip some large strawberries in to it, fry them and glaze them with a salamander".

This is also the earliest reference to a salamander I found as well.

- 1 quart vegetable oil
- 2 eggs, well beaten
- 1/2 cup plus 2 tablespoons milk
- 3/4 cup flour

- 1 tablespoon sugar
- 1 teaspoon baking powder
- 1 teaspoon cinnamon
- 1 pint whole strawberries, hulled

Prepared caramel sauce

Preheat oil in a deep, heavy pot until it reaches 350 degrees (measure with a clip-on thermometer.) Use your deep fryer according to manufacturers instructions. Combine first six ingredients and mix well.

Stir in strawberries a few at a time, being careful not to mash them. With two forks, remove one strawberry at a time and gently ease them into the hot oil.

Cook only two or three at a time in order to cook evenly, remembering to turn them over, and to keep the temperature of the oil hot.

If the temperature drops,

that means that the strawberries will be cooking in the oil longer, therefore soaking up more oil. Cook for two or three minutes or until the batter has evenly turned a medium brown in color. Remove to a paper towel lined platter or rack to drain.

Continue with remainder of strawberries. To serve, pour warmed caramel sauce over the top.


