Newark's jobless rate still state's lowest

Newark continues to have the state's lowest unemployment rate.

Figures without seasonal adjustments from the Delaware Department of Labor showed Newark with a 6.3 percent September jobless rate, unchanged from August, but well above the 4.1 percent in September of last year.

Wilmington's September jobless rate was an uncomfort-

ably high 13 percent, compared to 12.6 percent a month earlier and 8.2 percent a year earlier.

Other rates for September 2009, August 2009 and September 2008 were:

- New Castle County, 8.6, 8.4 and 5.3 percent.
- Kent County, 7.9, 8.1 and 5 percent.
- Dover, 8.8, 9.2, 5.9 percent.
- Sussex County, 7.3, 6.9,

4.6 percent.

The Department of Labor reported the seasonally adjusted jobless rate in the state for September rose to 8.3 percent from 8 percent a month earlier and 5.2 percent a year earlier. That was still well below the national jobless figure of 9.7 percent. There had been fears that Delaware's unemployment rate might come close to the national figure.

Total employment was down 4.9 percent from a year ago, compared to 4.3 percent nationally. That marked a slight narrowing of the gap between the national and state job loss numbers.

The only gains in employment came in education and health care. Big losses over the past year came in manufacturing (down 3,800 jobs), professional and business services

(minus 5,900) and wholesale and retail trade (down 4,300). The Newark area suffered the loss of the Chrysler plant at the end of 2008, with the Avon site closing also expected.

State government employment was down about 300 jobs from a year ago, not as high as some might expect, given the hiring freeze that has been in place.

Any employment recovery

might well be led by professional and business services, since that category includes temporary workers, who are often brought in when business conditions improve.

One bit of encouraging news came with the release of manufacturing hours worked. In September, the number of hours worked a week averaged 41.2, compared to 39.6 a year ago.

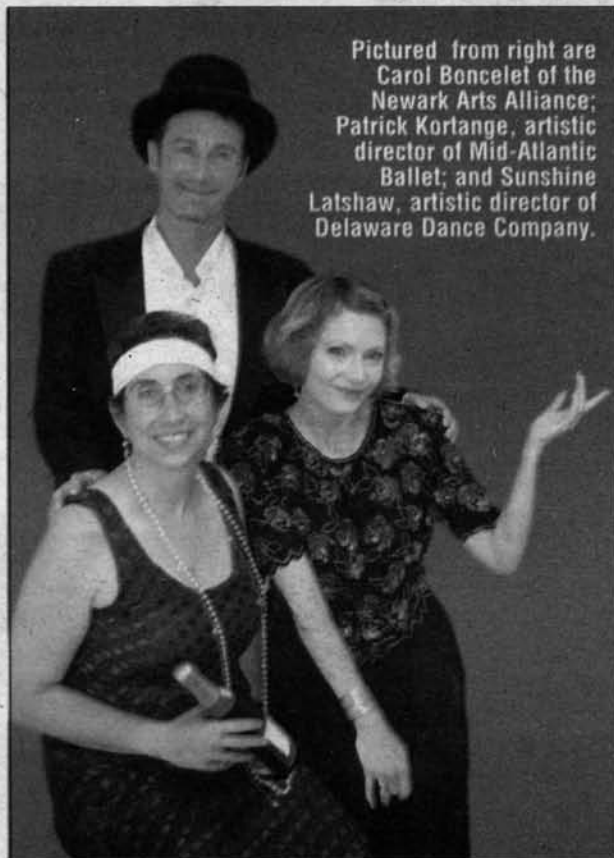
Nov. Arts gala looks back at roaring 20s

Area residents can go back in time and relive the Roaring '20s at the fourth annual event sponsored by Newark's Mosaic arts collaborative.

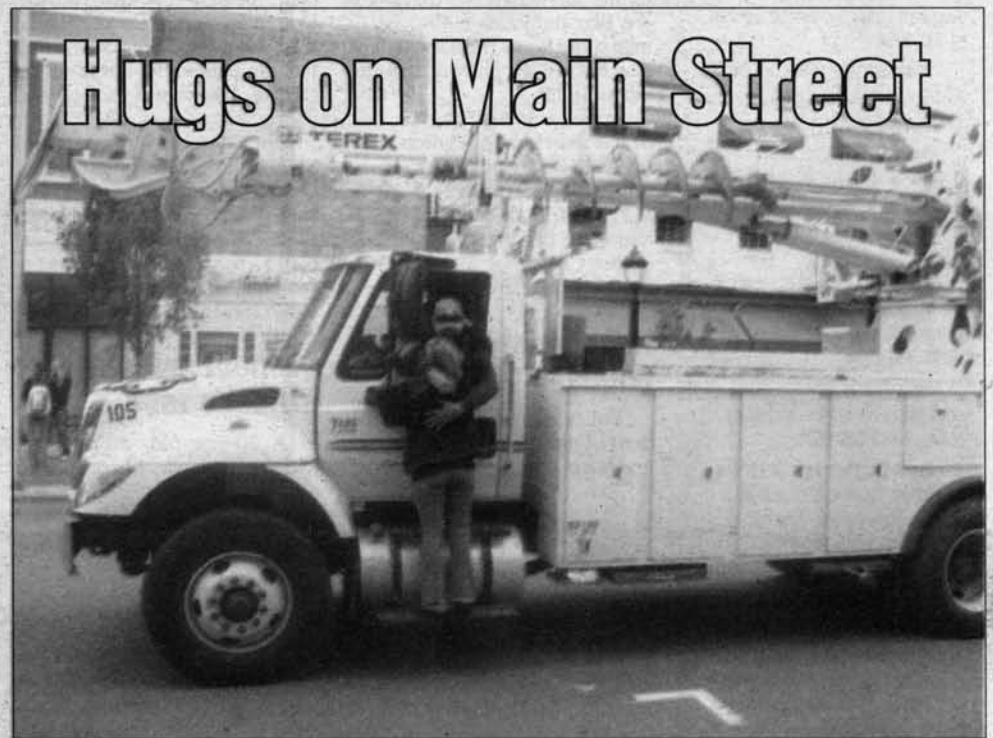

Copper thieves strike again at Louviers

The construction site at the future Louviers Credit Union has again been the victim of copper thieves. Approximately 350 feet of refrigeration tubing, worth over \$8,000, was taken from the ceiling of the first and second floors.

Police discovered that an area of metal framing had been bent to gain access to the tubing. A garbage can was also found with scraps of the tubing still in it. Officers believe that this can was used to transport lengths of the tubing to a location at the rear of the site. A representative of one of the firms installing the tubing alerted police that there are two individuals allowed to take scrap items from the dumpster, but are not allowed to enter the building.

Police are focusing on one of the individuals: a white male in his late twenties or early thirties, approximately 5'10 to 5'11, with dark, average-length hair. This person drives an older white Chevy or Ford pickup truck with Delaware tags.

Robbers steal metal goods

Police are investigating the theft of almost \$1,400 in copper and steel posts, braces, poles

and assorted scrap pieces from James Peel and Sons, located on 118 Sandy Dr. Video footage from October 10 shows two individuals running from the rear fence to various areas in the yard where the metal pieces were stored.

While walking the perimeter, officers discovered that part of the rear fence was loosened to lift the bottom, allowing a person to crawl underneath it. Additional video surveillance footage from a adjacent business shows a car being driven down the driveway, turning around, and leaving. Police have contacted nearby recycling centers, but have come up with negative results. The investigation has expanded to Maryland recycling sites.

Police are also looking into a scrap metal theft from a dumpster located behind Newark Dodge on Elkton Road. A hole was found in the chain link fencing behind the dumpster on the site. The area is used to hold automobile scrap metal parts.

The company is charged \$200 to process a full dumpster. Drag marks were found leading to a paved alley near Madison Drive. Several witnesses stated that no suspicious people were seen near the site. A review of video footage is still pending.

Suspect spits in officer's face

A 20-year-old North East, Md. woman was charged with

two counts of offensive touching. One of the counts involved her slapping her boyfriend's face while they were arguing in the parking lot of Blue Hen Bowling Lanes.

A Newark police officer was dispatched to the scene where he questioned the couple and several witnesses. Once it was clear that she was involved, the officer placed her into the rear of his cruiser to continue questioning at the police station. After being secured in the back seat, she yelled "I've got AIDS" and spat in the officer's face, causing saliva to enter his left eye. The officer will be tested for HIV and hepatitis. She was arraigned and given a \$750 unsecured bond, a curfew from 10pm to 6am, and was required to be tested for HIV.

Balls taken from gym's shed

Employees at 1614 Fitness reported that a storage shed on 318 S. College Avenue was broken into. The lock and hasp had been pried away from the wood on the door. Suspects removed 11 Bosu balls and 7 eight-pound medicine balls from the shed. The total value of the stolen merchandise is almost \$2,000.

Due to the cumbersome nature of the Bosu balls, police believe that multiple suspects committed the robbery. Employees of the gym feel that the crime may have been more of a prank than a burglary, due

to the items that were taken. The police are still investigating the incident.

Temp tags taken from Martin Honda

An investigation is ongoing in the theft of 100 temporary Delaware registration tags from Martin Honda, located at 298 E. Cleveland Avenue. The tags are valued at \$10 each, but can fetch as much as \$400 on the street.

Representatives from Martin stated that on October 8, an employee with Martin Honda Used Cars, Ronald Williams, 45, of Wilmington, picked up a box of the registrations without authorization. Workers at Martin called to ask where the box was and were surprised to find out that Williams had not returned after he had called to say that he was sick. Police have contacted Williams in an attempt to interview him. So far, Williams has not come in for questioning.

Trespasser takes blower

Police are looking for a suspect that took a Stihl backpack blower valued at \$450 from a truck belonging to Green Line Lawn and Landscaping, last week. Michael Cackowski, owner of the landscaping business, told officers that his crew had been doing work at Dow Chemicals, at Bellevue Road,

when a light blue Hyundai Sonata pulled up to their trailer and took the blower.

Video footage shows that the vehicle pulls up next to the truck and that a white male gets out of the car, looks around, takes the blower, and enters the passenger side of the car. The vehicle takes off after that. Dow told police that if the suspects are apprehended, they additionally want them arrested for trespassing.

Exxon robbery

Delaware State Police are looking for the man who robbed an Exxon Station on Ogletown Stanton Road south of Newark on Tuesday.

According to troopers, the store clerk was in the back preparing for the day when he heard the front door chime-letting him know someone had just come inside.

The clerk walked to the front to help the customer when he instead was confronted by a white male subject with a shirt over his face. The suspect was armed with a handgun and demanded cash. The clerk complied with the suspect's demands and turned over an undisclosed amount of money. The bandit ordered the clerk to the ground and he then fled the scene.

The suspect is described as a white male, white shirt and pants, and a shirt covering

Move by diocese to file for Chapter 11 draws fire

The Catholic Diocese of Wilmington filed for Chapter 11 protection as it faces court cases involving clergy and sexual abuse.

The filing came shortly before a trial on sexual abuse allegations. Under the terms of a state law, the Diocese is facing a wave of claims that came under a law that allowed suits to be filed past the statute of limitations.

The Diocese emphasized that the filing does not affect schools, churches or other entities within the Diocese that have separate structures.

Bishop W. Francis Malooly, wrote in a letter to parishioners that the filing "is a painful decision, one that I had hoped and prayed I would never have to make. However, after careful consideration and after consultation with my close advisors and counselors, I believe we have no other choice, and that filing for Chapter 11 offers the best opportunity, given finite resources, to provide the fairest possible treatment of all victims of sexual abuse by priests of our Diocese. Our hope is that Chapter 11 proceedings will enable us to fairly compensate all victims through a single process established by

the Bankruptcy Court."

"Some months ago, we petitioned the Superior Court to order an Alternative Dispute Resolution process so that a global, equitable settlement for all 142 claimants would be negotiated with the assistance of a court-appointed mediator," the bishop wrote in a letter to members of the Diocese

that includes Delaware and Maryland's Eastern Shore.

"On October 6 the court ordered such an ADR process for all cases without long-standing trial dates. Thirty of the 131 cases filed against the Diocese have been scheduled for trial, with a set of eight cases to begin trial on Monday, October 19. As has been our

policy, we were engaged in negotiations, with the assistance of a mediator, to settle these eight cases. These negotiations continued until today, but we were unable to achieve a settlement. Our concern throughout the negotiations was that too large a settlement with these eight victims would leave us with inadequate resources to fairly compensate the other 133 claimants, and continue our ministry. It is our obligation to ensure that all victims of abuse by our priests are fairly compensated, not just those fortunate enough to secure earlier trial dates," the bishop wrote.

According to Malooly, "the Chapter 11 filing is in no way intended to dodge responsibility for past criminal misconduct by clergy or for mistakes made by Diocesan authorities. Nor does the bankruptcy process enable the Diocese to avoid or minimize its responsibility to victims of abuse. Instead, the Chapter 11 filing will enable the Diocese to meet its obligations head-on and fulfill its responsibility to all victims."

The filing was quickly attacked by attorneys for the victims, who claimed no there were no serious negotiations, prior to the filing.

Attorneys and advocates for the victims, claimed the purpose of the filing was to avoid further disclosure.

Barbara Dorris, outreach director of the Survivors Network of Those Abused By Priests (SNAP) suggested the Diocese had other options that included:

- Revealing the wealth of the Diocese, but choosing not to.

- Seeking a loan from a bank or church sources.

- Asking members of the Diocese for donations for healing initiatives.

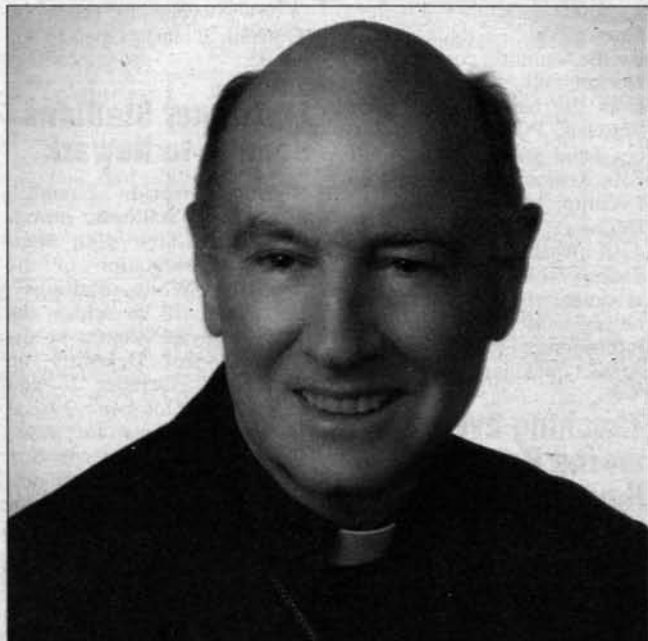
- Seeking a gradual payment of any settlement.

Malooly wrote the Diocese is "committed to pursuing the truth because truth heals. Three years ago Bishop Saltarelli, whom we buried here last week, released the names of 18 Diocesan priests who had admitted, corroborated or otherwise substantiated

allegations of abuse of minors. It was one of the most detailed voluntary disclosures of its kind in the United States. In all of those cases, the Diocese shared information about abuse allegations with law-enforcement authorities. All eight of the priests who were living at the time of Bishop Saltarelli's announcement previously had been removed from any ministerial duties, and for all eight priests, the Diocese has initiated or completed the process of laicization, or removal from the priesthood the harshest punishment that the Church can impose on a priest, short of excommunication."

Malooly also expressed regret that the filing would hurt lenders with a relationship with the Diocese.

SNAP's Dorris asked: "What happens now? Now, though the well-crafted words and careful-honed PR moves, Malooly claims this about wanting all victims to be treated equally, while playing legal hardball and actually treating all victims harshly."

Tri-State Rescue to honor DuPont

State gets more to appeal Bonistall decision

Delaware has been granted more time to decide whether to ask for a U.S. Supreme Court review of the reversal of a conviction and death sentence in the rape and murder of a University of Delaware student.

On Monday, Justice Samuel Alito granted the state's request

for more time and extended the deadline from Wednesday to Nov. 9.

The Delaware Supreme Court ruled in July that James Cooke's public defenders violated his constitutional rights by admitting Cooke's guilt but arguing he was mentally ill, over Cooke's objections.

Cooke argued that he was not guilty in the killing of 20-year-old Lindsay Bonistall, of White Plains, N.Y., or mentally ill.

Deputy Attorney General Paul Wallace says prosecutors need more time because of the complexity of the case.

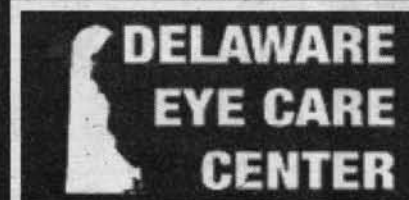

There is mercury in those light bulbs

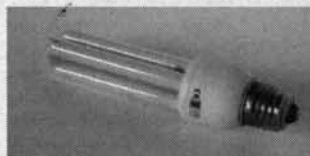

A common concern about switching from incandescent to compact fluorescent (CFL) light bulbs is that CFL bulbs contain mercury. It's true. CFL bulbs contain between 1.4 and 4 milligrams of mercury. They are also recyclable, allowing their mercury to be reclaimed and reused.

If you are using mercury

as an excuse not to make the switch to CFL bulbs, it is important to know that you are actually emitting more mercury into the atmosphere if you use traditional incandescent bulbs.

Most mercury emissions in the U.S. come from coal-fired power plants. Our electricity in Newark is heavily dependent upon coal. Because CFL bulbs use less energy, they reduce overall mercury emissions. By replacing a 60 watt incandescent bulb with a 13 watt CFL bulb, you can prevent 4.5 milligrams of mercury emissions. By recycling the bulb, you can prevent the mercury in the bulb from being released in the land-



fill. The bottom line is that incandescent bulbs are responsible for 4 times the mercury emissions of a CFL bulb.

Because CFL bulbs contain mercury, you should take care not to break them. If you happen to break one, there is no need to panic. The mercury enclosed in the bulb is a vapor and it will dissipate quickly. The Environmental Protection Agency recommends that you

evacuate the room and open the window for 15 minutes. Once the air has cleared, use sticky tape to clean up broken glass and the white powder, which is actually the phosphorous coating of the bulb and not mercury. You can also wipe up with a damp paper towel. Place all garbage in a plastic bag and throw away immediately. Then wash your hands.

When your CFL bulb burns out, do not throw it in the trash. These bulbs are recyclable and we have a drop-off location right here in our community. The Delaware Energy Office has recently initiated a state-wide CFL bulb recycling pro-

gram with a drop off location at the City of Newark municipal building. Simply place the bulb in a plastic sandwich bag before bringing it to the recycling location.

By using CFL bulbs, you can not only reduce overall mercury emissions from coal-fired power plants, you can also make our food supply safer. Once mercury is emitted into the atmosphere, it enters the food chain, where it is converted through biological processes to a more dangerous form, methyl mercury. Methyl mercury is most infamous for contaminating fish and other seafood, and can hinder brain development in young children. It is for this reason that women of childbearing age and children must pay particular attention to fish consumption advisories.

The best way to reduce the environmental and health impacts of mercury emissions

is to reduce your electricity consumption. Because most of our mercury emissions come from coal-fired electricity generation, and because most of the electricity we use in Newark is derived from coal, energy conservation can reduce your mercury footprint.

One of the easiest ways to cut down on your electricity consumption is by switching your incandescent light bulbs for CFL bulbs. Power-strip or unplug your household electronics when not in use, identify and eliminate energy hogs, and invest in efficient technologies and energy star appliances to save even more energy.

You may also want to rethink supper, particularly if you eat a lot of seafood. The Food and Drug Administration monitors mercury levels in some commercial species. If you fish in local waters, check your local fish consumption advisories.

Lessons to learn from the Zachary case

The dust has settled a bit on the Zachary Christie controversy and in the process I have learned a fair amount about school discipline and the new media environment. In case you missed it, Christie was the six-year-old Cub Scout who brought a camping utensil to school that contained a small pocket knife. In keeping with the Christina District's Code of Conduct, young Zachary was suspended for 45 days to be served at Douglass alternative school, in Elsmere. His mom and stepdad refused to go along and a website was launched, www.helpzachary.com. They bypassed The News Journal, the traditional venue for parents airing their grievances and took the matter into cyberspace where it created a sensation.

Like a story passed on from one person to another, the details changed along the way. Bloggers, some reasonable and others sitting on the fringes of the political spectrum weighed in with their own sometimes bizarre conclusions. The cake knife incident was woven into Zachary's case, with some inaccuracies introduced and repeated.

Douglass, an alternative program that has actually earned high marks in some quarters, somehow morphed into a reform school. This is not intended as criticism of the decision of Zachary's mother to not go along with the suspension. The little guy would have been thrust into an unfamiliar environment that did not fit the nature of the offense, even if you somehow buy into a zero tolerance policy. Most people don't, when it comes to kindergarteners and first graders.

The New York Times somehow found out about the situation and the proverbial manure hit the fan, leading to a Christina School Board meeting that effectively ended Zachary's suspension, with all indications pointing to further changes in the code.

Along the way, we learned the story of 13-year-old Kyle Hebert, who was apparently set up for suspension by his classmates at Kirk Middle School, after complaining about being bullied to administration. Hebert is still being home schooled, with his mother charging that most members of the Board of Education did not respond to her requests for action.

The blog entries are still hitting my mailbox, although the Colorado "balloon boy" family seemed to quiet the furor on the national stage.

However, a few things are readily apparent as Zachary

settles into a quiet school year at Downes Elementary.

First, it appears that the code of conduct was created in something of a vacuum, a point brought up by speakers at the board meeting. A look at the code for the Appoquinamink District showed the offense that earned Zachary a trip to alternative land would have been far less severe in Middletown.

The media shares some of the blame for this. Coverage of the Christina board has been sporadic as print and electronic media cover the waterfront with smaller staffs. Parental involvement with the board has always been a problem in the district that sprawls over an area running from the Maryland border to Wilmington.

In the end, we all share a little blame for something that caused at least temporary damage to the district. The challenge for all us is to become more involved.

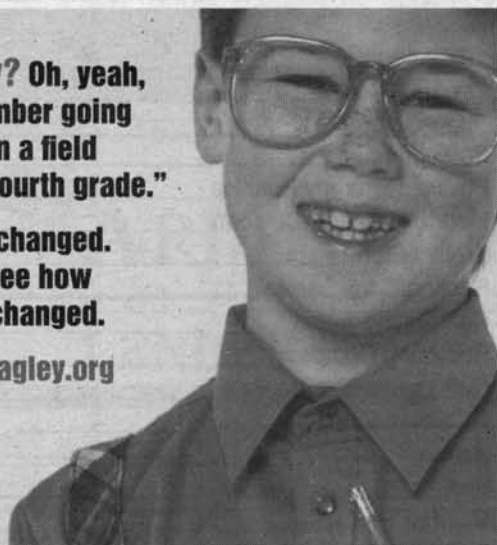

Grocery coupons go electronic

With the majority of Americans looking for ways to stretch their food dollar and the ever-expanding use of technology, an old form of saving money is changing. Clipping coupons from newspapers and magazines is a long established method for saving dollars at the grocery store. Now Americans can find those same — and more — coupons both online and on their cell phone, email or even Facebook page.

Coupon use had been declining since 1992 as consumers found less need for or some embarrassment in using them. However, as the economy worsened, frugal has again become cool and the popularity of coupons has grown. The coupon-processing company, Inmar Inc., reports that the use of electronic discounts and coupons more than doubled in the first half of 2009 compared with the same period last year.

Electronic coupons are currently only a small part of the total number of coupons used — 3 % — but their share of the coupon scene is growing dramatically. To find electronic coupons, sign up for your favorite companies' Twitter feeds, check their Facebook

pages and/or subscribe to their e-mail lists for deals. Some retailers offer discounts on a second purchase if you answer a survey online about your buying experience.

Electronic coupons offer the same benefits for retailers as any discount program: driving consumer traffic, building loyalty, increasing sales and attracting new customers. They also eliminate printing costs, reduce paper waste, can be updated more quickly and have higher redemption rates than the soon to be old-fashioned clipped coupon.

Supermarkets are jumping on board as well. Shortcuts.com provides an interactive online service in which you can link up coupons and other offers from participating vendors electronically with the reward cards or loyalty cards that you use with participating supermarkets. As with paper coupons, each coupon will be subject to terms that will apply and may include expiration dates, limits on product availability, and limits on the number of coupons that can be used per customer. Any purchases you make will be directly through participating merchants. Coupons and other offerings on Shortcuts.com are available for a limited time only and may be changed or discontinued at any time with-

out notice.

It's easy to get set up to receive electronic coupons sent directly to your reward card.

Step 1- Go to this website: www.shortcuts.com. At this site, you can read a bit about how the program works. To begin, get your Safeway or Genardi's grocery store reward cards together. Schedule a few minutes at your laptop, and you may be greatly rewarded. In our area, other markets are not part of this program yet.

Click the button printed with the word Partners. After clicking Partners, you will see the list of stores that are currently enrolled in the coupon deal. You can add your name and email to a list to be informed when they have become part of this program.

Step 2 - Enter your information as prompted: You will be asked to enter your name, zip code, and the usual information needed to track who is getting what. This may be to assure the store you are not using 10 coupons that are the same.

Step 3- Enter the member numbers from your card. The last thing you will do is enter the member number that is on the card. Your cards are then

supposed to be updated with a discount for the coupons you will use.

Before you go electronic, you may want to ask these questions before you do all of this. Am I getting a better deal than using Internet coupons or paper coupons? Am I purchasing product that I wouldn't normally purchase and is this really saving me money? Can I double these coupons like I can the coupons from the newspaper? Do I have time to go online and keep track of coupons?

As the technology progresses and, let's face it, we get better at using it, it will get easier to take advantage of these offers. One advantage is we probably won't be in the store without our member card, but we might forget our coupons. Moving toward coupons loaded onto our member card will ensure we never leave home without them.

Man causes major damage

New Castle County Police have arrested Michael Strouse, 31, who resides in the 500 block of Sparrow Court in the Bear-Christiana area south of Newark. Sparrow Court is not in the Sparrow Run community in Bear. He has been charged with multiple criminal offenses after he broke into his girlfriend's home, choked her, struck her with a chair, bit her ear (causing a laceration) and damaged over \$10,000 worth of property

inside - with the incident witnessed by her two children.

Police responded to the home in the Chelmsford Condominiums, near Christiana High School, for a report of a woman asking for help. When the officers arrived, they heard the sounds of glass breaking inside the residence. After the officers made an announcement inside the home to the occupants, a female, 37, who was hiding upstairs, emerged asking for help.

While speaking to the victim, officers heard more glass breaking and discovered her boyfriend had broken out the rear glass door and was attempting to flee. After a short foot chase, the suspect was taken into custody and later transported to the Christiana Hospital where he was treated for multiple lacerations.

The investigation indicated the victim was inside her bedroom when she heard the sounds of breaking glass downstairs. She then walked to her

front door and encountered her boyfriend who started to assault her. The victim attempted to defend herself at which time Strouse punched and held her on the ground while choking her with his hands. During the assault, he bit the victim's ear and struck her with a wooden chair.

The victim was able to escape and hid underneath her bed as she called 911. Meanwhile, Strouse proceeded to throw the chair into the television set and damaged several items inside.

After he was released from the hospital, Strouse was charged with the following offenses: possession of a deadly weapon during the commission of a felony, felony assault, unlawful imprisonment, terroristic threatening, felony criminal mischief, two counts of endangering the welfare of a child, and resisting arrest. He was later arraigned and committed to the Howard Young Prison after failing to post \$28,000 secured bail.

Girl Scouts compete in first annual national racing event

Girls, start your engines! That's the directive 12 Girl Scouts from Troop 425 of the Girl Scouts of the Chesapeake Bay Council, Inc., will hear on October 24 when they become the first Troop in the nation to race in Girls-In-Gears, a hands-on engineering and racing program debuting from the American Kart Racing Association (AKRA). The NASCAR Wives Association and several Waltrips, of Daytona International Speedway and Daytona 500 family dynasty legend, are involved in the event.

Selected for Girls-n-Gears

after a chance conversation between Troop 425 Leader JoAnn Bruch and co-worker Susan Taylor Walls, whose husband works with AKRA, the "daring dozen" will lap up the excitement of professional racing at Amelia Motor Raceway in Amelia Courthouse, VA. There, the girls will learn from professional male and female race car drivers how to design and drive a race car, assemble an engine, mount tires, calibrate speed, and more.

"We dream big," said Bruch, whose 11-year-old daughter, Taylor Michael, is in her Troop, which is part of the Girl Scouts of the Chesapeake

Bay Council, Inc. (GSCBC). "Some of these girls are very gifted in math and science and could end up being engineers for NASA or anywhere."

The girls created original designs for their karts' exteriors. After arriving in Virginia on Friday, October 23, they will be reunited with their designs, which will be emblazoned on karts. The girls will receive a briefing on kart engineering, aerodynamics and driving from professional race drivers and engineers. The engineers will lead a workshop in which the girls must mount tires, build engines, assemble karts, and learn to calibrate

speed and stopping distances.

After sleeping overnight at a nearby Girl Scout camp in Richmond, the girls will arrive at Amelia Raceway at 8 a.m., Saturday, to meet with former NASCAR Sprint Cup winners, tour the car pits, and review the track. The girls will drive their karts by themselves more than 15 laps around the 1 1/4 mile track and be scored on their best finish times. Then, they will assemble at the starting line and race each other for the Girls-n-Gears Championship Award.

The Girls Scouts will earn a Service Patch for successfully completing the event.

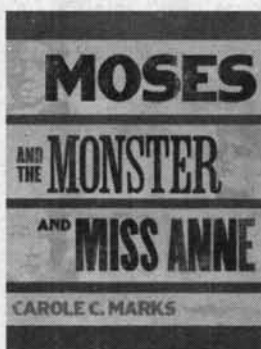

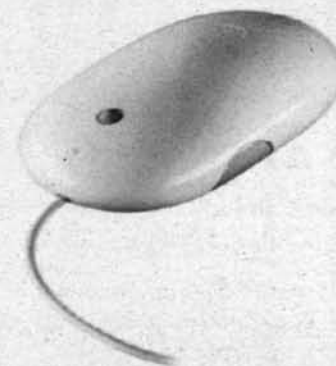



We had eleven out of 28 schools achieve a return rate of 90 percent or higher, and that was very impressive. I hope that this will become an annual tradition."

OUT OF THE ATTIC

This week's Out of the Attic item is a picture circa 1940 of Richards Dairy at 57 Elkton Road. The dairy store in front was popular with college students and townsfolk for its homemade ice cream. Milk from area farms was processed and bottled in the back. Edward F. Richards started the business in 1921 at the family home on the southeast corner of Main and Haines Streets. By 1928, 50 quarts of milk were hand-delivered daily. The family

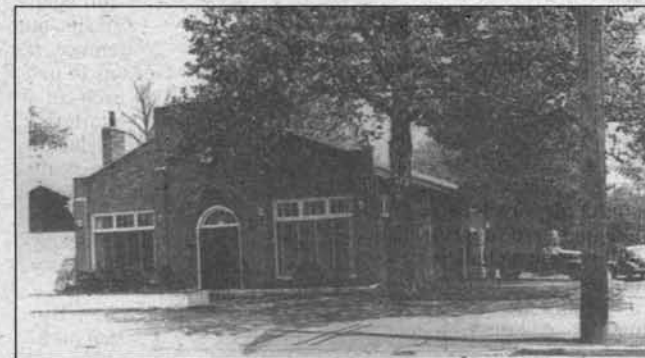
and dairy moved to 22 Choate Street. Richards' wife, Lillian, and daughters Ann and Elizabeth assisted in the business. About 1940 Richards bought the Elkton Road site and moved the growing dairy operations advertised as being "Newark's only home owned dairy." Retired in 1952, Edward sold the dairy to Elizabeth and her husband Alexander. They continued home delivery until the late 1960s. The property became a High's Dairy Store, The Crab Trap Restaurant, The Trap, and was recently razed to build Amstel Square.

The picture is on loan to the Newark Post from the Newark Historical Society collection.

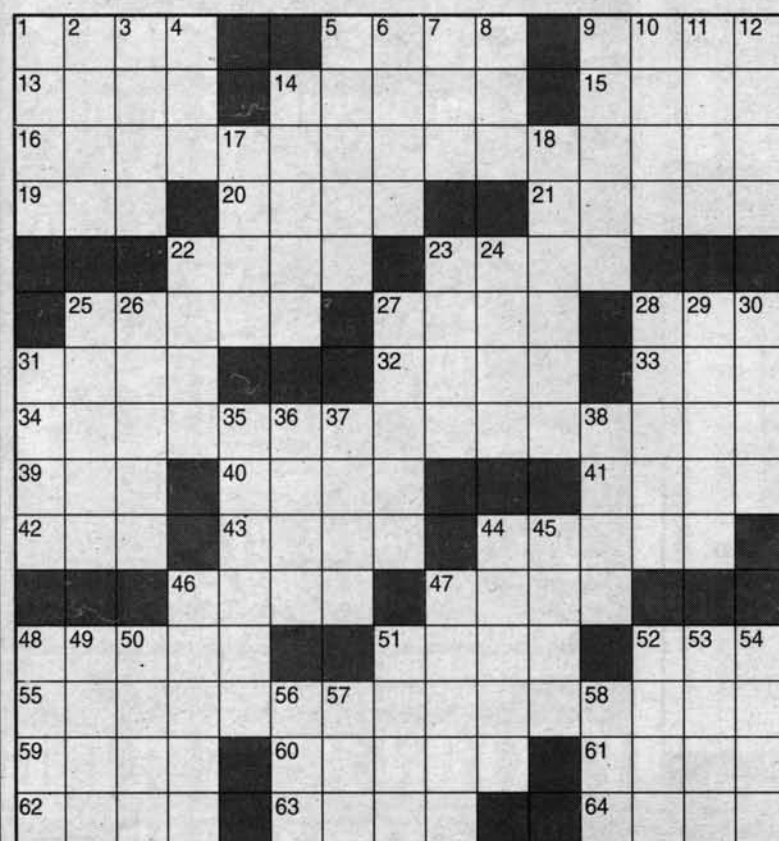

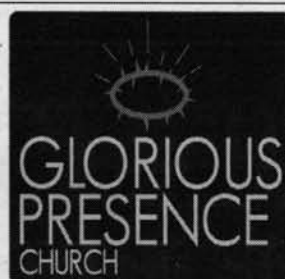

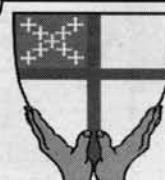

Newark American Legion Post #10 keeps "Old Glory" flying over Canada

In December 1941, Torbay, Newfoundland native Thomas Houlihan was visiting friends in America when he learned of the Japanese invasion of Pearl Harbor. Becoming enraged at the news, Houlihan volunteered to serve in the U.S. Army. After helping to liberate North Africa, Houlihan continued his service in Sicily and was part of the mainland attack of Salerno on the Italian coast before he was killed in action in 1943.

His body was returned to Canada, where a friend, Ronald Maher, erected a flagpole and monument to honor Houlihan's service to America. After the first flag became tattered by Torbay's unrelenting winds, Maher sought assistance for additional flags from the American Legion.

When the Lt. J. Allison O'Daniel American Legion Post #10 in Newark learned of the project, they stepped forward and have donated two flags every year. The high winds of Torbay require the flag to be replaced every six months.

The members of the Post are proud to support such a fitting tribute to an individual who gave his life in defense of the United States.

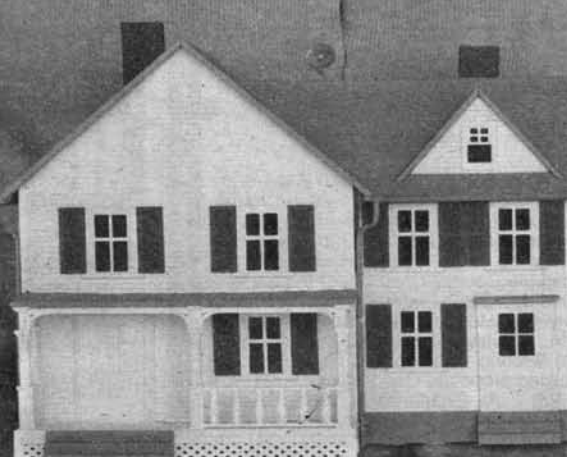

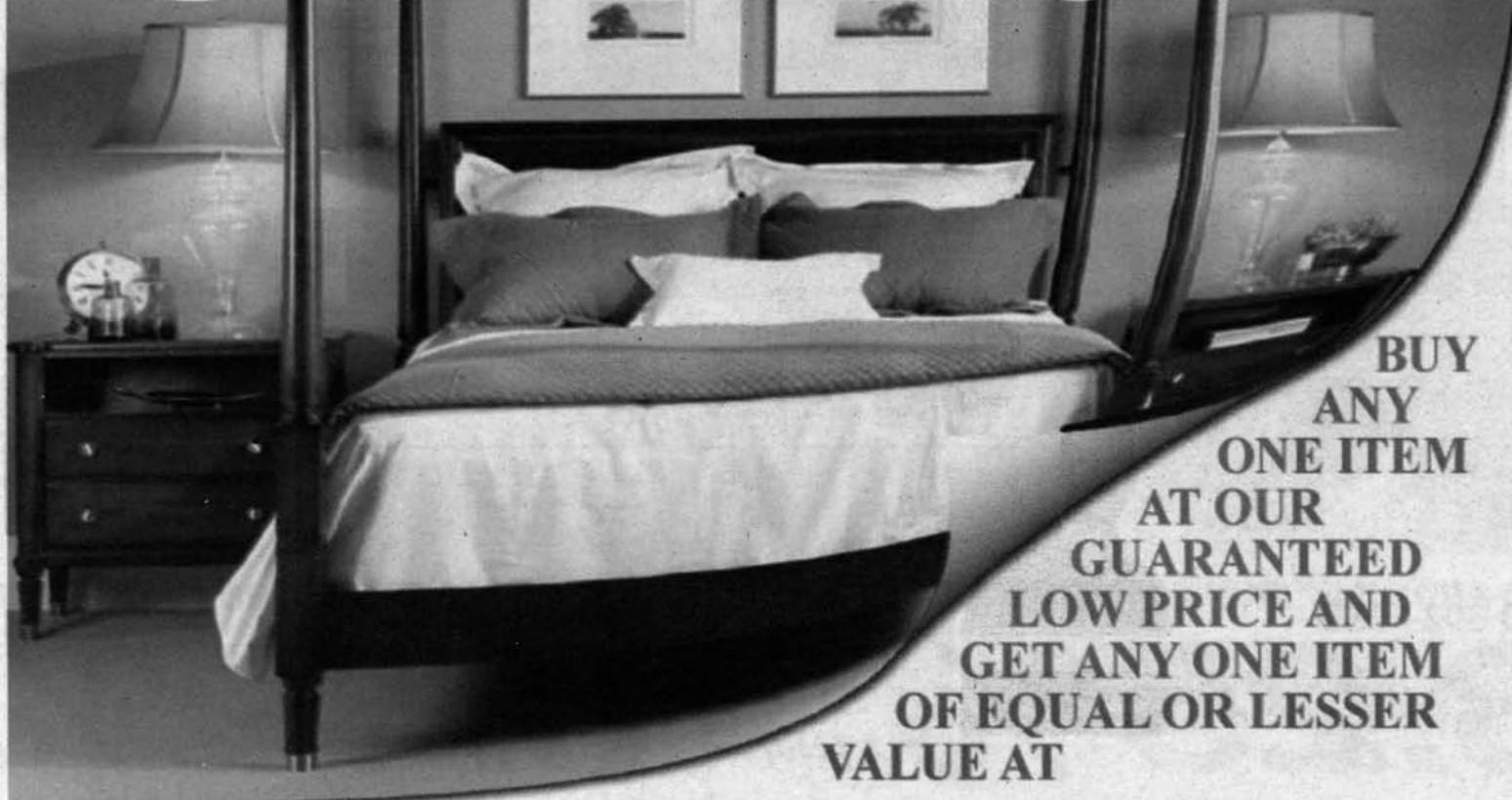
