Recreation fees will jump 25%

At Monday's meeting, Town Council voted to increase Parks and Recreation program fees for Fall 2009. In response to concerns from Newark participants and council members, fees will be increased 25 percent for residents and 33 percent for nonresidents, with the likelihood of further increases in future years.

An earlier proposal called for a doubling and even tripling of some fees.

This incremental concept was suggested in a letter from City Manager Kyle Sonnenberg to the Newark Council. Sonnenberg wrote the concept that fee increases would be limited each year to either a 25 percent increase for residents or a 33 percent increase for nonresidents. He writes, "over a period of years, these increases would be applied until the fees reach the level where they recover the proportion of the cost specified..."

Council has also agreed to look at charging more for adult programs, as opposed to child programs, in an effort to alleviate financial burdens on families. The City Manager writes, "We have limited the resident youth cost ultimately to be collected to

Newark girl's red tresses featured in new book

The daughter of Cynthia Rice of Newark is perhaps the cutest of 400 redheads featured in a book published by mom and former

California marketing executive, Nicole Giladi. And no, NBC late night host Conan O'Brien failed to make the list. Redheads in the book had to be under 10.

After noting the attention that the copper-colored locks of her son received, Giladi put her marketing and writing skills to work to publish, *Little Redheads Across America*.

The coffee table book features 400 redheads from all 50 states, chosen from a field of 2,500.

In addition to the over 400 professional photographs, the book contains facts about redhead's characteristics like freckles, sunburns and genetics.

"I was fascinated to learn that redheads make up only two to four

percent of the US population. I was also astonished to learn that it's a recessive gene, which means both my husband and I gave our son his copper-colored locks," said Giladi.

The United States has the largest population of redheads in the world, with the number ranging from 6

Dogged police work cracks motel shooting case

A two-state investigation into the murder victim found in Carneys Point, N.J. led to a Newark motel room and a Bear resident suspected of the crime.

On July 10, the Newark Police Department was con-

tacted by the Carneys Point Township Police Department and Salem County Prosecutor's Office about a murder investi-

gation that had been going on since May.

The investigation began on May 4 when the body

of an unidentified black male was found near Courses Landing Road in Carneys Point Township, N.J., a short distance from the Delaware Memorial Bridge. The victim had suffered multiple gunshot wounds.

A story in Today's Sunbeam newspaper reported the man had been shot twice in the back of the head and once in the temple. He was found clad in only his T-shirt and underwear, his head and feet wrapped in black trash bags.

The Carneys Point Township Police Department and Salem County Prosecutor's Office began their investigation and it took approximately four weeks to identify the victim as Steven Hinds, 29, of New York City. Today's Sunbeam reported he was in the clothing business.

Their investigation revealed that the victim had made statements to acquaintances that he was concerned for his welfare and feared for his life, in the weeks leading up to his death.

At this point in the investigation, the reasons for the victim's concern have yet to be determined with certainty, according to Newark Police.

The investigation traced the suspect's and victim's location to the Super 8 Motel at 268 East Main Street in Newark on the weekend of May 3. It is at this location in a room rented by the suspect, Leonard Michael Taylor, 23, Anderson Court, Bear, where Hinds was murdered.

Taylor was identified as a gang member of the "Bloods". It is not known whether Hinds, who was in the clothing business, had any ties to the gang.

Crime scene processing performed by the Newark Police Department confirmed evidence of human blood inside the room where they stayed; further DNA analysis is pending.

Currently, Taylor is jailed in Harford County Md. on a probation violation. His extradition to Delaware is pending.

Salem County Prosecutor's Office Chief of County Detectives Ralph Padilla said "The arrest of Taylor speaks volumes to the resolve and professionalism of the detectives from adjoining states

that worked on this lengthy investigation."

"The multi-state cooperative effort which brought this case to its investigative conclusion exemplifies what can be accomplished when dedicated public servants work together," he said.

Carneys Point Police Department Chief of Police Edmund Spinelli Jr. commended the efforts of the detectives responsible for bringing the defendant, Michael Taylor, to justice. "An investigation of this magnitude cannot come to an unfortunate but successful conclusion without their resilient effort and utilization of a multitude of resources. The professionalism and expertise displayed in this investigation speaks volumes for all of the officers involved. I previously stated that the detectives will do everything in their power to track those responsible for this heinous crime and we will find out who is responsible. The detectives have done just that. Although the investigation has led to the arrest of Taylor, additional arrests are anticipated for their involvement in this crime. The diligent work put forth will give closure to the victim, his family and the community," he stated.

Chief Paul Tiernan of the Newark Police Department offered his appreciation to New Jersey law enforcement authorities, adding that their professionalism and diligent efforts working with the detectives of the Newark Police Department have brought a serious crime to a successful conclusion in the city of Newark.

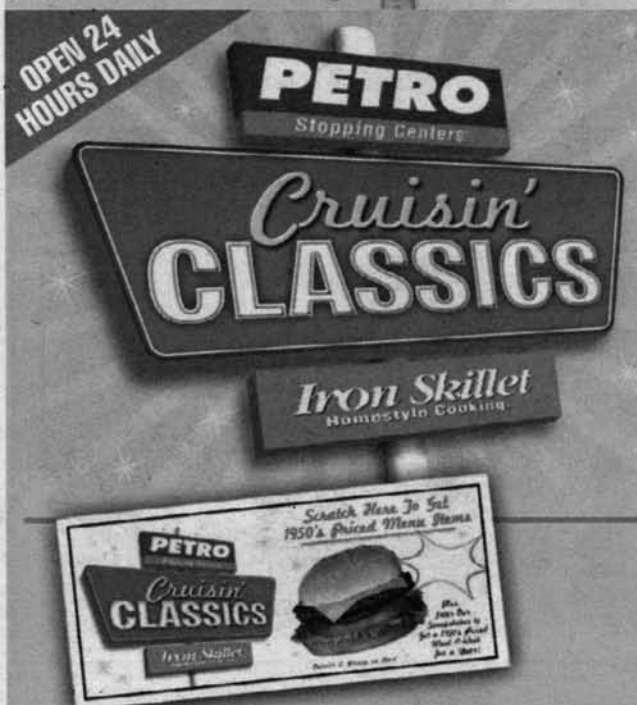

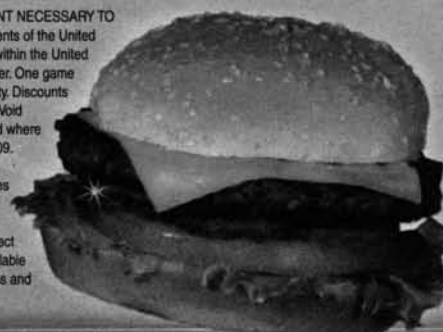

Alcohol sales approved for Catherine Rooney's

100% of direct costs and 50% of departmental overhead. This reflects your interest in providing youth services at a lower cost than adults." He continues, "The resident adults cost ultimately to be collected would be 100% of direct costs and 100% of departmental overhead."

The council discussed many possibilities, including subsidizing programs or even providing scholarships for needy families.

Councilman Ezra Temko suggested keeping the fees the same for both residents and nonresidents, in an effort not to alienate people living outside of Newark. He also stated that the Parks and Recreation Department is important for keeping youths off the street and preventing the need for more police enforcement, which would increase costs to the city.

Councilman Paul Pomeroy told Council to not "price ourselves out", claiming that too large an increase would create fewer participants, thereby generating less revenue. The councilman noted that a few of his constituents have sent e-mails saying they would rather have a tax increase than to cut programs.

In other news, Council voted 4-2 for granting a Special Use Permit to the sale of alcohol

to Catherine Rooney's, a full-service Irish pub in the Trolley Square section of Wilmington, that will be located at 102 E. Main St., on the Bank of Newark site.

Residents of the Washington House condominium building voiced their opposition to Council.

Several condo owners stated that Newark is not in need of another bar, especially one that is across the street from them. Since live music will be featured at the restaurant, condo owners are also concerned about noise levels and after-hour loitering

near their residences.

Catherine Rooney owners Joseph and Gerry McCoy told Council members of their neighborhood and city partnerships in Wilmington to illustrate that the pub will not be just another college bar, but a business that caters to families and the community.

Though Catherine Rooney's has been granted the ability to serve alcohol until midnight, McCoy asked for the possibility of serving till 1 pm, in the future, if the restaurant proves they are a reputable establishment. Councilman Jerry Clifton

stated his reluctance to approve the permit and asked McCoy why a business geared toward families would need to be open that late.

Council approved the second reading of an amendment to the city code designed to control predatory towing that has occurred even when an individual was visiting the business. The amendment adds the words "before or" to the present code to read, "...A general written authorization may be provided for non-consensual trespass towing to be done outside of the property owner's (or agents')

normal business hours, provided that any vehicle towed before or after business hours must have been parked for one full hour prior to being towed..."

Owners will still have the ability to tow cars from their property before their business opens and after it closes in cases where "predatory parking" is taking place.

The towing issue continues to bedevil the city, with numerous accusations that it drives away shoppers. (See letter on Page 6.)

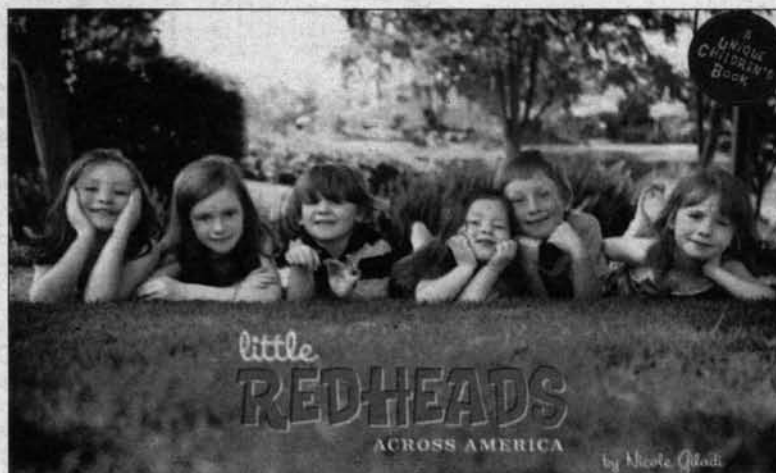
Book has America seeing red

million to 12 million. That may be due to this nation's high rate of immigration from Scotland and Ireland, two nations believed to have the highest percentage of redheads. While closely associated with Britain and Ireland, virtually all races have examples of red hair.

Giladi also notes that the recessive gene could mean the end of redheads, taking note of a National Geographic story that predicts the gene could disappear. Man arrested in samurai sword death

New Castle County Detectives have arrested Michael Kolesar, 21, Sandlewood Drive, for allegedly stabbing his girlfriend to death with a samurai sword. The resident of Glen Eagle Village Apartments has been charged with manslaughter in the death. The apartments are near Christiana High and Salem Church Road, southeast of Newark.

New County Police responded to Kolesar's apartment for a report of a cutting involving a sword. When the officers arrived, they immediately took the two male occupants into custody and found a female victim dead in a rear bedroom. The victim had sustained a stab wound to her upper torso. The investigation indicated Kolesar and girlfriend, 21, had engaged in a verbal altercation while patronizing a local bar. When they returned home, the argument continued and turned physical.

Kolesar has been charged with manslaughter and possession of a deadly weapon during the commission of a felony. His arraignment disposition is pending. The other male was released from custody and not charged with a crime.

Man waves gun

On Friday, July 24, Newark Police arrested Jarrod Penn, 30, of New Castle, for entering the residence of his ex-girlfriend, Kychona Price, 26, of Madison Dr., Newark, and waving a gun at her and their children.

Police earlier that night responded to a Domestic Disturbance call at Price's residence. Price stated that Penn had entered the house, by an unknown means, and started waving the handgun and saying that he would hurt a friend of Price's. Price then called 911 on her cell phone and left the line open. Penn took this phone and Price's work phone and left the house. After the house was secured, Penn re-entered the house by an unlocked window and asked Price why she called

the police. At this point, Price retrieved her personal phone from Penn who answered it when 911 called back.

Penn fled the scene in his silver Infiniti I30. When police arrived, Penn placed a call to Price using her stolen work cell phone asking her to meet him at Nick and Joe's in Pencader Plaza, outside Newark.

When police arrived to arrest Penn, he led them on a short chase, after which he ditched his car, the cell phone, and his gun. Penn was arrested on Burglary Second Degree, Aggravated Assault, Theft Under \$1,500, four counts of Reckless Endangerment, Possession of a Firearm During the Commission of a Felony, Possession of a Deadly Weapon By Person Prohibited, Failure to Stop at a Red Light, Reckless Driving, and Disregarding a Police Officer Signal. Penn was given \$69,000 secured bail and taken to Gander Hill Correctional Facility.

Bear bank robbed



Delaware State Police are investigating a bank robbery late Friday afternoon at the PNC Bank branch at Eden Square, near the intersection of Routes 40 and 7. Troopers said the man, between 30 and 40 years of age and with an average build, presented the teller with a note demanding money. The teller complied. The suspect then fled the bank.

Unknown suspect deposits stolen check

Police are investigating a \$1,000 check stolen from The Raymond Entertainment Group, located at 62 N. Chapel St., Newark. Manager Mark Doughty told police that a check that was endorsed by him and was on his desk before he left for vacation has turned up missing. Doughty stated that his reason for not depositing the check was that he was waiting until his

business had enough money to cover the amount.

Doughty says that there is no surveillance at his business and that he does not suspect any of his employees. The landlord has been contacted to see who has access to the building. The stolen check was deposited into a PNC via ATM, but local bank officials, so far, have not been successful in locating either the check or the account. Both PNC Loss Prevention and the Newark Police are actively searching for the missing check.

Checkpoint nabs man with prior DUI's

Michael McLaughlin, 43, of Newark was arrested at a Sobriety Checkpoint set up at Capital Trail and Poplar Ave., last Friday. An intoxilyzer test at the station showed McLaughlin had a blood alcohol content of .281. A DELJIS check showed four prior DUI arrests: March 1989, October 1990, July 1998, and May 2003. McLaughlin was charged with 5th Offense after Four Prior Offenses, Driving a Vehicle.

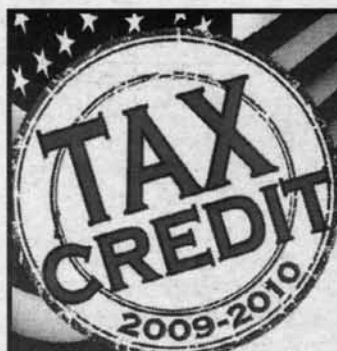
15 foot display stolen on Main Street

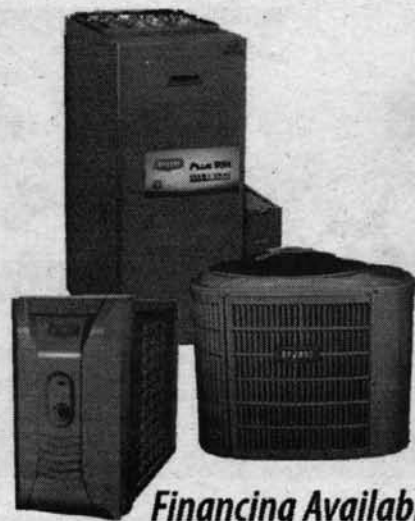

A faith-filled life remembered

The Rev. Chuck Better's of Glasgow Reformed Presbyterian Church did not hesitate when asked to describe 11-year-old Ashley Van Wingerden.

"She loved the Lord," Better's said. "She loved studying the Scriptures and memorizing verses. Ashley's faith was unusual for an 11-year-old. She didn't mind telling people about her relationship with Christ," Better's said.

Ashley was a typical girl, too.

"She loved dancing. She loved music. She loved playing on her family's farm. And she loved boating. It was a pretty big deal when her family got a new boat," Better's said.

Then he paused.

"She was so full of life. She was a very special girl. I know all parents think their children are special, but she truly was a very special girl."

Ashley was a fifth-grade student at Red Lion Christian Academy, Bear, where she went after Ashley's parents home-schooled her, said Better's.

Better's, senior pastor at the church made his comments on Monday night — a day after police found Ashley's body floating in the Sassafra River near Ordinary Point in Cecil County.

The recovery of her body at 8:30 a.m. Sunday ended an intense three-day search that started after a large wave knocked Ashley out of her family's boat about 4 p.m. on Friday.

The accident happened while the girl was sitting on the bow, or front, of a 22-foot motor boat

operated by her father, Jake Van Wingerden of Earleville.

Also on board were her 7-year-old brother, Jacob, and her uncle.

"When the boat rounded Ordinary Point, it encountered a large wake from a passing tug boat in that area and the victim was thrown into the water and did not resurface," explained Art Windemuth, public information officer for the Maryland Natural Resources Police.

Ashley wasn't wearing a life jacket, police said.

But the girl wasn't required to wear a flotation device, by law, police added.

Earlier this week, Better's provided information about Ashley and her family, who have been members of his church for at least seven years.

Better's described the Van Wingerdens, who operate Tidewater Growers Farm in

Earleville, Md. as "very active in the church."

He also described the Van Wingerdens as a faithful Christian family consisting of Jake; his wife, Wendy; and their children — Grace, 15 months old; Emma, 3; Jacob, 7; and Ashley, who was the eldest child.

"The family is absolutely devastated, as you can imagine,"

Better's said. "I've been over their house every day since this happened (Friday), just sitting with them, praying with them, counseling them and sharing our experience."

Better's can empathize, and not just because he's a minister who has helped countless families deal with their grief over the loss of loved ones.

On July 6, 1993, his 16-

year-old son, Mark, died in a car crash that also killed Mark's girlfriend. He was the youngest child of Better's and his wife, Sharon.

"To this day, we still don't know what happened," Better's said. "Today, Mark would have been about the same age as Ashley's parents. They're in

This week's Out of the Attic features a 1973 view looking east at the fire at the original Aetna Fire House (1890) on the west side of Academy Street. The fire broke out early in the morning on March 16, 1973 resulting in extensive damage to the historic property. The fire engines are in the parking lot behind the Main Street School building. After the Aetna Fire Co. had moved in 1922 to its new building across Academy Street, this building was variously used as the Town Hall, the Police Station, and the Alderman's Court. After the fire, the building was restored and, in 1975, returned to active use by Aetna as an emergency ambulance station.

The picture is on loan to the Newark Post from the Newark Historical Society collection (courtesy of Aetna Hose, Hook, and Ladder Co.). The Society is seeking pictures and other artifacts of places, activities, and life styles in the Greater Newark Area.

I became aware of what I would call a very poor business practice involving the Newark Shopping Center, and possibly the Newark City Council. I received a phone call from a relative that one of her friends had her car towed from the Newark Shopping Center and asked if I would provide a ride to the tow truck parking area (this was Saturday evening, July 18th, and they had dinner on Main Street). After providing the needed ride, I asked some questions of those who are a part of the towing process – and I was taken back by the answers I received.

The scenario as I was told is that if you park in the Newark Shopping Center, and then leave the premises – if you shop there

or not that night – you will be towed. The explanation I was given was that this was needed to be done so that customers of the various stores, etc., would have room to park, and that the center's management, the City Council, and the Police Department all agreed that this was a good practice. This sounded reasonable until I thought it through, and realized that this was in reality a "sham" (a legal, but unethical one), a poor business practice, and most of all, a very serious safety issue.

To start with, I have shopped in this center for at least ten years, and have never had a parking problem. And during the summer, it's not nearly full.

I think it's ironic that the Newark merchants ask us to shop locally and then the town's officials allow this type of action to go on. Incidentally, I have shopped at Minster's, Second Source and Audio Works,

in addition to shopping regularly at the Salvation Army and Dollar Store, as well as eating at the Mexican (no longer there) and Vietnamese restaurants, and bowling at the Blue Hen Lanes – with never a parking problem!

For many years, my wife and I have eaten and shopped at the center, then attended the Chapel Street Playhouse – obviously this can't happen going forward. If at all possible, I and whomever else I can persuade will shop somewhere else... where someone isn't lying in wait to catch you and get the tow truck out!

My letter may seem sarcastic, but it's hard not to be upset at this happening in a place that I think is really a great town. I hope someone will take some action to correct this out-of-character process for Newark... and before any tragedy occurs as a result of the towing process.

When integrity won out over greed

Seldom in recent memory has there been a time when money – or the lack of it – has been so important to

all of us.

The failure of companies once regarded as the foundation of our nation's economy and the collapse of Wall Street financial titans has adversely affected institutions and individuals alike. Federal, state and local officials are struggling for new sources of revenue and appeals for assistance have grown more frequent and more strident in tone.

Democratic supporters are begging for funds to implement programs advocated by the White House, while their Republican counterparts plead with equal passion for contributions to block them. Desperate pleas for help cite the needs of the poor, the environment and animals, both domestic and wild. Museums, the performing arts, and historical and educational group of all descriptions are increasingly aggressive in seeking gifts from all

potential sources.

Even our own University of Delaware recently initiated an elaborate scheme whereby alumni will henceforth be evaluated by their level of financial support – a level that also will determine the location of their seats and parking places at future athletic contests.

This policy change led me to recall an incident in happier days when integrity triumphed over greed. That moment came in 1977 when Coach Tubby Raymond's underdog Division II Blue Hens faced the unenviable task of playing a Division I Colgate team, then ranked first nationally in total offense and fourth in scoring.

The Red Raiders were considered a shoo-in for the Lambert Trophy, awarded annually to the best team in the East, and the game had attracted national attention. ABC-TV offered a handsome fee of \$175,000 to televise the game, if Delaware would agree to change the starting time to 4 pm and move the site to Philadelphia. The decision was Delaware's, since the game initially had been scheduled at Delaware Stadium.

Most athletic offices would have jumped through a hoop to accept such a lucrative pay-off, but the Blue Hens' athletic director, David M. Nelson, was not only a capable administra-

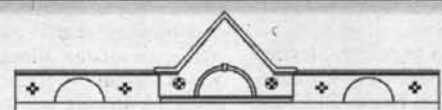

Newark man loses foot in cycle-car mishap

A Newark man and his wife remained hospitalized Wednesday, three days after their motorcycle crashed into a sport utility vehicle near the Chesapeake and Delaware Canal Bridge on Route 213 in Maryland.

Maryland State Police identified the injured couple as 53-year-old Stephen Wayne Mikulcik and 53-year-old Ann Marie Mikulcik.

Mikulcik's right foot was severed in the crash, while his wife suffered a major cut to her leg, resulting in a significant loss of blood.

Both were taken to the University of Maryland hospital where they were listed in good condition.

A companion motorcyclist, 30-year-old Edward F. Goralski Jr., also of Delaware, suffered lesser injuries in the traffic accident, police said.

According to police, Stephen Mikulcik was driving a motorcycle north on Route 213, just south of the Chesapeake and Delaware Canal Bridge, at about 7 p.m. when a GMC Suburban pulled into his path. Mikulcik's wife was riding on the back of the motorcycle.

The SUV driver, Susan Mitrishin of Pennsylvania, reportedly was attempting to

turn left as she left the parking lot of an ice cream stand off of the northbound side of the highway when she pulled in front of the motorcycle.

The Mikulciks' motorcycle smashed into the SUV as it crossed the northbound lane, police said.

Meanwhile, Goralski, who was riding a motorcycle behind the Mikulciks, attempted to avoid the crash, police added.

Goralski was taken to Union Hospital, where he was treated for scrapes and other minor injuries.

Mitrishin and her husband, who was in the front passenger seat of the SUV, suffered no injuries, according to Proctor, who noted that the couple was able to drive their vehicle away from the accident scene.

Heroin arrest

New Castle County Police have arrested Kevin Gunter, a 20 year old male who resides in the unit block of Burleigh Court in the Bear-Glasgow area. He has been charged with trafficking heroin and related drug offenses after county police officers executed a search warrant at his home and recovered

220 bags of heroin. An additional 11 bags were later recovered from his buttocks prior to being placed in a holding cell at police headquarters.

Over the past week, officers from the Mobile Enforcement Team (MET) were assigned to conduct proactive patrols in the area of the Iron Hill and Vinings Apartments in response to complaints of disorderly subjects, loitering and open air drug transactions. Over the past few days, MET officers stopped a number of cars that were leaving the apartment complex and learned that at least three vehicles had occupants who had just purchased heroin from within.

Based on information gathered from the traffic stops, MET officers were able to apply for and obtain a search warrant for the home of the alleged dealer, Kevin Gunter. A further inquiry revealed Gunter was on probation and was wearing an ankle monitor device.

MET officers and officials from Probation and Parole executed the search warrant at the home and found Gunter and four children inside. During the course of the search, officers found 17 bundles of heroin (220

baggies) from a drawer in the kitchen and \$1,400 in suspected drug proceeds.

Gunter was arrested without incident and transported to police headquarters where an additional 11 bags of heroin was recovered from his buttocks area. He has been charged with the following offenses: trafficking heroin, possession with the intent to deliver heroin, maintaining a dwelling for keeping a controlled substance, tampering with evidence and four counts of unlawfully dealing with a child. He was later arraigned and committed to the Howard Young Prison after failing to post \$43,500 secured bail.

Crash claims life

A fiery two-vehicle crash Sunday night claimed one life on the Roth Bridge over the C&D Canal. The vehicles involved in this crash were a 1991 Ford Van, operated by Patrick Turner, 21, of Virginia Beach and a 2007 International Tractor-Trailer, operated by Lloyd Jones, 51, of Dover. According to the Delaware State Police, the van was traveling on Route 1 southbound, in the middle lane, toward the top of the Roth Bridge when the vehicle experienced mechanical problems, caus-

ing it to rapidly lose speed. The tractor-trailer approached the van and was unable to avoid the vehicle. A rear-end impact took place and both vehicles veered to the right, with both erupting into flames. The van had five occupants. Four of the five people were able to escape from the burning vehicle. However, a female 21-year-old rear seat passenger, was trapped inside. She was pronounced dead at the scene once the flames were extinguished. The release of her name is pending a notification to the next of kin. A computer check revealed Turner was driving with a suspended license. This crash remains under investigation and no charges have been filed.

The victim heard mumbling and laughter on the phone and went to the front door to knock. As he was approaching the house, he was approached by three suspects, one of whom was displaying a handgun. The suspects then demanded the victim's money, cell phone and the food. One of the suspects went through the victim's pockets from behind and removed his cash and cell phone. They also took the pizzas that he was carrying. The suspects all fled north on Jefferson Street without harming the victim.

The suspects were described as three black males, 15-18 years old.

Ramada Inn robbery

Delaware State Police are investigating an armed robbery at the Ramada Inn on Chapman Road in the Christiana area. Three subjects, two black males and one black female, entered the lobby, dressed in dark clothing with their faces covered with scarves. The female remained in the lobby as a lookout while the two male suspects jumped over the counter. One of the males was displaying a black handgun while demanding cash from the clerk. The clerk complied and the suspects made off with an undisclosed amount of cash. They were last seen fleeing the scene

Police to operate sobriety checkpoint

Delaware law enforcement officers will be running a sobriety checkpoint this weekend in the Newark area.

To date, police have arrested 26 individuals for Driving Under the Influence (DUI) of alcohol and/or drugs last weekend under the Checkpoint Strikeforce campaign.

Agencies conducting checkpoints included the New Castle County DUI Task Force (Newark), DSP Troop 5 (Laurel), DSP Troop 6 (Newport) and the Rehoboth Beach Police.

In addition to the 26 DUI arrests, officers issued one citation for underage drinking, apprehended six wanted individuals, made eight drug arrests, nine felony arrests, seized one weapon, issued seven seat belt citations, two child restraint citations, and issued 58 citations for various other traffic violations.

The weekend's enforcement brings the total number of arrests for the first month of the 2009 Checkpoint Strikeforce campaign to: 85 for DUI, 25 for drug violations, 26 for felony violations, and two for underage drinking violations. In addition officers have recovered one stolen vehicle, apprehended 20 wanted individuals, seized two weapons and issued 43 citations for seat belt violations, 13 for child restraint violations and 243 for additional traffic violations.

Checkpoint Strikeforce is a regional sobriety checkpoint campaign aimed at arresting DUI offenders, and using high visibility enforcement to deter those who would otherwise choose to drink and drive. The campaign, a six-month-long effort running through New Year's Eve, involves setting up weekly DUI checkpoints statewide.

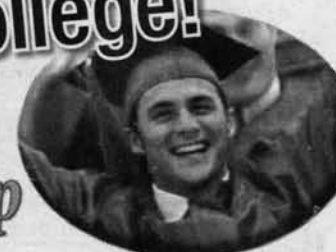



President to honor local science teachers

Patricia DeLeon, professor of biological sciences and member of the Board of Trustees at the University of Delaware, and two graduates, Jo Anne Deshon and Karen Fredricks, will be honored by President Barack Obama for excellence in science, math and engineering teaching and mentoring.

The Delaware trio will receive the Presidential Awards for Excellence during a White House ceremony in the fall.

DeLeon will receive the Presidential Award for Excellence in Science, Mathematics and Engineering Mentoring, which is presented each year to individuals or organizations in recognition of the crucial role that mentoring plays in the academic and personal development of students studying science or engineering and who belong to minorities that are underrepresented in those fields.

Deshon, a first grade teacher at John R. Downes Elementary School in Newark and Fredricks, a fourth grade teacher at Thurgood Marshall Elementary School in Newark, will each receive the Presidential Award for Excellence in Mathematics and Science Teaching, which is awarded annually to the best pre-college-level science and math teachers from across the country.

DeLeon has mentored more than 100 trainees, including undergraduates, graduate students, postdoctoral fellows and visiting scientists from around the world. A large majority of her undergraduate mentees are women and about one-third of them are minorities. She also has mentored young faculty in the early stages of their careers.

Deshon, who earned a master's degree in education in 1980 and a doctorate in education from UD in 2000, said she owes the honor for teaching science to her nomination by her school's principal, Denny Schwartz, and a former UD graduate student, Julie Kittleson, assistant professor of mathematics and science education at the University of Georgia, who earned a doctorate in education from UD in 2006.

Fredricks, who earned a degree in elementary education from UD in 1975, said she is thrilled to be honored for teaching mathematics and by the

possibility of meeting Obama during the award ceremony.

Each award winner will receive \$10,000 from the National Science Foundation. They also will

receive an expense-paid trip to Washington, D.C. for the White House awards ceremony and several days of educational and celebratory events, including visits with members of

Congress and science agency leaders.

The winners are selected by a panel of distinguished scientists, mathematicians, and educators following an initial

selection process done at the state level. Each year the teaching award alternates, going either to science and math teachers in grades K through 6

- as it is this year - or to those teaching in grades 7 through 12.

Bear resident Smith commits to Syracuse

What started out as an opportunity of a lifetime to attend

Syracuse University's one-day football camp earlier this month, turned into a life-altering opportunity for Pencader Charter's senior-to-be Jerome Smith.

Smith, a 5-foot-11, 210-pound running back who rushed for 936 yards and scored eight touchdowns as a junior, informed Syracuse coach Doug Marrone he has accepted their scholarship offer and plans to sign a letter of intent in February.

"I was very impressed and excited about the facili-

ties," Smith, who also received a scholarship offer from Wisconsin, said in a phone interview. "I knew about a week after I got home from the campus after following up with some of the coaches that it was where I wanted to go."

While going away to college will be a big move in and of itself — he had never even been to the state of New

York until his visit to the college campus — Smith says it is the speed of the game which will be the biggest challenge playing at the next level.

"The pace of the game is so much faster," he said. "Time management during the game is also much more critical in college."

Pencader coach Rahsaan Matthews believes Smith, who also played outside linebacker and strong safety on defense during Pencader's 7-3 season in 2008, is the perfect candidate to help Syracuse continue to rebuild its football program. The Orangemen have gone 10-37 the last four years.

"Jerome helped turn our program into a solid program and I really believe he embraces the underdog role, which made Syracuse intriguing," Matthews said in an e-mail. "As a running back he can truly do it all, which is what the Syracuse coaches are looking for. He is a back that can run you over or make you miss and get in the end zone. Jerome has the ability to do both."

And it's not just on the field that Matthews feels Smith will excel, but also in the family atmosphere off the field that Marrone is trying to establish during the rebuilding process. "Off the field Jerome is a high character individual," added Matthews, who played quarterback at William Penn High School and Delaware State University. "He's just a really good kid who enjoys being with his family and teammates. And that family atmosphere

that the new Syracuse staff is developing is what I think sealed the deal for Jerome."

With the decision behind him now, Smith can focus on his senior season, when he claims he'll have just one goal in mind: "To win the state championship. I'm willing to do whatever it takes to make that happen."

kids can be covered.

The bill, House Bill 139, allows families with personal incomes above 200 percent of the federal poverty level to pay a small monthly premium to insure their children. The state's Children's Health Insurance Program (CHIP) was only available to children in families that have an income level less than 200 percent of poverty. This new program could help 9,000 uninsured kids receive health insurance.

I also authored a bill that requires screening for developmental delays for infants and toddlers, and requires that private health insurers in Delaware cover the screenings. House Bill 199 was recommended by the American Academy of Pediatrics and the Delaware Early Childhood Council and would cost the policyholders of these screenings a mere three cents a month. Providing these early screenings is essential to ensuring that children are diagnosed early for any problems and can get treatment as soon as possible.

After learning of an incident

in which a May B. Leasure Elementary School student was suspended and faced expulsion for bringing a knife to school to cut a cake, I introduced and the General Assembly passed legislation that gives school boards more discretion in enforcing the state's "zero tolerance" provision.

I think adults know the difference between a weapon and a knife being used to cut a cake. But because the law was so strict and there was no room for discretion, families were placed into difficult situations where they have to get a lawyer to fight expulsion. The new

law allows school boards to modify the terms of expulsion or determine that expulsion is not appropriate on a case-by-case basis.

I also sponsored legislation that will give schools more flexibility with how they utilize their funds, while making sure that more funds make it where they are needed most - in the classroom. We need to continue looking for ways to spend less on administrative costs and funnel more funds directly into classrooms.

Lastly, we passed legislation eliminating the Delaware Student Testing Program

(DSTP) and will replace it with a more adaptive test that better serves the students who take it and helps the teachers manage their classroom. Educators should not be teaching to a test; the test should help them teach more effectively.

I want Delaware's kids to be healthy, educated, and prepared to take the reins as tomorrow's leaders. And it all starts with our commitment to them today. In passing these important bills this session, we have made great strides in making an investment in our kids' future, which is also our future.

tor, a tactical football genius, and an authority on the rules of the game, he was a man of integrity. He announced that the game would be played in Newark as originally planned

because he had promised Delaware's alumni, students and fans a home game and he intended to see that they would get it. News accounts at the time noted that it was one of the rare moments in recent football history that athletic policy had not been dictated by

television dollars.

Delaware's fans - 23,029 of them - were doubly rewarded. They not only got their home game, they witnessed a thrilling 21-3 upset victory that will long be remembered. And many of them continue to support the University to this day.

What can your backyard do for you?

If you have a backyard, no matter how small, there are ways to use that resource to help you or your

family. Many people don't realize the potential that their backyards have or they don't realize their own potential in being able to do something to help their wallet as well as the environment. Cooperative Extension is here to help.

Delaware Cooperative Extension is hosting an exhibit at this year's Delaware State Fair themed What Can

Your Backyard Do for You? to help show you what you can do! The State Fair is July 23 through August 1 at the Delaware State Fairgrounds in Harrington, DE.

We've mocked up a backyard scene with focus areas and descriptive posters to help give you some ideas. Extension personnel will be on hand to answer questions

or provide resource information on where to go to get your questions answered. We've got a vegetable garden, native ornamental plants and garden, a small flock of chickens, a composting area, a 4-H project in progress, an aquaculture tank and others — all in a 20 foot x 40 foot area! Throughout the week there will also be a variety of interactive demonstrations.

Composting is an area where many homeowners can help themselves, as well as the environment.

By composting your household wastes such as kitchen scraps (do not compost oils, fats, meats, or dairy products), paper and yard waste, you can reduce your impact on landfills by 25% or more. This can have a direct impact on your pocketbook. Another great benefit of composting is compost, the end product of your efforts. Your kitchen scraps, leaves, paper and yard debris will turn into a wonderful amendment for your soil in your garden or yard.

No matter what the size of your yard you can plant a garden. Whether it be in several containers on your back step or an elaborate row garden.

Across our state, more and more people are getting into raising backyard flocks of chickens or other poultry and fowl. Chickens can bring a lot to the table — literally speaking — in the form of meat and eggs. They are also loads of fun and provide hours of entertainment. In New Castle County there are restrictions, so be sure to know what these are and if you are able to have a flock of chickens on your property.

The Delaware Cooperative Extension State Fair Tent is going to be an interactive exhibit brimming with a lot of ideas for you and your backyard!
