The Committee to whom was referred that part of the Governor's message relating to the establishment of a Penitentiary in this State, having considered the suggestion, respectfully report: That they are fully aware of the imperfection of our system of punishment, and the importance of reform in many particulars, but for want of sufficient time in which to acquire information on the subject, your Committee are not now able to recommend any remedy for the existing evil. The erection of a Penitentiary at this time, owing to the high price of labor and building materials, would involve considerable outlay, and it would, perhaps, in the present indebted condition of the State, be imprudent to incur that expense. Your Committee have had no opportunity of observing the economy of the system in States approximating to our own in population, and it is a matter of doubt whether in so small a State as this an institution of the kind could be made self-supporting, and any proposition to remove convicts beyond the limits of this State, and place them in institutions over which our authorities have no control, is, in the opinion of your Committee, very objectionable.

The effect of Penitentiary discipline upon the moral and physical condition of prisoners has also been the subject of much discussion, and grave differences of opinion exist as to the propriety of such a mode of punishment, and great doubts are entertained by many whether such discipline usually results in the reformation of criminals. As to these questions, however, your Committee forbear an expression of opinion, as they have not had an opportunity to study the subject with that care its importance demands. In view, therefore, that proper legislative action may hereafter be had in relation to the matter, your Committee would recommend the appointment of a commission, by the joint action of the two branches of the Legislature, to thoroughly investigate the subject, and report thereon at the next meeting of the General Assembly.
