Biden talks wind power at visit to alma mater

U.S. Vice President Joe Biden returned to his alma mater to help usher in a new period of economic growth by helping Delaware to create the first offshore wind farm in the United States. With a deafening round of applause and a palpable sense of pride, they welcomed the Vice President as he walked into the room.

Holding the press conference in the University of

Delaware's Memorial Hall, UD President Patrick Harker welcomed Biden, U.S. Secretary of the Interior Ken Salazar, and a host of state, university and national dignitaries to the campus. Joining Harker, Biden and Salazar at the podium were U.S. Senator Tom Carper, U.S. Congressman Mike Castle, Delaware Governor Jack Markell and UD College of Marine Studies professor Willett Kempton. It was Kempton who led the study to show the economic and energy-related impacts of offshore wind power on Delaware. Biden acknowledged Bluewater Wind President Peter Mandelstam, Delmarva Power President Gary Stockbridge, former

Lt. Governor John Carney, and several members of the Delaware Legislature, all of whom were in attendance.

The Vice President led the discussion on how the University of Delaware and the state had begun to create the image of being "incredibly environmentally conscious" as early as the 1970s. Biden commented on the work of former Governor Russell Peterson, one of the attendees, and the work he started during his administration. The Vice President stated, "I would be remiss if I didn't again recognize Governor Peterson, who did what I probably think paved the way for us being able to sustain this state in a way that wouldn't have occurred

before with the Coastal Zone Act. It was gigantic - it was such a departure from business as usual back in 1971 ... that I think it set the stage for so much more."

Biden stressed the importance of energy independence and how it is paramount to the future success of the American economy. "This is a moment", stated Biden. "This is a moment that seldom comes in history. It's probably occurred five or six times in the history of the United States, when we reach an inflection point that is so consequential for the next generations, not because of the merit or demerit of those in power, but because of the

But instead, were shocked to find out that they were the inaugural recipients of Grammy-winning Black Eyed Peas star will.i.am's i am scholarship. The award will cover tuition, books and room and board for four years.

Beckham will be attending Cabrini

College, with Williams going to Wilmington University, Barien White attending Hampton University and Darien White heading to Virginia Tech.

"This is really a blessing for these boys. They work so hard and wanted to go to college. And now they can. I'm so happy for them," said Dave Jones, head track and field coach at Christiana.

While presenting the scholarships, will.i.am, who also was raised by a single mother, told the boys: "The only thing you have to worry about is succeeding and showing the world that the youth is the future of America and the world. The only thing I ask for you guys is to prove that single parents are the strongest people on the planet."

POLICE BLOTTER

Students face stabbing, assault charges in Newark High incident

Police blotter items are compiled by Mark Corrigan from reports from the Newark, New Castle County and Delaware State Police. For the latest updates, log on to newarkpostonline.com.

Newark Police reported that two students were injured in an incident that resulted in one person being stabbed. Police reported that around 10:30 a.m., Friday a confrontation between a male and female student, both 17, occurred in the in-school suspension room at Newark High School.

An argument between the two

led to the male student assaulting the female student-grabbing her by the throat, punching her in the face, and throwing her to the floor. A teacher intervened and pulled the male away from the female. The teacher walked the male away from the female. At that point, the female retrieved a kitchen knife from her purse and stabbed the male in the back, police report.

Both were transported by ambulance to Christiana Hospital. The female was treated for a bloody nose and contusions. She was released after treatment. The male was treated for a puncture

wound and a collapsed lung. He was admitted in good condition.

Further investigation revealed that a 50 year-old female teacher who attempted to take the knife from the female suffered minor cuts on her hand. She did not require medical attention.

The female was charged with Assault 1st Degree (against the 17 year-old male), Assault 2nd Degree (injury to the teacher), Possession of a Weapon During the Commission of a Felony, Carrying a Concealed Deadly Weapon, and Possession of a

Car thief caught in the act

Deadly Weapon in a Safe School Zone. She was committed to the New Castle County Detention Center in default of \$14,500 bond. The court also ordered her to have no contact with the victim or with Newark High School.

The male was charged with Assault 3rd Degree.

The Christina School District issued no statement on the incident. However, Interim Superintendent Freeman Williams is organizing a series of public forums on school safety. Parents will be encouraged to attend and share ideas and concerns, according to district spokesperson Wendy Lapham.

Duo holds up victim with shotgun

Last week, Dashiell Hause, 20, of Madison Drive, Newark reported that he was robbed at gunpoint while walking home from a party on East Cleveland Ave. Hause walked past the cemetery located at 300 Elkton Rd. and used the cut-through to enter a back alley on Madison Drive. While in the alley, a man ordered Hause to stop and empty his pockets. Hause described the man as a black male, 5' 8" tall, with a lean build, having "nut-ton-chop" sideburns and tattoos on his arms, wearing a white t-shirt and jeans. The suspect was brandishing a gray-colored, single-barrel shotgun. Hause also observed another person, a black female about 6' tall, that was acting as lookout, several feet away. Hause surrendered his cell phone and wallet, which contained several credit cards, his ID, \$250 in cash, and a spare house key. The suspects fled in the direction of Lincoln Drive. The case is still active.

7-11 robbed again

A 7-11 store in Ogletown has been hit for a second time in recent weeks. County Police responded to 60 S. Gerald Drive Thursday night for a report of an armed robbery that just occurred.

When police arrived, they were told by a female clerk that she had been robbed at knife point. The victim reported a black male entered the store and attempted to purchase a tobacco product. When the clerk opened the cash register, he showed a large knife and threatened to stab the victim if she did not relinquish the cash. The suspect took the cash from the register and

Assault reported at UD

A University of Delaware student reported he was assaulted shortly before 9 p.m., April 30, near the main entrance to Harter Hall.

According to University Police, the victim had secured his bicycle and was about to enter the building when he was approached by two men who first asked to use his cell phone and who then asked for 50 cents to make a telephone call. When the victim declined, one of the men struck him in the face. The victim then ran for safety to a nearby restaurant on Main Street. He was transported to the emergency room at Christiana Hospital for treatment. University Police described one suspect as being 5-feet 10-inches tall and of average build. He was wearing a white shirt and had short black hair. There was no description on the second suspect.

Car thief thwarted

On Monday, April 27, police were dispatched to Tantallon Court, Newark, where a Theft from a Vehicle was reported in progress. The report listed a white male wearing a black hoody and jeans. Police arrived on scene to discover that the suspect had fled. A short while later, another report was made at 7 High Ridge Ct. Police arrived about a minute later

to discover a white male, wearing the clothing in the report, behind the wheel of a white pickup truck. Police drew their weapons and ordered the male to exit the vehicle. The suspect, Christopher Yarnell, 31, of 6 Country Hills, Newark, was searched, where police found over \$47 in spare change, several pocketknives, a small blue flashlight and other miscellaneous small items. A canvass of other neighborhood vehicles was performed and owners reported several items had been taken from their cars. Some of the cars had been locked, while others had been unlocked. Yarnell was charged with Burglary Third Degree.

Mail scam hits Newark

Saturday, May 2, Jack Mullen of Hunt at Louviers called Newark police to alert them of a possible mail scam. Mullen had received an envelope mailed to him that contained a letter and check. The envelope was from Monster Worldwide Job Agency. It was mailed from Canada, but included a mailing address of 3365 Piedmont Rd. NE, Atlanta, GA 30305 and a phone number listed as 1-514-573-6251. A letter contained in the envelope listed Mullen as a "Secret Shopper" and directed him to deposit the enclosed check for \$3,780.00, which was filled in with Mullen's name, and to mail out a money order to Europe/Athens/Greece to Ioan Hrezdac or Ismet Vrushi. The check was from the Keybank National Association of Albany, NY 12207. An Internet search by police revealed that Keystone National has been involved in several other scams.

My huge check is in the mail

I must be one of Newark's most fortunate residents.

At a time of financial distress for so many of my friends and neighbors, I am about to become a wealthy man! This change in my financial status is the result of a series of e-mails that arrived in the last several weeks.

The first of these messages appeared on my computer screen on January 16 and brought the welcome news that I had been chosen to receive a cash prize of 300,000 British pounds and a new car as a winner in the London Peugeot Automobile Lottery.

Three days later, more exciting news appeared. One message reported that I would soon receive a parcel containing a check for 535,000 pounds from Mrs. Brenda Howell whose West African foundation assists underprivileged persons throughout the world. My name had been chosen in a promotion utilizing a random selection of e-mail users.

Imagine my surprise and delight when a second message arrived on the same day from Mrs. Maria Elena Fernandez seeking my assistance in distributing funds from her late husband's estate. These funds, totaling \$7,300,000, were being held in a security company trunk box in Abidjan, West Africa. Mrs. Fernandez' physician has informed her that she is dying of cancer and, therefore, she needs someone who will see that her funds are distributed in accordance with her wishes. She has turned to me because she has no children and fears that her late

husband's non-Christian relatives will not follow her instructions.

Just two days later, the promotion board of Chevron/Texaco Oil and Gas Company of Abuja, Nigeria, notified me that I am one of four "lucky winners" who has been approved for a payment of 3,000,000 pounds in a company promotion marking Chevron's anniversary and encouraging worldwide Internet use. My name had been selected in an e-mail drawing encompassing sources in Europe, Asia, Australia, New Zealand, the Middle East, parts of Africa and North and South America.

Scarcely had I absorbed this good news when Mr. Vincent Cheng Hoi Chuen, chairman of the Hong Kong and Shanghai Banking Corporation, requested my participation in a complex plan to divide the multi-million dollar estate of a high-ranking Iraqi Army officer and businessman. He and his son had been assassinated and no heirs had

been located.

The most recent of these good tidings arrived several days ago. Mr. Norbert Coleman, a member of the Independent Committee of Eminent Persons in Switzerland, reported his desire to share with me \$35 million currently held by the Holocaust Claims Processing Office of that country. Exxon owner: Incorrect report hurt business

The owner of an Exxon in Newark says her business has been hurt by an incorrect report that the station's gasoline was contaminated with water.

Anne Ruohonen said business slowed at the station at 820 College Avenue, following publication of a story in the News Journal linking motorists' problems to the gas station. She asked the media to get the word out that the station was incorrectly listed.

Also quoted was a gasoline

distributor who confirmed the problems.

The gas was traced to the Valero refinery in Delaware City, which is looking into the matter.

The story was also distributed on the Associated Press.

Ruohonen said her gas stations (she also owns a Sunoco on Elkton Road) do not use the wholesaler mentioned in the story. She further claimed that the odds of contamination are

very small, thanks to equipment and steps delivery drivers take in checking for water.

She said she demanded a correction from the News Journal and was assured that would occur. However, she said she wanted the correction to have additional prominence. The story appeared on page three in the local section of the News Journal.

As of Tuesday afternoon, all references to the Newark station had been removed from the online version of the News Journal story and a correction with a larger headline was printed the following day.

The location of the station tied to the complaints was listed as being in the Boyds Corner area north of Middletown. A second-day story on the situation in the News Journal also noted in a headline above the story that the Newark station was not affected.

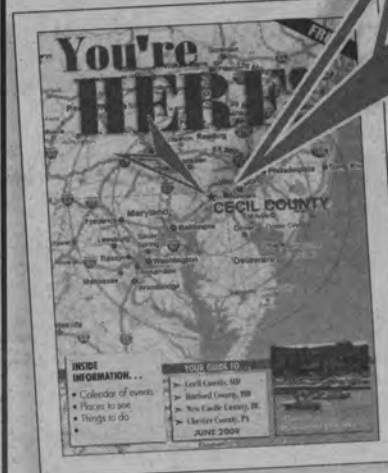

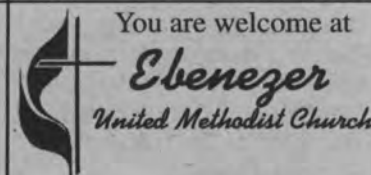
