### Representative's Certificate

*Manitow* Tribe, No. *18*

To the Great Council of Delaware:

This is to Certify, That Past Sachem *James F. Wright* has been duly elected the Representative of this Tribe to serve from the 30th sun of Corn moon, G. S. D. 4 *13*, until the 30th sun of Corn moon, G. S. D. 4 *14*, and as such Representative is entitled to the mileage and per diem.

In Witness Whereof, we have hereunto subscribed our names and affixed the Seal of our Tribe, at *Wilmington* this *30* Sun of *Corn* moon, G. S. D. 4 *13*

RESOLVED, That this Great Council recommend that the Tribes elect by ballot at the election for chiefs in Corn moon, the Representative who shall be entitled to the mileage and per diem as provided by the Great Council, and a certificate under seal of the Tribe shall be required before the said mileage and per diem is paid. PROVIDED, however, that the said Representative shall be required to attend all sessions of the Great Council to be entitled to said mileage and per diem.

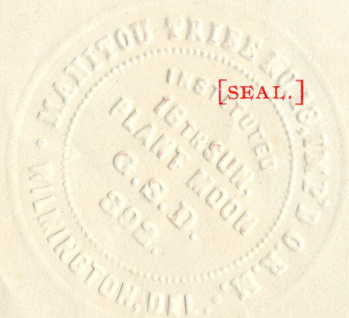
