509 Your telegram 245 consider first sentence very good stop since seeing you Brussels developments rate situation in Mexico I now learn are such that we must be more cautious than ever in references to proposed new rates stop While I am confident we will get adequate rates needed we are experiencing some further delay Mexico and we must avoid any statements which may make securing rates more difficult or impossible stop Suggest changing second and third sentence to read quote As against extreme state intervention we have increasing examples of some Latin American government collaborating with and coordinating their programs with private enterprise unquote While I believe what you planned to say is correct publicity given such a statement at this time could do us a great deal of harm and
