## DSD hosts open house of new school

As part of their Spirit Day celebration, the Delaware School for the Deaf (DSD) hosted a Homecoming Brunch and Open House on Friday, Feb. 4. Honored guests included Dr. Marcia Lyles, superintendent of the Christina School

District; Dr. Freeman Williams, former interim superintendent; and Ed Osienski, State Representative for the 24th district.

The event featured a pep rally for the students and a tour of the new Delaware School for the Deaf for guests and dignitaries.

The new facility will encompass over 111,000 square feet, with an additional 18,000 square feet of dormitory and living space in a separate build-

ing. The project has been under the supervision of Whiting Turner and will open next to the present school, located at 620 E. Chestnut Hill Rd, Newark (Route 4).

Classrooms in the new school will be equipped with state-of-the-art Smart Boards, wall mounted electronic message boards, tri-colored signaling

## Man dies in blaze on Welch Tract Rd.

One person was killed in a fire Friday morning, near Newark. It was Delaware's first fire fatality of the year.

The Delaware State Fire Marshal's Major Incident Response Team along with the Office of the State Medical Examiner continue to investigate the fire reported by neighbors shortly after 6:00 a.m. in 300 block of Welch Tract Road.

Aetna Hose Hook and Ladder Fire Company of Newark responded along with several neighboring fire companies to the blaze.

Units arrived on scene with heavy fire coming from the two story single family dwelling. During fire suppression operations, a victim was located on the second floor. The fire was brought under control within 45 minutes. The structure received heavy fire damage.

There were no other injuries reported.

Damage was estimated at \$50,000.

Identification of the victim will be made by the Medical Examiner's Office.

Cause of the fire has not been determined.

## POLICE BLOTTER

**UD student accused of striking officer**

A 20-year-old University of Delaware student is facing charges of striking a Newark Police officer during an investigation late Saturday night.

She was identified as Abigail Fashouer, of the 100 block of East Park Place.

Police were called to her residence for a report of a party that was getting out of hand. The resident of the home expressed gratitude for the

arrival of officers and requested assistance in clearing the house of approximately 100 persons.

After clearing the residence, a second resident of the home, Abigail Fashouer, refused to provide identification to the officers and fled through the home. She was quickly apprehended and handcuffed. After being handcuffed and while being escorted to the officer's vehicle, police said she became belligerent, and started yelling obscenities.

She then attempted to pull away and struck the officer in the jaw with her elbow. The officer was uninjured. The defendant was processed at Newark Police headquarters and later released pending her appearance in Alderman Court #40. She faces numerous charges.

**Law firm site of break-in**

Over the weekend, police investigated a burglary alarm set off at Dingle and Kane, a law firm at 356 E. Main St. Partner Fred Dingle told offi-

cers that an unknown suspect had used a large rock to break a front door window. The suspect entered the office area and may have removed a laptop computer from a docking station near one of the desks, depending on whether a staff member had taken it home or not. The laptop is valued at \$500.

Officers searched the area and saw that the only disturbed area was where the computer had been docked. Other computer peripherals were strewn about and a phone had been knocked off its cradle. Police removed the rock and shards of glass from the front porch as evidence. A dusting for fingerprints showed no results and no witnesses were found. Authorities are attempting to recover video footage from other businesses in the area. No suspects have been named yet.

**Juvenile robbed outside Wilson Center**

Newark Police are investigating an armed robbery of a juvenile leaving a party.

The robbery occurred in the parking lot of the George Wilson Center, 303 New London Road at 10:25 p.m., Saturday night. The victim had just left a large private party at the center and was in the parking lot when a large fight broke out.

The victim and several others ran from the fight but returned to search for a friend. While walking back through the lot, the victim was approached by a

suspect who displayed a black semi-automatic handgun.

Approximately 10-20 additional persons then surrounded the victim. The suspect then removed the victim's cell phone from his jacket pocket and fled on foot southbound on New London Road towards Main Street.

The suspect is described as a black male, approximately 16-17 years old, 5'6" to 5'8", 130-150 lbs., with a thin build. He was wearing a black jacket and a black ski mask. The victim, 16, was not injured.

Dana Johnston, community affairs officer for the City of Newark, said the city Parks & Recreation Department keeps an attendant at the center during parties and other events. However, security arrangements are not required. An interview of the employee by Parks Director Charlie Emerson was being conducted on Monday.

**Pair rolls TV out of business**

Two white males are wanted in connection with a shoplifting incident where they stole a

television from K-Mart, located at 301 College Square, Newark.

A clerk in the electronics department said that she had observed two males pushing a red shopping cart into the area and placing a 32" Samsung LCD television into it. The suspects rolled the cart out of the department, but were stopped by the clerk who stated that the television had to be paid for there. The males ran with the cart, out of the store, and in an unknown direction. A loss prevention officer was notified, but could not determine where the suspects had fled.

Newark Police have received a video surveillance tape from the store and are reviewing it to get a better description of the suspects and to release a photo at a later date.

**Caffe Gelato missing sign**

Last Friday morning, Ryan German, owner of Caffe Gelato, told police that an unknown person had taken a 2 foot by 3 foot free standing sign that is used for advertisements and restaurant events. The sign is sits outside of the business on the sidewalk and is valued at \$400. Police are on the lookout for the sign.

**Diesel thieves strike again**

An employee with American Van Lines, at Interchange Blvd. in the Interchange Industrial Park, told Newark Police that someone had broken into the yard and siphoned 150 gallons

of diesel fuel from two trucks parked at the site. At present prices, the fuel is valued at over \$510. The business has been the victim of fuel thefts in the past.

Officers were told that a high-speed siphoning device is available on the market, and may have been the means of removing the fuel.

No signs of tampering were apparent and outside conditions yielded little physical evidence. A search for video footage is ongoing. The business was told by authorities to upgrade their security surveillance system and to invest in locking gas caps for the vehicles to prevent further incidents.

**Tools taken in vehicles break-in**

Boulden Heating and Plumbing, in the Interchange Industrial Park, reported the theft of over \$5,000 worth of tools and equipment from two vehicles secured at their lot.

The theft was reported on January 31 and involved an HVAC repair truck and a plumbing truck.

Locks securing the rear compartments of the vehicles were found nearby, showing that they had been cut with a bolt cutter or similar device. The suspects took their pick of the tools, leaving other valuable pieces, behind.

Police are still reviewing fingerprints evidence from the scene. A large number of footprints were seen next to the trucks, but employees with

**2 held on robbery charges**

Pennsylvania State Police have taken into custody a man and a woman suspected of robbing and injuring a 77 year-old Newark woman at the Shop Rite store at First State Plaza, Stanton.

The suspects are identified as:

Detectives were contacted by the Pennsylvania State Police on Friday, February 4, 2011 after they had taken both John and Deborah Reilly into custody in Media, PA. The Pennsylvania State Police had been investigating the Reillys for similar crimes that had been occurring in their jurisdiction.

During a search of the suspect's vehicle, a tan Chrysler Town and Country mini van, numerous purses and identifications were located. A subsequent interview of the Reillys by Delaware detectives led to the issuance of warrants against them for the above listed crimes. Deborah and John Reilly are currently being held in the Delaware County Prison and will be arrested by Delaware detectives upon their

extradition back to Delaware.

In addition to the strong arm robbery which had occurred at the Shop Rite, detectives linked the Reillys to the theft of a purse belonging to a 41 year old Hockessin, DE woman which had occurred in the parking lot of the Lantana Square Shopping Center on Friday, December 31, 2010.

While the Reillys share the same last name, State Police said the nature of their relationship has not been determined.

**UD robbery suspect sought**

University of Delaware Police are seeking assistance in identifying the man who is a person of interest in connection with a strong arm robbery of a student that occurred shortly after 5 p.m., Friday, Feb. 4, in the vicinity of the tennis courts on Academy Street.

The man was wearing a dark varsity jacket with yellow/orange sleeves and was observed on video leaving the Morris Library around 5 p.m.

**Truck, chain no match for ATM**

Newark Police have released photos of a vehicle tied to a failed attempt to pry loose an automatic teller machine from the outside of a bank branch.

Police were called to the Wachovia Bank located at 622 South College Avenue at 7:30 a.m. for the report of an attempted theft. Officers received information from a witness who saw the suspect standing at the ATM machine on the south side of the building. Initially, the witness

believed the person was working on the machine; however, the witness then observed a chain attached to the rear of a pickup truck. Camera footage of the vehicle is available on [Newarkpostonline.com](http://Newarkpostonline.com)

The suspect then entered the pickup truck, but failed to pull the ATM from its base, causing the chain to snap. The suspect then exited the truck, picked up the chain and fled the parking lot onto southbound South College Avenue and then westbound onto Christina Parkway (Route 4).

The witness attempted to follow the suspect vehicle to obtain the license plate. However, the plate was covered with fabric. The vehicle was last seen turning left from Christina Parkway onto southbound Elkton Road.

The suspect is described as a black male, approximately 25-27, 5'9"-5'10", average

build, wearing a waist-length dark colored jacket.

The suspect vehicle is described as a bluish/gray GMC or Chevy 2500 extended cab pickup truck with a ladder rack.


James, their son and his grandson, Ryan.

And don't forget how important it is for boys to see girls play. Imagine the look on your son's face when he sees Elena Delle Donne shoot a 3-pointer. It's important to teach boys about girls playing sports at an early age to eliminate stereotyping in the future. This is especially important if there are no female siblings playing youth sports.

Winter is more than half over — I know, thank goodness — so hurry up and take advantage of the opportunity to go cheer on a local team. Not only will the local players love to see the bleachers full, it will get you and your kids out of the house to a warm place as the snow continues to melt.





## OUT OF THE ATTIC

This week's Out of the Attic item is a photograph of the McDonald's Restaurant as it was when it opened on March 15, 1960 at 374 East Main Street on the traffic circle.

Owned and operated by Leonard Dukart under the franchise name Dukart Management Company, this was the first McDonald's in Delaware. The menu included Hamburgers for 15 cents, French Fries for 10 cents, Soda for 10 cents, and Milkshakes for 20 cents. The first mascot "Speedy" was replaced by the now world famous clown Ronald McDonald in 1963. As business and the menu grew the store was expanded.

Breakfast started in 1972 with the Egg McMuffin added in 1975. Disaster struck December 1, 1976 with a 9:30 a.m. explosion that caused Major Loss, according to the fire report.

With the rebuilding, the Drive-Thru was added and opened on June 11, 1977, the third on the East Coast. Happy Meals started in 1979. Dukart Management has opened additional locations starting with South College Avenue and is now led by the next family generation - Les, Alan, Mike, and Joel. lights, and an integrated Wi-Fi system that allows students with hearing devices or cochlear implants to receive audio signals in class. The classrooms are also designed with features unique to the school, including sound dampening panels and double-paned acoustic glass windows to reduce echo vibrations and outside ambient noise.

A 340-person auditorium, a courtyard, an updated cafeteria, and improved testing facilities are also included in the new school. A separate dormitory building will house 32 students in 16 rooms on two floors and will host a common room, computer resources, laundry options,

and play areas.

Four apartments, as part of the new living quarters, and a Family Resource Center will allow the families of tested students to stay at the school and reduce the number of home visits by staff. It will also expand the reach of the DSD beyond New Castle County to act as a regional hub for deaf and hard-of-hearing students.

Representatives with Whiting Turner said that construction will be completed in late March with furniture scheduled to be placed in April.
