We have taken due note of the information which you have sent us so far as sending telegrams to Amitas or to you during weekends is concerned.

Mr. Lorié asked me in a letter sometime ago at what station we would arrive and I told him that it should be the Pennsylvania Station unless I informed him to the contrary.
