# THE SECOND BIENNIAL REPORT OF THE DIVISION OF RECORDS OF DELAWARE.

Honorable Preston Lea:

Sir:

The Division of Records, as reappointed by you in April, 1907, respectfully submits the following report.

At a meeting held June 24, 1907, a set of by-laws governing the work of the division, was adopted. The following officers were elected:

President-Henry C. Conrad.

First Vice-President-Julia Ford Burton.

Second Vice-President-George W. Marshall.

Secretary—Josephine Tatnall Smith.

Treasurer-Mabel Lloyd Ridgely.

Auditor-Thomas Robinson.

In January, 1908, a circular letter was issued, asking the co-operation of interested people in the work of rescuing from total loss old paper, ancient manuscripts, books, etc., now lying in confusion and disorder in out of the way places. This, together with personal researches by your Division of Records, met with encouraging results, much information being received of the whereabouts of important and valuable State, judicial and genealogical papers, which, doubtless, will come under the care of the Records Division, at such time as the State shall be furnished with a fire and burglar proof apartment for their safe keeping.

The appropriation of Five Hundred Dollars (\$500.00) annually for two years, given by legislative enactment in

1907, while greatly aiding the work of the Division in enabling its members to obtain a better understanding of existing conditions, has not been sufficient to allow of any great accomplishment. The work in New Castle County has been confined to the office of the Register of Wills, in the Court House at Wilmington.

A new will book has been prepared, in which has been transcribed three hundred and forty seven (347) ancient wills, the former records of which are missing. All the original wills, prior to the year 1800, have been arranged, both chronologically and alphabetically, and an index made of the same. A letter is enclosed from Mr. Francis M. Walker, Register of Wills, expressing his appreciation of the work done in his office, and its value.

In Kent County, lists have been made of manuscripts and loose papers found in the State and County buildings prior to 1800, a detailed report of which is annexed.

Investigation in the Court House at Georgetown showed the early records in need of immediate care, to prevent annihilation. The Division has an agent at work there, now also one in Dover.

Closets, desks, shelves, boxes cellars, and lofts in the public offices of the State are being searched successfully, the contents sorted and catalogued. Many valuable papers have been rescued giving material from which the Division aims to prepare for publication a series of Delaware Arch-One volume of Military and Naval service of Delaware men, in Colonial and Revolutionary wars, is already Other volumes will be prepared as in the printer's hands. rapidly as possible, provided the State Assembly allows a suitable approriation of funds. Heretofore, Delaware has had no printed archives of her own; her history being absorbed in that of the neighboring colonies. Your Division of Public Records now aims to extract Delaware records from New York, Pennsylvania and Maryland archives and give our State its rightful place in Colonial history. preparation of such a work means unlimited personal service by the Division, as you understand, without remuneration, and the employment of agents and clerks, as well.

The Division very much wants your interest in its work, and trusts you will recommend to the next Assembly an increase to Three Thousand Dollars (\$3,000.00) in the next appropriation.

Dear Madam:-

I beg leave to report to the Division of Records, through you, the work done by Miss Charlotte S. Wier, and to assure you of our appreciation of the same. As you know Volumes D, E and F and parts of Volumes H and I, embracing a period of years from 1721 to 1747 and from 1751 to 1772, respectively, are missing from this office, and a large number of the original wills, as shown on the index, are also missing. The work of your agent consisted of arranging all wills prior to 1800, both chronologically and alphabetically, and of recording all of the wills which are on file, and the records of which are missing. We would state that the work of recording these old wills, owing to their condition, some badly torn and the writing on many being almost illegible, was very tedious and required much care and patience. The index of this office shows that prior to the year 1800 there should have been 1610 wills on file, but examination of our files discloses the fact that 423 wills are missing, only 1187 being here. We found 347 wills among our files, the records of which are missing, and which were recorded by Miss Wier, so that now all wills on file in this office are of record, and parties making a search can examine the record instead of handling the old papers as they did heretofore, and which afforded an opportunity to unprincipled persons to carry away the same.

Your clerk also made an index of all wills, prior to the year 1800, now on file.

We wish to extend our hearty thanks to the Division of Records for having this work done. Our Will Records now being as complete as it is possibe to make them under existing conditions. It gives us great pleasure to state that the work of your clerk in this office was done in a conscientious and intelligent manner and was entirely satisfactory.

To His Excellency, Preston Lea, Governor of Delaware.

Pursuant to the Act of Congress establishing Agricultural Experiment Stations, I submit herewith a report of this department of Delaware College for the fiscal year ending June 30, 1908.

In general, it may be said that the year has been one of progress. Much time and effort have been spent in preparing the foundations for the future work of the Station. This has taken of the means and energy that in later years will be spent in research and demonstration. While it is unfortunate that the time necessary for these preliminaries has come when so much is expected of the Experiment Station, it is to be hoped that its constituents will be patient and not feel that it is unworthy of the support that has been so loyally given it. The Station is eager to fulfil its utmost obligation to the State in an acceptable manner, and, if possible, to do even more than this.

#### Administration.

It is to be expected that when any Institution is reorganized there will be a number of changes in its personnel. The changes in the working staff of the Station have been as follows:

During the year, Prof. Charles L. Penny, Chemist to the Station since the beginning, resigned to accept the Chair of Agricultural Chemistry at the Pennsylvania State College. He was succeeded July 1st, 1908, by Firman Thompson, B. S., a graduate of the University of Michigan. Since graduation, Prof. Thompson has been engaged in Experiment Station work, and comes eminently fitted to render most efficient service.

Dr. Margaret B. MacDonald, Assistant Chemist resigned to accept a similar position at Pennsylvania State College.

At the close of the year Mr. S. H. Jackson, Assistant Mycologist, severed his connection with the Station.

The vacancies caused by the resignation of Dr. Mac-Donald and the leaving of Mr. Jackson have not as yet been filled.

## The Mailing List.

The Mailing list is being constantly revised, and now carries 8555 names. This is an increase of about 24 per

cent since 1906. Except under unusual circumstances new additions are made only by request. If any residents of the State desire to receive the Bulletins as they are issued, they may do so by sending their name and address to the Agricultural Experiment Station, Newark, Del. The name is then added to the mailing list of those who receive publications as they are issued.

At present, less than one-half the farmers in the State receive the Station publications. This is a matter of regret. The progressive farmer cannot afford to be uninformed in regard to experiments that are being made in his avocation. Even if he does not agree with conclusions reached, the very fact that the matter has been brought to his attention and has caused him to think of the questions under discussion, will have the tendency to make him a better farmer. I would urge, then, that the farmers of Delaware have their names put on the Station's mailing list, keep informed as to what is being done, and co-operate by offering suggestions for the welfare of Agriculture of the State.

The State is so small that it is possible for its farmers to come into closer personal relation with the various members of the Station staff than is practicable in the larger states, and I take this opportunity to extend a most cordial invitation to the people of Delaware to become thoroughly familiar with the investigations of the Experiment Station, and to co-operate in improving her agricultural conditions.

The Purpose of the Experiment Stations.

The purpose of the Experiment Stations is defined in a comprehensive manner in the Act of Congress establishing them. "That in order to aid in acquiring and diffusing among the people of the United States useful and practical information on subjects connected with Agriculture, and to promote scientific investigations and experiments respecting Agriculture, there shall be established, etc." This gives the Station, so far as the Hatch fund is concerned, wide scope in its activities. However, there is a marked tendency on the part of the Office of Experiment Stations, which administers all Station funds, to hold members of the staff in Experiment Stations to research work, and to depend upon the State governments to provide for Agricultural Extension workers in the various phases of this work.

In this State, however, conditions differ from those in most other commonwealths. Delaware is so small that part of the duties of the Experiment Station can be performed in the most satisfactory way by personal contact with the farmer; either at Farmers' Institutes, Grange Meetings, or Farm Meetings. As yet the demand for this intimate relationship between the farmer and the Station is limited, but it is hoped that it will rapidly increase as it would be a most positive indication of the mutual interdependence that should exist between the Station and its constituents. Specifically, then, the Station offers its services to Delaware farmers along the following lines:

- 1. Outling policies in farm management.
- 2. The selection and use of natural and artificial fertilizers.
  - 3. Identification of weeds and other plants.
  - 4. Examination of seeds for adulteration and vitality.
- 5. Suggestions in orchard and garden management, including pruning, fertilizing, spraying, etc.
- 6. The identification of and remedies for noxious insects.
- 7. The examination of feeds, with suggestions in regard to their compounding and use.
- 8. Suggestions in regard to the care and management of wood lots.
- 9. The identification of plant diseases, with suggestions in regard to remedies.
- 10. Suggestions in regard to the management of contagious animal diseases.

#### Publications.

During the year the 16th, 17th and 18th Annual Reports were published, clearing up all unpublished matter and bringing these reports up to date.

There were issued also, Bulletins 79, 80 and 81. Fur-

ther publications were witheld, owing to the many other demands upon the Station's funds.

Bulletin 79, by Prof. Penny, describes in detail the method of making home-made miscible oils. The question of spraying is such a vital one in the State that the information furnished by this Bulletin has had an unusual demand.

In the home-made miscible oils the formula for which has been so successfully worked out by Prof. Penny, he has found it possible to add copper in the form of copper sulfate. While the effect of this combination of oil and copper as a fungicide has not been demonstrated experimentally, it is hoped that it will prove as efficient in this respect as it has as an insecticide. The particular advantage of the "Penny oil" is that it is easily made, is efficient as a scalecide, is easily applied and is cheap.

In the orchard tests made by Prof. Houghton, and described in this bulletin, it has been found that heavy oil emulsions such as the Penny oils, are more efficient in destroying the San Jose scale than the Kerosene emulsions. It is not recommended, however, that the Penny oil be used in a weaker solution than 10 per cent.

Bulletin 80 is the Annual Report of the Director for the year ending June 30, 1907.

Bulletin 81 is the Report of the Agronomist for the season of 1907. While the report is a record of but one season's work, it brings out clearly a few facts that are of the greatest interest to farmers. During the year, fifty varieties of corn were tested, and although the season was very unfavorable, the results of the test are interesting. The yields based on a 100 per cent stand varied from 5.7 bushels per acre to 18.5 bushels, a variation of over 400 per cent.

In an ear row test, 24 ears of native yellow white-capped corn was selected and 100 hills from each ear planted, in as many rows. At the end of the season, the crop from each 100 hills was harvested and weighed separately. Basing the yields upon a 100 per cent stand, the highest yielding ear produced at the rate of 71.7 bushels per acre, while the poorest ear gave only 25.7 bushels. This indicates that

in Delaware, where corn is the leading crop, it is of the utmost importance, in order to secure maximum yields, to know the breeding value of the seed that is to be planted.

This report also gives an indication of the great value of Soy Beans, a crop that is but little grown in this State. There are many varieties, some of which are and some are not adapted to Delaware conditions. Of the varieties tested during the season of 1907, four yielded more than five tons of hay per acre, and four others produced at the rate of more than 25 bushels of seed per acre. When it is realized that soy bean hay compares favorably with alfalfa hay in feeding value, and that the grain is nearly equal to cotton seed meal in its content of digestible protein, the promise of the plant can be readily appreciated. Another striking feature in this report is the results obtained in top dressing timothy. The results of this test indicate that it is profitable to apply as much as 160 pounds of nitrate of soda on timothy in the spring as soon as the plants begin to grow. This is usually accompanied with ground bone or acid phosphate and a little muriate of potash in the proportion of 2 of nitrate of soda, 2 acid phosphate and 1 of muriate of potash.

## The College Farm.

A large part of the energies of the Director, the Horticulturist and Agronomist have been spent in putting the farm in condition for satisfactory work in the future. To this end a number of fences that were dilapidated and not needed have been removed, some of the wet spots drained, orchards planted, and so far as possible, live stock purchased to consume a part of the roughage that is of necessity grown on the farm.

A close acquaintance with the farm shows it to be well adapted to the purpose for which it was intended. When the equipment has been completed there will be few Experiment Stations that have a better farm for their work. The wisdom of the commission of the Legislature has been clearly demonstrated by their choice of a farm for the use of the College and Experiment Station.

## Farmers' Day.

One of the most pleasant days of the year was the fif-

teenth of June. This was the day set apart by the Experiment Station as Farmers' Day. About 3,000 invitations were sent out to the farmers in the State asking them to spend the day at Newark, and study at first hand the work of the Experiment Station. About 400 accepted the invitation, and were much interested in the work that was being conducted on the farm. Prof. W. J. Spillman, of the U. S. Department of Agriculture, gave an address on Farm Management, which was well received. Short addresses were also made by prominent farmers of this and other States. So successful was the day that arrangements are being made to make it an annual event.

## Needs of the Experiment Station.

There are a number of things that, if they could be had, would greatly facilitate the work of the Station. A small appropriation for conducting co-operative experiments would be much appreciated. Such an appropriation would enable the members of the Station staff to come into even closer contact with the farmers in all parts of the State than is now possible. A systematic series of co-operative experiments would demonstrate the various methods of soil treatment practicable on different types of soil and in this way be of distinct value to sections where such co-operative or demonstrative experiments could be carried on.

In a number of States the county farms in whole, or in part, have been placed at the disposal of the Experiment Station for demonstrations and co-operative experiments, with satisfactory results.

Two more tenant houses for the help of the farm are much needed.

Without doubt, however, the greatest need of the Experiment Station is a barn, and in order to present somewhat in detail the reason for this statement, the following is presented:

Functions of a Barn on the College Farm.

The funcions of a college barn are many. In the first place, it should be a building in which the work of an Experiment Station, as far as it pertains to the farm, can be

carried on with the least possibility of error. To this end, there should be suitable provision for storing a large number of different kinds of seeds and forage with the assurance that they will not be mixed, and that they will not be in danger of injury from mould or decay.

A College barn should be a model of neatness and convenience in arrangement, in which the maximum amount of work can be done with the minimum amount of labor; a building in which the most modern labor saving devices may be demonstrated for the benefit of students and visitors. Further, a College barn should be of such proportions and arrangements that the College may demonstrate the most approved methods of agricultural practice and enable the farm to be worked with maximum results with reference to crops harvested and fertility maintained, or if possible, increased.

Again, it is desirable, if not essential, that on a farm as large as that which the State has so generously given us, a large amount of stock should be kept, not only to consume the roughage grown, and for the value of fertilizer produced, but, primarily, to provide the animals for the large amount of investigating that needs to be done in the important field of Animal Husbandry.

In view of the agitation that is now current, it would be impossible to house any number of animals in stables such as we now have at our disposal, and maintain our position before practical farmers or a consuming public. Present knowledge demands that farm animals be houseed in comfortable, light, airy, well ventilated and otherwise sanitary buildings.

#### The Present Barn.

I believe that any man who is thoroughly conversant with the conditions of successful agriculture today, would condemn the present College farm barn because it is:

- 1. Much too small for present needs.
- 2. Poorly adapted to College and Station work.
- 3. Unsanitary (and it cannot be made sanitary.)

- 4. Badly out of repair.
- 5. Badly located, being on low ground.

It would be very expensive to remodel and repair it and for the reasons given above it could never be made sanitary.

## A Legal Aspect.

The act appropriating money for the purchase and equipment of a State farm for the use of Delaware College and Experiment Station expressly states that the farm is for educational and experimental purposes. The College, therefore, should use its every endeavor to conform to the spirit as well as the letter of this generous act. It is evident, however, that it is impossible on the part of the Trustees to carry out the intent of the act until a suitable barn is provided and the farm properly equipped.

Federal Rulings in Reference to College Farms.

The office of Experiment Stations has ruled very definitely in reference to College farms. This office insists that a farm conducted with the Experiment Station funds, as the Delaware farm is, must use the farm for definitely planned experiments, and that ordinary farm operations do not constitute such investigations.

The question of how the College farm is conducted has already been raised by Federal authorities, and if the query could not have been answered by the statement that experiments had been planned which would utilize the whole farm, and that we were only waiting for a suitable barn, our position would have been an embarrassing one, to say the least. While it is understood that Morill funds may be used to carry on a farm for educational purposes, Experiment Station funds must be devoted to research.

It is true, perhaps, that the farm sales have been large enough to bear the expense of carrying on that portion of the farm not as yet devoted strictly to experimental work; yet it must be conceded for obvious reasons, that neither Delaware College nor the State should undertake commercial farming.

### Cost of a New Barn.

The chief objection to a new and suitable barn is the one of expense. This objection may be considered from two points of view. First: Is the College and Experiment Station a benefit to the State, and is it worthy of State aid and support? The College and Experiment Station has been in existence long enough now to enable the taxpayer to answer this question.

Granted that it is to the advantage of the State to have a suitable barn for the work of the College and Experiment Station, the question arises, how much can the State afford to spend for the purpose? This in turn is answered by the value of the benefit that may accrue from having the Experiment farm properly equipped.

The sales of products from Delaware farms amount annually to about \$7,000,000. If, however, to be on the safe side, it is assumed that farm sales have averaged but \$5,000,000 for the past twenty years, or since the beginning of the Experiment Station, we have the grand total of One Hundred Million Dollars that has been received by the farmers of the State in two decades. Is it too much to say that the work of the Experiment Station has been worth at least one-fourth of a mill for each dollar our farms have produced? This is a conservatie estimate in view of the fact that the value of the farm products of the whole country has increased nearly 30 per cent during the past nine years.

Outside of the farm appropriation, which is shared by the College and Experiment Station, the State has never been asked to contribute anything to the support of the Experiment Station. Just now, in order to carry on its work in a manner acceptable to most farmers, it needs a barn. The cost of building it, if it is ever built, must be met by a State appropriation. The need of a barn will be greater two years hence than it is now and in all probability the State is as able to build it now as it will be two years from now.

"The wealth of Delaware is in her soil, and her strength lies in its intelligent development." Again, "To

devote public money to charities is philanthropy: to devote it to the development of productive industries is statesmanship."

## REPORT OF PUBLIC LANDS COMMISSION.

To the Honorable Preston Lea, Governor of the State of Delaware:

The Commission appointed by the last General Assembly, under the Act "Approved March 29, 1907, providing for the survey of certain public lands of the State" near the Atlantic Ocean, beg leave to report:

That in pursuance to their appointment, the Commission met at Dover, April 4, 1907. Present, Messrs. Ebe W. Tunnell and M. Hayes. A certified copy of the Act was obtained from the Secretary of State and submitted to the State Treasurer who thought it advisable to obtain the opinion of the Attorney-General as to his legal right to pay the bills necessarily incurred by the commission in prosecuting the work at the expense of the State, if the same should exceed the amount definitely appropriated by the Act.

August 22, 1907.—The Commission met at Rehoboth. Present, Messrs. Tunnell and Hayes. A letter to State Treasurer Rawlins from Attorney-General Richards was submitted, stating that in his opinion "the amount which can be expended, in any manner, under the bill is limited to the amount of One Hundred and Fifty Dollars (\$150) as this was the only amount contained in the General Appropriation Bill, applicable to the expenses incident to the survey." The Commission had an interview with Mr. John Hopkins, a skilful surveyor, and concluded to authorize him to make a preliminary survey of the public lands from the Life Saving Station at the head of Rehoboth Bay, southward on the coast to Indian River, distance of about five miles.

January, 1908.—The Commission met. Messrs. Tunnell, Parker and Hayes present. Mr. Hopkins submitted a sketch of the preliminary survey of the lands between the Sea Coast and Rehoboth Bay claimed by the State.

Included in the limits of this survey are lands claimed by persons, who cannot, in the opinion of the Commission, show a sufficient and proper title to the same and also others who have not completed their title to portions claimed by them. For instance:

A careful investigation made by the Commission respecting the parcel of land designated on the plot accompanying this report as "Fifty acres claimed by R. R. Co," discloses the status thereof to be as follows:

"By Section 2 of an Act passed January 31st, 1871, amending the Act incorporating the Junction and Breakwater R. R. Co., that company was authorized to "survey, locate and construct a branch railroad from any point on its then existing railroad at or near Lewes to any point on the Rehoboth Bay at or near Rehoboth City in Sussex County, and by an Act passed March 22nd, 1877, further supplementing the Act incorporating the said Railroad Company it was provided that as soon as the Junction and Breakwater Railroad Company shall have surveyed, located and constructed a branch railroad from any point in its then existing railroad at or near Lewes to any point on the Rehoboth Bay at or near Rehoboth City, in Sussex County, it shall be lawful for said Company to enter upon and occupy a portion of the land lying between Rehoboth Bay and the Atlantic Ocean, the property whereof is in this State, not exceeding fifty acres of area, and to hold, use, occupy and enjoy the same. Subsequent to the passage of this last mentioned Act, the Railroad Company undertook the location and construction of the said branch railroad extending from a point on its line near Lewes in the direction of Rehoboth Bay, and completed, and has since operated, the same to a point in Rehoboth City, approximately distant one and one-half miles from Rehoboth Bay.

It is asserted by the Railroad Company that the location and construction by it of said branch railroad as now

existing was measurably induced by and constitutes partial performance of the condition prescribed by the said Act of March 22nd, 1877; and that by reason of the location and construction of the same to the extent aforesaid, it has already acquired, and become possessed of, an inchoate equity in the said parcel of land, which, although not entitling it to obtain complete title to, or to occupy and use the same, unless and until it shall have extended its said branch railroad to a point on Rehoboth Bay, nevertheless will entitle it to do so when the said branch shall have been extended to that point and that its right in this behalf is a continuing one.

The claim and contention thus made by the railroad company appears to the commission, under the above mentioned circumstances, and conditions to have a reasonably substantial basis and should, in the opinion of the Commission, be recognized accordingly.

In consequence of this, the Commission could not see its way clear to proceed with this work without first having an examination of titles of the various claimants and to do this would necessarily greatly increase the expenses. In the judgment of the Commission this was a matter of the highest importance and it was an oversight of the last General Assembly that sufficient funds were not provided for the work and for seaching titles and making a complete survey of the public lands designated in the Act.

The Commission authorized the Surveyor to make a plot or blue print of the ground surveyed, to be attached to this report.

Subsequently a meeting of the Commission was held at Dover. All members present. The surveyor, Mr. Hopkins, had prepared a blue print showing the lands claimed by the State between Rehoboth Bay and the Ocean within the lines of his survey which is attached hereto. By an account in detail of the expenses incurred it was shown that but a small balance remained of the money appropriated for the work, and under these circumstances the Com-

I have the honor to transmit herewith my annual report as Commissioner of Fish and Fisheries in accordance with the provision of law; for the year ending December 31st, 1907.

During the year I have visited many of the streams, ponds and fisheries, and have not found any direct violation of the laws. Owing to heavy rains during the entire season we could not obtain any food fish for distribution until late in the month of December, and, as the weather was not

very promising at the time, the fish were distributed principally in New Castle County, with a few in Kent and Sussex Counties, as follows, viz:

REPORT OF PRESIDENT OF BOARD OF TRUSTEES OF THE DELAWARE STATE HOSPITAL, FOR THE YEAR 1908.

Hon. Preston Lea,

Governor of the State of Delaware:

Sir:

As President of the Board of Trustees of the Delaware State Hospital at Farnhurst, I have the honor to report that in the months of April and October I visited the-following Institutions caring for the wards of the State: I found all of these defectives being well cared for and well instructed and their physical condition all that could be wished for under the circumstances. Mr. Delfino, an official of the Blind Asylum at Philadelphia, and Mr. Vantrump, of Wilmington, have done good work in hunting up the indigent blind of the State and several additional pupils have been sent to the school. Most of the deaf and dumb, the dependent deaf and dumb, of the State, of a suitable age, are being taken care of in Washington and Philadelphia and all are being educated on modern lines. The State is supporting twelve feeble minded children, male and female, at the Elwyn School. I am sure there are many, many more of such unfortunates in the State that should be under instruction and under custodial care. people as they grow up are a great danger to society, and unfortunately they will reproduce their kind and are thus a menace to the coming race. With all my heart I recommend that this matter be looked into by the coming Legislature, that a commission be appointed and the State canvassed, to hunt out these defectives and sufficient money be appropriated to educate them and give them custodial care and thus relieve us of the great peril these degenerates are and will be to those who come after us in the race for life.

## REPORT OF STATE FACTORY INSPECTOR.

Wilmington, Del., July 1, 1908.

The Governor,

Dear Sir:

I have the honor to submit to you my report as State Factory Inspector for the quarter ending June 30, 1908.

I have made 108 inspections divided among 48 establishments, and have found the conditions much improved in Wilmington. All the establishments, where children are employed, send all doubtful cases to me before employing them.

There have been 30 children sent home who could not get proper certificates.

38 children have been refused certificates.

12 certificates have been issued to children of widows.

There has been an improvement in the sanitary conditions.

The night schools, which were opened by the Wilmington Board of Education, to which I referred in my last report, are now closed after having been kept open 60 nights, allowing a large number of children to get school certificates.

There is quite an improvement in the child labor con-

dition, in the City of Wilmington, as the employer understands the law better and gives it more attention.

I have made some few inspections outside of Wilmington, have visited Dover and Newark. At Dover there was very few places coming under my jurisdiction. At Newark I inspected six establishments, of which five were O. K., and the other one had four white boys and two colored boys employed without proper certificates.
