An Act to provide for the conservation, protection, improvement and profitable use of agricultural land resources of the State of Delaware and for cooperation with the Government and agencies of other States and of the United States pursuant to the provisions of Section 7 of An Act of the Congress of the United States known as the Soil Conservation and Domestic Allotment Act, to assent to and accept the provisions of said Act; and, in conformity with the provisions of said Act, to designate and authorize the University of Delaware as the State Agency of this State in conformity with such provisions, to formulate, submit to the Secretary of Agriculture of the United States, and administer, State plans to carry out the provisions of this Act, to define the powers and duties of said University of Delaware as such State Agency, to provide for an Advisory Board and otherwise to provide for the administration of this Act, and making an appropriation.

Was taken up for consideration and read a third time, by paragraphs, in order to pass the Senate.

On the question, "Shall the Bill pass the Senate?"

Was taken up for consideration and read a third time, by paragraphs, in order to pass the Senate.

Mr. Matthews moved that all rules be suspended and that so much be considered the third reading of the bill.

Motion prevailed.

On the question, "Shall the Bill pass the Senate?"

An Act to amend Chapter 166 of the Revised Code of Delaware, 1935, entitled, "State Highway Department," by providing for the establishment of a Public Highway Drainage System; authorizing the State Highway Department to construct Ditches and Drains, and to take over existing Ditches and Drains affecting Public Highways, and to maintain, regulate and control the same; directing the several Levy Courts to appropriate money for, and otherwise to provide for the expense thereof; and by providing for the punishment of persons wilfully or negligently injuring Ditches and Drains; and by providing the power of Eminent Domain.

Reported the same back to the Senate favorably with Senate Substitute.
