# STATE OF DELAWARE EXECUTIVE DEPARTMENT

April 12, 1939

To the Honorable, the Senate 107th General Assembly, State of Delaware Dover, Delaware

#### Gentlemen:

I herewith return without my approval, Senate Bill No. 306, entitled "An Act to amend Chapter 57 of the Revised Code of the State of Delaware, 1935, entitled 'Department of Elections for the City of Wilmington,' by providing for the establishment of a Department of Elections for New Castle County."

This bill abolishes the Department of Elections for the City of Wilmington and establishes a Department of Elections for New Castle County. It is substantially of the same form as Senate Substitute for Senate Bill No. 86 and contains all of the vices presented in that bill. It is a purely partisan measure and names nine persons who shall constitute the Department of Elections for New Castle County. By its provisions, the minority political party is entitled to but two members out of the nine on the commission. The sole purpose of this bill is to gain control of the Election machinery for one political party.

I recommended in my message at your convening that a revision of the General Election laws of the State of Delaware should be undertaken by your body, with a view to safeguarding the right of franchise of our citizens by effecting economies in the election machinery. This bill in no way deals with or meets these problems, which so long as they are present hold out Delaware as a State having expensive and antiquated election machinery, susceptible of corruption and thwarting the will of the people. The continued persistence of this General Assembly to consider solely legislation of a partisan nature will establish it as one which ignored and disregarded the general welfare of our State. Economy and non-partisanship are no parts of this bill. The attributes of good legislation have been lost in the setting of the dangerous precedent of wholesale ripper legislation.

This bill, like similar bills, heretofore presented for my consideration, is designed solely for political purposes and in my opinion, no such legislation is beneficial to our State. To approve such a bill would be to sanction political plunder at the taxpayers expense.

I feel that any legislation that would curtail employment at this time is entirely out of order and that we should do everything in our power to discourage any legislation of this type.

To the Honorable, the Senate 107th General Assembly, State of Delaware Dover, Delaware

#### Gentlemen:

I herewith return, without my approval, Senate Substitute for Senate Bill No. 152, entitled "An Act to amend Chapter 153 of the Revised Code of Delaware, 1935, relative to Offenses Against Religion by Legalizing Motion Pictures on Sunday after two o'clock P. M. in Incorporated Cities having a population of more than 25,000; providing that this Act shall not become effective unless ratified at Special Election."

This bill is designed to permit the exhibition of motion pictures on Sunday in incorporated cities having a population of more than 25,000 provided, if at a referendum held for that purpose, a majority of the voters should ratify the legalizing of such exhibitions.

A great many of our citizens, as well as the religious leaders of our churches in the State deeply feel that there should be no tendency to sponsor or countenance matters which would tend to make Sundays and week days indistinguishable. The Sabbath Day should be kept apart from other days of the week.

This bill presents also a constitutional question. It may be well doubted whether under the Constitution of our State matters of referendum may be submitted to voters of the State or any of its political sub-divisions except under Article XIII relating to local option. The Constitution makes no provision for the submission of other questions to the voters. This doubt as to the constitutionality of this bill persuades me that it should not have my approval.
