Upon inquiry made at the office of the Adjutant General of the United States shortly after I had been authorized to collect the claim of this State against the United States for commutation under the provisions of the Act of Congress, approved February 28, 1867, I learned that the balance of the appropriation from which this class of claims was paid by the War Department, at Washington, had been turned into the Treasury, and that such claims are now, after approval by the Secretary of War, referred to the Second Auditor of the Treasury; and upon inquiry of the Second Auditor it was ascertained that such claims, when approved by him, are referred to Congress with favorable recommendation, and are provided for in the General Deficiency Bill. I have also been authoritively informed that such claims can only receive the approval of the officers aforesaid when accompanied by the receipts of the receiver of commutation money. I at once caused the following advertisement to appear in four newspapers published in the State, viz: the *Delawarean* and the *State Sentinel*, of Dover, and the Gazette and Republican, of Wilmington, viz:

"Persons who were drafted in the State of Delaware for the United "States military service in May, June, or July, 1864, and paid com"mutation, and were afterwards again drafted in 1865, and were 
"required to procure a substitute or enter the military service under 
"the latter draft, will find it to their advantage to communicate, either 
"personally or by letter, with the undersigned, who has been author"ized by the State Legislature to collect from the Secretary of War 
"the commutation money paid by such persons; the Secretary of War 
"having been directed by act of Congress to refund the commatation 
"paid in such cases."

"Dover, Del., July 10, 1879."

In response to this notice I have received quite a number of communications from persons who supposed themselves to be entitled to the benefits of the aforesaid act of Congress, quite a number of which I suppose were good claims; but the parties making the claims were not in possession of the receipts for the commutation, which have necessarily to be filed in the Adjutant General's office, at Washington, with the claims, when presented, so that I could do nothing in the way of obtaining the approval of the Secretary of War or the Second Auditor's recommendation to Congress for their payment.

It appears that when these commutation moneys were paid, twothirds of each commutation having been advanced by the State, through the Commissioners appointed for that purpose in pursuance of the provisions of the act of the General Assembly of this State, entitled "An act for the relief of persons subject to military duty, passed at Dover, February 12, 1864," said Commissioners themselves took charge of the receipts given by the receiver of commutation, and none of these receipts were held by the petson drafted, who paid only one-third of the commutation. It is believed that these receipts are now in the keeping of the Secretary or Clerk of said Draft Commissioners, Richard G. Cooper, Esq., or of James G. Waples, Esq., the only surviving member of said commission.

I would therefore respectfully suggest that your honorable body shall adopt a joint resolution directing James G. Waples and Richard G. Cooper, Esquires, and all other persons having in his or their possession any books, receipts, documents, or other papers pertaining to the military drafts, or the business of the Draft Commissioners of this State during the late civil war, to deliver the same to me, to be used in collecting the aforesaid commutation claims, and to be afterward deposited by me in the Executive office of this State, except such as I may be required, in the prosecution of said commutation claims, to file in the War Department at Washington, or elsewhere.

## SPECIAL MESSAGE.

## Gentlemen of the Senate and House of Representatives:

At a meeting of the Governors of the thirteen original States, held in Carpenter's Hall, and adjourned to old Independence Hall, in the city of Philadelphia, in 1879, it was determined that the Centennial Anniversary of the surrender of Cornwallis, at Yorktown, should be commemorated with suitable ceremonies on the 19th day of October, A. D. 1881. It was also resolved that the Governor of each State should appoint a Commissioner, whereupon I appointed Hon. Benja-

min T. Biggs, for Delaware.

This is an event which appeals with peculiar force to the patriotic sentiment of these States, inasmuch as it virtually terminated their condition of colonial bondage and placed them on a footing of equality among the nations of the earth. That which they obtained by the recognition of each State as a separate and distinct sovereignty was not acquired by right of inheritance nor by voluntary grant, but was purchased by the immense sacrifice of life and property. Our patriotic ancestors, in the dark days of the Revolution, having distinguished themselves by their wisdom in council and their chivalry in battle, it is very natural that Delaware should feel a deep interest in the commemoration of those events of revolutionary times, whereunto the heart of every lover of civil and religious liberty turns with fond and reverential respect.

The battle of Cowpens, being one of a series of contests between the American and British forces preliminary to the triumph at Yorktown, forms also an event of prominence and importance in the history of American Independence, the centennial anniversary of which is proposed to be celebrated in a proper manner, at Spartansburg, on the

11th day of May, 1881.

I call your attention to these subjects, and herewith submit the accompanying papers in reference thereto, in order that you may take such steps as you shall deem necessary for a proper participation by Delaware in the observance of those occasions.

In making this special communication, I would also direct your attention to the International Exposition to be held in the city of New

York, in 1883. This will be an occasion of interest and importance to the people of this State, since it will afford an opportunity for the exhibition of specimens of our manufactures and various agricultural products, and thus enlarge public acquaintance with our natural resources, and lead, perhaps, to their more thorough development.

Upon my recommendation, the President of the United States has appointed J. Parke Postles, of Wilmington, and Alden B. Richardson, of Dover, as Commissioners on behalf of this State, and Cæsar A. Rodney, of Wilmington, and Joseph B. Wilson, of Claymont, as

alternates.
