WHEREAS the article circulated had to do with a case of a colored farm hand who died prior to February 1905, twenty years after he had been vaccinated; and

WHEREAS the case is cited from the second number of the first volume of a medical magazine which must have been drawing its first breath of life, and whatever its weight later as authority, certainly could not be accepted as an authority then; and

WHEREAS, there was nothing sufficient to indicate let alone prove, that the vaccination had anything to do with the carcinoma; and

WHEREAS, anyone with no more intelligence than that found in a gnat's brain would have sense enough to see that such an isolated case would not furnish any conclusive proof against vaccination; and

WHEREAS, the party circulating the article seems with his medical knowledge of vaccination to have gotten no further than that covered in the period from 1905 to 1921; and

WHEREAS, said circulator seems to take pride that during nearly one half of this period he was a dissenting Editor; and

WHEREAS, as a baby which rolls its stick of candy about in the dirt, yet holds blindly upon it when someone tries to clean off the dirt, so does the party circulating the paper hold on,—in this instance a case history of one single colored farm hand from one of the malaria ridden sections of one of the southern States, —and apparently expects people who do have common sense and intelligence to be as blind as he; and WHEREAS, the efforts of the circulator are ineffectual and his evidence offered disgusting,

NOW, THEREFORE, BE IT RESOLVED by the House of Representatives of the 109th General Assembly of the State of Delaware

That Porter F. Cope be and he is hereby advised that this body feels his article circulated as Liberty Paper is lacking in intelligence and common sense and that the members have no desire to receive his circulars, but on the contrary do not want any of them, and

BE IT FURTHER RESOLVED that the said Porter F. Cope take steps to come out of the fog of the past in which he now seems to be enveloped, and to acquaint himself with modern medical knowledge as a result of which it is hoped his ignorance in medical matters will not be so pronounced, and

BE IT FURTHER RESOLVED that a copy of this Resolution be spread upon the Journal of this House and a copy thereof forwarded to the said Porter F. Cope.
