And, in order that the law may be entirely effective, the existing law in the State of Louisiana is recommended to their favorable consideration. It shall further be provided that all laws and parts of laws, and all provisions of the Constitution of the United States and of this State, inconsistent with the acts or decisions of this Returning-Board, shall be repealed, made null and void.
