On the 10th day of February I received a check for \$94,725.39.

On the 26th day of February I received two checks, one for \$20,000 and another for \$31,417.37.

The check for \$20,000 I was authorized to use at once, and presented the same the following day at the New Castle Bank, on which it was drawn, and was informed that there was not sufficient funds there to meet it, whereupon I waited upon Mr. Herbert, and advised him of the situation, and he told me that the said check would be made good on the following day (Saturday). With this understanding I left the check with the bank officers, and I have just been informed, by telegram, that he had substituted for this check one for \$17,000, which was paid, and one for \$3,000, which would be sent to me by mail.

The check for \$31,417.37, I still hold, having presented it the same day at the same bank, payment of which was refused and marked "Not sufficient funds."
