# STATE OF DELAWARE EXECUTIVE DEPARTMENT

March 24, 1939

To the Honorable, the Senate, The 107th, General Assembly, State of Delaware, Dover, Delaware.

#### GENTLEMEN:

I return herewith, without my approval, Senate Substitute for Senate Bill No. 224, entitled "An Act to amend Chapter 166 of the Revised Code of Delaware, 1935, providing for Reorganization of the State Highway Department by increasing the Membership thereof."

This bill is designed to reorganize the State Highway Department by increasing the members thereof and establishing a board consisting of seven members without the Governor of the State. This bill names the persons who shall be members of the Department. It has all of the vices that were inherent in Senate Substitute for House Bill No. 30. The reasons for my disapproval of that bill are applicable to this present bill.

Here again is a bill whose sole purposes is an attempt to oust from office the present personnel of the State Highway Department. Here again is a measure solely seeking political patronage at public expense. So long as the attention of the General Assembly is directed to bills of this character, so long will the vital needs and the welfare of the people of our state be unaided and forgotten.

Our system of State Government to which we have been accustomed throughout many years should not be over-thrown as ruthlessly as that exercised by a European dictator. Insofar as the operation of the Highway Department is concerned, this bill is more vicious than Senate Substitute for House Bill No. 30, as by its provisions, it makes possible a further shift in the policy and personnel of the Department within a two-year period and disrupts the orderly administration of the people's business.

I emphasize the dangerous precedent set by such legislation and I am satisfied that the continued attention of this General Assembly to

purely partisan matters will result in the disregarding and denial of the needs of our citizens.

No attempt has been made to create a non-partisan Department, but the desire of this Legislature as expressed in this bill is only to make the Highway Department a political adjunct to the Republican party. This appears the more so when consideration is given to the voting down of the amendments presented to this bill by the Democratic members of the Legislature, which, if adopted would have taken the Department entirely out of politics.

Changing or ripping out all present laws might also have the tendency to discourage the incorporation of various Companies or firms who have in the past looked to our State as a favorable place to locate. The results of your action during this session in the year 1939 will have far-reaching effects on our State for good or evil on all future sessions of our General Assembly.

Much has been written and spoken about the operation of the Highway Department being disrupted and numerous changes made in the Engineering Department. Such is not true. Since the Democratic Party gained control of the Highway Department, no changes have been made in the personnel of the Chief Engineer's Office except three positions which were filled on the Chief Engineer's recommendation.

Two County Resident Engineers were replaced with two graduate Civil Engineers.

The administration of the Highway fund, together with the budgeted expenditures have not been changed. Maintenance costs have not doubled as stated by one of the Senators, but were lower in 1938 than in 1936 under the former administration.

1936 . . . \$1,086,894.78 1937 . . . 908,245.78 1938 . . . 1,011,059.24

There has been no dissention among the present membership of the Highway Commission. Any requests made by the Republican Members for road improvements or construction have always been complied with, and I can see no reason except partisan political greed for increasing this Department. Again may I ask that more studied and sober thought be given to the welfare of the State in your reconsideration of this Bill, and I again appeal to your better judgement as a group of honorable, high-minded men with the best interests of our State at heart to seriously consider all angles of the measure before making it a law.

# STATE OF DELAWARE EXECUTIVE DEPARTMENT

Mar. 29, 1939

To the Honorable, the House of Representatives, The 107th General Assembly, State of Delaware, Dover, Delaware.

#### GENTLEMEN:

I return herewith, House Substitute for House Bill No. 1, which I have approved with the following exceptions:

Code F—6—8e State Treasurer for \$75.00 in each year of the biennium.

Code F—10—12e State Auditor for \$92.00 in each year of the biennium.

These two items are inadequate to provide legitimate expenses for the attendance of the State Treasurer and State Auditor at the annual conventions of the National Association of State Auditors, Treasurers and Comptrollers. The federal licensing of corporations, as proposed in Congress, is tentatively on the program of the Association's next meeting. In this Delaware has a large stake and should be represented. While I commend economy in general, I consider this unwise for Delaware at this time, and I, therefore, request that a larger amount be granted on these two items.

Code 1—18a—18e Old Age Welfare Commission-Pension Account.

The following recommendations are made in lieu of those appearing in the Budget Bill:

In making this recommendation for a change in the allotment of the appropriation, I realize that the Legislature has adopted the recommendations I made in January. Since then, however, due to Federal requirements as to personnel, office management and travel needs, and to the provisions of your House Bill No. 169, realignments in these appropriations are necessary. On the surface it would appear that administrative costs are being increased at the expense of pensions, but such is not the case when the Old Age Welfare Commission, Special Account, composed of Federal grants-in-aid, is considered. By adopting this recommendation the State will appropriate more for administrative costs and less for pensions, but the same in Governor's message on House Substitute for House Bill No. 1. total; but it will receive sufficient Federal monies for pensions to compensate it for these adjustments.

Code G—2, State Insurance Commissioner, \$30,000.00 for the year ending June 30, 1941.

This amount appears excessive at this time. For many years custom has been to carry insurance on buildings where little, if any, hazzard exists. I believe some are over-insured. On such buildings the State should adopt a self-insuring policy, rather than hand out insurance policies as a type of political patronage. The State Insurance Commissioner should report in full as to all policies to the 1941 Legislature. Then if additional funds are needed there will be ample time for the 1941 Legislature to vote them by a supplementary appropriation act. This appropriation should be reduced by \$10,000.00 to \$12,000.00.

K-6a-6f, State Board of Agriculture, Bureau of Markets, \$3,600.00 for each year of the biennium.

The reduction of this appropriation from the \$5,500.00 recommended by me threatens to cost our Delaware farmers many times the cost of the attempted savings. The Bureau of Markets has cooperated with the farmer to better his greatest problem, that of finding good markets for his produce. The reduction is unsound and the original amount of this appropriation as recommended should be restored.

L—5—7d Parole Board, Salary of Parole Officer \$1,800.00 for each year of the biennium.

Delaware has had no parole racket because paroles in this State have been handled cleanly and efficiently. The major credit for this belongs to the parole officer. Reducing his salary from \$2,400.00 to \$1,800.00 certainly indicates no appreciation for his meritorious and conscientious service. Rather is it petty politics. The amount of this reduction should be restored.

I respectfully call to your attention the three following situations created by this Budget Bill:

- (1) The operations of the State Board of Agriculture will be drastically curtailed, especially in the fields of controlling the diseases of livestock and of inspecting farm products. The State's service to our farmers will be greatly impaired.
- (2) The Mosquito Control Commission will have insufficient funds to maintain the marshes drained by Federal authorities, although I agree that we cannot now afford to continue with a new drainage program. I do believe we should take care of what has been done for us.
- (3) The State Housing Commission is legislated out of operation because of no appropriation. There will exist no central housing body where plans can be formulated to improve housing conditions, especially in Wilmington, where the need is so great.

So the question was decided in the affirmative and the Amendment having received the required constitutional majority, passed the House.

Mr. Benson offered House Amendment No. 8 to House Substitute for House Bill No. 1.

Which was taken up for consideration and read in order to pass the House.

Mr. Benson moved the Amendment be adopted.

Mr. Buckingham seconded the motion.

On the question "Shall the Amendment Pass the House?"
