State of Delaware, Executive Department, August 1, 1939

To the Members of the 107th General Assembly of the State of Delaware.

#### Gentlemen:

Again it becomes my duty as Governor of our State to give to you information of affairs concerning the State and recommend for your consideration such measures as are in my opinion expedient. It is not my intention now, to review the record so far made by this General Assembly. That record is open and available to the scrutiny of every citizen of our State, but it is my hope that you will now, during these remaining days of the session, cast aside partisan purposes and give to our State and our citizens the best possible means for efficiency and economy in government that can be had.

In my inaugural address, and since—in various messages to the

General Assembly, I expressed the definite view that the expenditures of Delaware should be confined to its income. In other words, we must pay as we go. I still am of that opinion, but false economy should not thwart the progress of social reforms and caring for our less fortunate citizens.

It is gratifying to report that the financial position of our State is excellent, as was indicated in the sale of \$1,250,000.00 of Highway Bonds, at a premium of \$17,312.50 and the low interest cost of 1 5/8 per cent. If the premium is added to the \$625,000.00 of Federal funds obtained, the interest cost to the State is just a little over 1 per cent. This clearly shows the high regard in which the obligations of the State of Delaware are held, but it must be pointed out that postponed obligations are the hardest to pay, and only by continually endeavoring in the face of additional demands for public service, to provide for such public service at a reduced cost can our balanced budget be maintained.

There are two matters of great importance awaiting your action. There is now before the Senate for its consideration forty-one nominations made by me to fill various State offices. Each one of these offices exercise an important governmental function. The Senate has failed to perform its constitutional and legislative duty by not acting upon these nominations. This failure has resulted in the crippling of the State's business. Important work of the State Government cannot be carried on as a result of this. The Senate, by its unprecedented failure to act, has hindered the performing of the public duties which the constitution and statutes provide should be performed for our citizens. It is time this sit-down strike ended. It is imperative that action be taken on these appointments lest governmental functions cease.

The matter of appropriations to our hospitals, fire companies and other institutions lies in your power. Such appropriations should be made in the method provided for by our constitution, and further should provide for a practical method of disbursing these funds. I urge that both of these important duties be promptly performed.

In addition to these measures, there are other matters which concern the welfare of our citizens.

Crowded conditions exist at Brandywine and Edgewood Sanitoriums. The prevention and cure of tuberculosis is a matter which our State owes to its citizens. The waiting list for these institutions demands that additional facilities be made available to our people.

Two years ago a report was made to the General Assembly, pointing out the necessity for additional buildings at the Ferris Industrial School. The work of this school in remoulding the lives of young boys so as to give them a better opportunity to take their place in society should not be curtailed. I recommend that a bond issue be authorized in the amount of \$200,000.00, so as to provide for the additional buildings at the Brandywine and Edgewood Sanitoriums and the Ferris Industrial School.

With demands for assistance and pensions to those over sixty-five years of age increasing, I recommend that an additional and supplementary appropriation in the amount of \$50,000.00 be made so that needy and deserving applicants can be given aid.

Our present relief system, whereby the same is administered by the Old Age Welfare Commission, from funds contributed by both the State and the respective counties, has operated successfully. Since there is every prospect of increasing employment at the present time, which will lessen the burden of relief on the counties and the State, and the indications are that the present system can be maintained without further increase in our tax rate, I recommend the continuance of the present system.

I am happy to report that the Permanent Budget Commission recommended by me in my message to this General Assembly has been put into effect by the provisions of House Bill No. 467 and that economies and efficiency in the State Government already are resulting.

A definite survey and program should be formulated to determine the future requirements of all of our State institutions and particularly the Delaware State Hospital at Farnhurst, so that future General Assembles may be fully informed as to their needs.

I bring to your attention that typographical errors exist in House Substitute for House Bill No. 315 and Senate Bill No. 319. In order that these laws may be carried out in accordance with their intention, I recommend that correcting amendments be enacted.

There is another matter which is of great importance which has not received the merited attention of this General Assembly. Our State should undertake by appropriate planning a program designed to meet our local conditions and in harmony with the welfare and social reforms of the Federal administration. There was paid by the citizens of our State to the Federal Government for the year ending June 30. 1939. \$71.859.797.00, and if possible, an effort should be made to receive a larger share of Federal funds for our citizens. Too long have we delayed in availing for our people the advantages offered by the administration in Washington. Particularly has this General Assembly failed to make an appropriation which would make possible the continuance of the CCC camps in Delaware. The Park Service, the Mosquito Control work, the Forest Service and the drainage work done by these institutions are most beneficial to our State. But more important, these institutions give encouragement to young boys and men by giving them physical and mental training so as to prepare them for a place in society. Again, I recommend an appropriation to provide for the continuance of these camps, and further I recommend that the various State agencies cooperate more fully with the Federal Administration.

The Treasurer's report shows that there is sufficient money now in the State Treasury to provide for the interest and the amortization on the bonds I have recommended to be issued for the building program at Brandywine and Edgewood Sanitoriums and the Ferris Industrial School, and also to provide for the annual appropriation of \$25,000.00 in order to maintain the CCC camps. Public money, as well as private money, should not be idle and the financial status of the State warrants the use of this money for the general welfare of our citizens.

Again I emphasize the work and welfare of the State must come first. Personal or political advantage must be subordinated to the best interests of the State. Cannot this General Assembly, in its closing days, give sole consideration to all of our citizens, so that Delaware may be first in performing its duties for the general welfare of its people as well as in name among the States of our Union? To the end that this may be accomplished, I solicit your aid and cooperation.

## STATE OF DELAWARE

#### EXECUTIVE DEPARTMENT

August 14, 1939

To the Members of the One Hundred Seventh General Assembly, State of Delaware

### Honorable Gentlemen:

I am pleased to advise that I have today signed the twelve appropriation bills passed by the General Assembly on August 1st covering the necessary appropriations for the hospitals and other welfare institutions of the State. These bills have been enacted in a constitutional manner and so far as I know, there is no obstacle to the prompt disbursement of the funds provided to the institutions which are to receive them. My regret is that the request made by me on August 1st to the Republican members of the State Senate, that they immediately pass these bills after the speedy action of the House and have them delivered to my office so that I could then sign them in order that the various

institutions could receive these appropriations the following day, was totally ignored by not delivering these bills to me until today. The urgent needs of these institutions were apparently overlooked, but in order to carry out the good faith in which my suggestion was made and in order to prevent any further delay in these appropriations reaching the various charities, I am happy to report that they have been signed by me and are now law.

I believe I voice the sentiment of the people of this State when I ask you to give your attention to the urgent legislation which is now required rather than to legislation which has to do with partisan politics. The continual centering of the attention of this General Assembly on partisan matters has been to the disadvantage of the citizens of this State. The record is clear on that and it was made more clear when bills passed by the General Assembly on May 2, 1939, providing for appropriations to the Claymont School and the Mothers' Pension Commission were not delivered to me at my office until August 2, 1939, thus depriving these institutions of these appropriations for more than three months in deference to partisan matters.

I again voice my regret and I believe the regret of the greater number of people of our State at the action of the majority members of this General Assembly in voting against bills presented on August 1st by the minority members providing for an appropriation to take care of a needed building program at the Edgewood Sanitorium and the Ferris Industrial School and the continuance of the CCC camps with their ditching, mosquito control and forestry work. I trust it is not too late for these bills to be reconsidered.

The recently adjourned session of the Federal Congress enacted several amendments to the Social Security Act directly affecting the State Unemployment Compensation Laws.

In order to bring the Delaware Unemployment Compensation Law into conformity with the Federal law as amended, the Unemployment Compensation Commission has prepared a bill amending the appropriate sections of the Delaware Act.

These amendments provide for the following changes:

1. The Federal definition of "wages" is adopted thus limiting the base of contributions under the State Law to the first \$3,000 earned by

an individual from any employer during a calendar year. Reliable estimates indicate that these amendments will save Delaware employers about \$350,000 a year, beginning in 1940.

- 2. National banks and state banks, members of the Federal Reserve System, will be covered by the State Law. Since they will be required to pay the Federal 3 percent excise tax, this places no additional tax burden upon the banks, and does provide protection for their employees.
- 3. The change in tax base from "wages payable" to "wages paid" is provided for in order that employers may keep payroll records and file reports on the same basis for the various taxes under the Social Security program.
- 4. The bill redefines "taxable wages" following exactly the language of the Federal Act. This will simplify the employers problems as to liability for contributions under the State Law.

Since certain of the changes in the Federal Act are effective as of January 1, 1939 and others as of January 1, 1940, it is imperative that prompt consideration be given the amendment proposed by the Commission.

The action of the Republican members of the House in voting against the consideration of these amendments this morning is a blow to the business interests of our State. Cannot this action be reconsidered now?

In addition to the above matters, there is still the important unfinished business of action by the Senate on my appointments in various governmental offices. Again I stress the importance of such action so that the governmental functions of our State can be carried on.

There is another matter which may seem small but is a convenience and a necessity particularly for the new enterprises which have adopted Delaware as their home. I refer to House Bill No. 382, introduced by Representative McGuigan which provides for the increasing of the number of notary publics in the State. The limit now fixed by law has been reached and new enterprises are without this proper and needed service. I urge the immediate passage by the Senate of this bill.

I feel that in the public interest, having in mind that of economy, these matters should be covered by needed legislation and that this General Assembly, which has surpassed all others in the matter of the expense to the taxpayers and has been prolonged beyond all State records, should thereupon adjourn sine die.

Many persons took the opportunity and one group appeared, being represented by counsel. While numerous charges and counter-charges were made, some against the Commission and some in support of the present Commission, your Committee is of the opinion that most of the complaints arose out of personal differences or personal considerations and were not of a nature that militated against the proper functioning of the Game and Fish Commissioners. Your committee feels that inasmuch as the major part

of the evidence dealt with personal matters and did not show any serious defects in the administration of the laws relative to fish and game and also that such involved matters on which there could be an honest difference of opinion, that it cannot recommend to this General Assembly that the present Board of Game and Fish Commissioners should be abolished. In so saying we do feel that there are some minor matters, which having been called to the attention of the Commissioners, will naturally be corrected by them.




