To His Excellency Hon. Robert P. Robinson, Governor of Delaware. Dear Sir:

Since our last written report to you in March 1925, we have, as members of a commission, the same being authorized by House Joint Resolution, Chapter 248, Volume 321, Laws of Delaware, given considerable time, thought and effort, to endeavor to draft a bill relating to the catching or taking or attempting to catch or take fish from the waters of the Delaware river, lying between low water marks of the State of Delaware and State of New Jersey, which would be agreeable to the inhabitants of said states as under compact agreement passed by the congress of the United States in 1905, we must have a common right of fishery on the waters of the Delaware river in order to have any law at all, except the laws as were in existence previous to 1905, and only such parts of them as did not interfere with a common right of fishery.

As our compact agreement states, we must have a common right of fishery in the waters of the Delaware river and may have uniform laws relating to fishing on the bay, we have deemed it advisable, as the fishing in the bay appeared as most of our difference, to draw a bill relating to catching or taking or attempting to catch or take fish from the waters of the Delaware river only.

This bill which has been introduced in the Senate of the present session of the General Assembly was drawn after considerable communication between the commissions appointed of the State of New Jersey and State of Delaware. On the advice of the attorney general of the State of Delaware, Clarence A. Southerland, Esq., who conferred with the attorney general of the State of New Jersey, we are now presenting, with a few changes, the law passed by the State of New Jersey in 1907, and which law we find after frequent consultations with the people of the State of Delaware, who are interested in the fishing industry as a means of livelihood and conservation of food fish, to be as near perfect as a law can be applying to fishing on the waters of the Delaware river.

We believe that the people of the State of Delaware would not be satisfied with any material change in the law as presented and that the State of New Jersey will pass it at its next session of their General Assembly which will be not later than 1928 and possibly sooner. We understand they do not expect to adjourn sine die and may meet again this year.

We wish to assure you that the task of securing uniform legislation is both complicated and arduous, and the present commission believes that the only way we can secure a common right of fishery on the River and uniform laws relating to catching or taking or attempting to catch or take fish from the waters of the bay is by the enactment of two separate acts and the present act of applying to the river will be of great help in future considerations of the bay question.

The Delaware commissioners also desire to state that they entertain sentiments of the best personal regard and respect for all members of the New Jersey commission who are men of unquestionable integrity, ability and high standing in their state; the personal relations of the two commissions have been most pleasant.

In submitting our report to you, the commission is of the opinion that the fishing industry in New Jersey and Delaware is hampered because of the lack of uniform legislation and the confusion which has arisen since the compact of 1905.

The Delaware commission desires to state that in considering uniform fishing laws it has always had in mind the conservation of food fish and it is only fair to say that the New Jersey commissioners have heartily cooperated in this matter.

This commission deems it proper to call your attention to the fact that for some years and since the passage of the Federal migratory bird law there has been considerable agitation in favor of a migratory fish law which would place the catching and taking of migratory fish under Federal regulation.

Other states beside Delaware and New Jersey, between which navigable waters run, have had great difficulty in agreeing through their State Legislatures upon uniform fish laws and this condition which exists all through the United States has been the cause of the present agitation for Federal control of fishing. Such a Federal law may prove to be the only solution of the difficulty but it may be many years before such Federal control may be made effective.

We wish to take this opportunity to express our thanks to the attorney general of the State of Delaware, Honorable Clarence A. Southerland, for the great amount of interest he has taken in the work of our commission. He has made trips to Trenton to confer with the attorney general of the State of New Jersey and our commission has had numerous conferences with him in working out our problem.

## REPORT OF "THE STATE HOUSE ANNEX COMMISSION"

To the Honorable, the members of General Assembly of the State of Delaware:—

The State House Annex Commission begs leave to submit the following report:—

By virtue of Chapter 8, Volume 34, Laws of Delaware, entitled, "An Act providing for the erection of an Annex to the State House," the Governor by virtue of the power and authority in him vested by said act, appointed five (5) persons, who together with the Governor, were created a Commission to erect an Annex to the State House as provided in said Act.

The Governor appointed as members of said Commission Mr. Peter J. Ford, of Wilmington, Delaware, Mr. Frank N. Overdeer, of Wilmington, Delaware, Honorable William G. Taylor, of Wilmington, Delaware, Mr. Harry V. Lyons, of Lewes, Delaware, and Arley B. Magee, Esquire, of Dover, Delaware, who together with the Governor constituted the said Commission.

Upon the death of the Honorable William G. Taylor, the Governor appointed the Honorable Sylvester D. Townsend, Jr., to fill the vacancy. Upon the death of Mr. Townsend, the Governor did not fill the vacancy, for the reason that the work of the Commission was substantially completed.

The said "The State House Annex Commission" was authorized, empowered and directed to construct and equip an Annex to the present State House, to be used for state offices and administrative purposes, to be located at the rear of and adjoining the present State House and the said Act provided that no part or portion of such Annex should encroach upon or extend across, over or into the public street and road known as the "South Little Creek Road" and running in an Easterly direction from the Dover Green between the present State House and the old County Building, formerly used as administrative offices of the State Highway Department.

The Act further provides that the duties of said Commission shall include the erection and completion of the Annex afore-

said, the equipment of such Annex with necessary fixtures for heating and lighting and furnishing and decorating the same and the making of such alterations to the present State House as shall be necessary or proper to enable the new Annex to be used in connection therewith.

Immediately after organization, the Commission employed Messrs. Brown and Whiteside, of Wilmington, Delaware, as Architects, and proceeded as rapidly as possible to have the necessary drawings and specifications prepared for the construction of said Annex, and plans for lighting, heating, decorating and furnishing the same.

The Commission let contracts for the execution of the work authorized by said Act after public advertising, to the lowest, best and most responsible bidder, reserving the right to reject any and all bidsfi and did require all contractors to give bond satisfactory to said Commission for at least equal to one-half of the amount of the respective contracts.

The Act further provides that the total aggregate cost for the construction, equipment and decoration of such Annex and for the necessary alterations to the State House, the performance of all other work authorized, including all fees, commissions, salaries and expenses of all kinds should not exceed the sum of one Hundred and Fifty Thousand Dollars (\$150,000.00) and the said sum of One Hundred and Fifty Thousand Dollars (\$150,000.00) was appropriated for said purposes.

The Act further provides that the said Commission should use its best endeavor to complete all of their duties and work by the First day of January, A. D. 1927.

The Act further provides that the said Commission have the power to allot and assign and re-assign any and all rooms or portions in said building or in the State House, including recent addition, to the various state offices and departments, after a thorough study of the available space and the needs and requirements of each state office or department.

The Act further provides that the Commission shall render to this General Assembly a full report of it proceedings under the provisions of said Act.

The Commission has completed and equipped the Annex Building and begs leave to submit herewith a detailed statement of its expenditures, to-wit:—

The members of the Commission have made no charge for expenses incurred in connection with their duties as members of the Commission, and have expressed their pleasure of having been able to serve their State in this connection.

The Commission has allotted and assigned the rooms in the said State House Annex and in the State House to the various offices and departments, as follows:—

## ASSIGNMENTS

Pursuant to the authority set forth in Chapter 8, Volume 34, Laws of Delaware, and action taken by the State House Annex Commission, at its meeting held on October 13, 1926, the State House Annex Commission allotted and assigned rooms in the State Buildings at Dover, as follows:—

- (1) The allotments and assignments as set forth in Section 1, Chapter 4, Revised Code of Delaware (1915) were continued and remain as set forth in said Section, with the following exceptions.
- (a) The room in said Section allotted and assigned to the Insurance Commissioner was allotted and assigned to the Senate for use as a committee room during all times that the Senate shall be in session, but the right to make any other assignment thereof for other periods of time was reserved.
- (b) The room adjoining the Supreme Court room on the North was allotted and assigned to the House of Representatives for use as a committee room during all times that the House of Representatives shall be in session. At all other times said room was allotted and assigned to the Industrial Accident Board.
- (c) The space on the first floor immediately beneath the Senate Chamber (with exception of the hallway) was allotted and assigned for the use of the Secretary of State.

- (d) The storeroom adjoining the hallway and stairway, leading from the first floor of the State House to the Senate Chamber was allotted and assigned to the Secretary of State.
- (e) The space heretofore constituting the hallway between the offices of the Auditor of Accounts and the State Treasurer, and which now constitutes a portion of the Auditor's Offices, was allotted and assigned to the Auditor of Accounts.
- (2) The building heretofore known as the "County Building" which was purchased by the State under the provisions of Chapter 5, Volume 29, Laws of Delaware, was allotted and assigned to the State Board of Agriculture.
- (3) Rooms in the State House Annex were allotted and assigned as follows:—
- (a) The Northwesterly room on the first floor and the room connecting therewith on the South were allotted and assigned to the State Bank Commissioner.
- (b) The remaining rooms on the first floor were allotted and assigned to the State Highway Department.
- (c) The Northeasterly room on the second floor and the next room immediately to the South thereof, were allotted and assigned to the State School Tax Commissioner.
- (d) The room next immediately to the South of the rooms assigned to the State School Tax Commissioner, was allotted and assigned to the Insurance Commissioner.
- (e) The Northwesterly room on the second floor was allotted and assigned to the Chancellor.
- (f) The remaining rooms on the second floor were allotted and assigned to the State Board of Education. The State Board of Education shall not have the right to use for its meetings the offices of the Auditor of Accounts, as provided in Chapter 4, of the Revised Code.
- (g) All of the rooms on the Easterly side of the third floor with the exception of the two most Northerly rooms on said side of said floor; also the three communicating rooms at the Southerly end of the third floor and the four communicating rooms on the West side of the third floor, which lies nearest to the Southwesterly room on said floor, were allotted and assigned to the State Board of Health.
- (h) The two most Northerly rooms on the East side of the third floor were allotted and assigned for the use of Legislative clerks during all times that the Legislature shall be in session, but the right to make any other assignment thereof for other periods of time was reserved.

- (i) The Northerly room to the West side of the third floor corridor or hallway was reserved for subsequent allotment and assignment.
- (j) The room to the West of the third floor corridor or hallway which lies between said last mentioned room and the toilet was allotted and assigned as a rest room for the female employees for the State House buildings.
- (k) All other rooms and spaces not specifically hereinbefore allotted and assigned were reserved for subsequent allotments and assignments. In addition, the right to re-allot and re-assign any and all rooms and spaces in the hereinbefore mentioned buildings was reserved.

The Commission commends the Architects, the Supervisor, the General Contractor, and all sub-contractors for their faithful and efficient services.
