We found that the public road in question, which is used by the Oyster Planters and for the benefit and convenience of those engaged in that business exclusively, is in such condition that, unless some rebuilding is done at once, will be entirely destroyed within a very few months by the tides of the Delaware Bay and storm seas that break over it. The road in question is now cared for by Kent County with the assistance of an appropriation of four hundred dollars annually. This has heretofore been sufficient, together with what has been appropriated by the Levy Court of Kent County, but under the existence of present conditions, this falls very much short of the needs of the road.

The State being the only beneficiary of the Revenue derived from the Oyster Trade, your Committee deems it proper that an appropriation of at least twenty-five hundred dollars be made by the State for the purpose of assisting Kent County in the rebuilding and straightening of this road, provided, however, that Kent County shall bear one-third of the entire cost of said road.

THE AMERICAN NATIONAL RED CROSS

Dear Sir:

The Delaware Red Cross, under its charter, aids in any fight against pestilence, and therefore urges the passage of House Bill

- No. 120. We submit to you the reasons why the Red Cross upholds the enclosed bill as a claimant for your support and your vote.
- 1. This bill is statewide and not local. It is not for any local hospital which the locality itself can help. The State Tuberculosis Commission must take care of the whole State.
- 2. This bill is intended to benefit the negro consumptive. At present the negroes—comprising one-fifth of the population—have not an adequate number of hospital beds. As one-fifth of the population, they have a right to consideration.
- 3. This measure will return value to the State, in its effect on public health. Each destitute consumptive cured means a citizen restored to industry and self-support. Each advanced case isolated during the last stages means other cases prevented. Economically, tuberculosis appropriations are a permanent investment in State betterment. The Red Cross itself maintains two hospital beds at Hope Farm this year.
- 4. This bill is necessary and supersedes all unnecessary or only partly necessary appropriations. Substitute "small-pox" for "tuberculosis," and perhaps you will recognize the necessity in that case. But tuberculosis is a far more deadly disease than small-pox. There is little small-pox in Delaware, and only one out of four cases is fatal. There are hundreds of cases of consumption in Delaware, and almost all end fatally. This bill is of immediate necessity, and demanded for the protection of Delaware homes.

We submit all these reasons for your consideration, and are persuaded that you will admit their force and truth.
