
NOT FOR PUBLICATION COUNCIL OF NATIONAL DEFENSE WASHINGTON Woman's Committee 1814 N Street N.W. September 18, 1918. TO THE CHAIRMEN OF THE STATE DIVISIONS OF THE WOMAN'S COMMITTEE: For some time it has been apparent to the Woman's Committee of the Council of National Defense that some plan should be devised by which the war service of the whole people might be coordinated; that it is impossible to separate the work of men from that of women, and that it is illegical that the one should be sanctioned, directed, and financed by the State, while the other is sanctioned and directed by the Government at Washington, although obliged to look to the State for financial support, or failing that, to depend upon voluntary contribution from private sources. This fact has become evident in many States, where already the State Council of Defense and the State Division of the Woman's Committee have been amalgamated and now constitute one committee directing all war work in the State. This thought of joint committees of men and women formed the basis of the resolution passed by our Conference held in Washington last May, for a closer union between the State Councils of Defense and the State Divisions of the Woman's Committee; ever since which time the Woman's Committee of the Council of National Defense has been seeking such a solution as would bring about the desired result, with the least disturbance to the success of the work which has been so admirably planned and carried forward in many States. After numerous conferences between the Council of National Defense and the Woman's Committee, the following plan was unanimously approved by the Woman's Committee at its executive session in September: "That a joint committee known as the Field Division shall be created by the Council of National Defense, to be presided over by the Honorable Franklin K. Lane, Secretary of the Interior and a member of the Council. Said Division to consist of twelve members, six of whom shall be men and six women, including a Director and an Associate Director. That this Division shall have joint direction of the State Councils of Defense and the State Divisions of the Woman's Committee in their relation to the war measures of the Government; that the chief functions of the Woman's Committee and all of its departments, shall pass over to the Field Division, and the State Councils and Women's Divisions shall carry on jointly all the war work formerly conducted by both groups. In expressing its gratification at the success of its efforts toward this real and fundamental coordination, the Woman's Committee does not by any means imply that a mistake was made in the original appointment of a Woman's Committee and the organization of women thus far effected. On the contrary, it is convinced that it is only upon this foundation already laid, that a useful and effective union can be built; and that because of it the women of the State Divisions will bring to the joint committee, an organization fully equipped, with leaders and directors of their own selection, enjoying the confidence of the women of their respective States, and possessing valuable experience of the needs of the hour and the best way in which these needs can be met.

The Lesson of the Day is Union, and in a deeper sense than we have ever realized before. All the old catch-words and shop-worn phrases about cooperation and combination become quick and vital, burned into our consciousness by the fire through which we are passing and by which we are being tried. At last our soldiers are united into one body and fighting under one leader in France; our industries and our public utilities are combined into weapons of offense, not less effective than the guns which thunder so close to the German border; all of our available man power is listed and pledged, and the time is over ripe when the civilian men and women of the Nation should join hands in one vast reserve to stand invincibly back of our battle lines.

This amalgamation of two of the most highly organized federal war agencies has grown out of the need and desirability of bringing the women of the country more closely into the Government's war work and at the same time causing a more efficient guidance from Washington of the state defense activities. Already in many states the state divisions of the Woman's Committee and the State Councils of Defense have joined hands to the end of better coordinating the war service of the whole people, women as well as men. Hence the reorganization now announced follows logically the amalgamation taking place throughout the states.

From the first month of America's entry into the war the Council of National Defense, through the State Councils Section, has coordinated and guided the work of the great system made up of the State Councils of Defense, which are now organized by counties or towns in every state, with community organizations in the majority of the states. President Wilson has urged the general use of the State Defense Councils through the agency of the Council of National Defense to carry out as far as possible the local work of the federal agencies. The War Industries Board recently put the local control of building operations during the war in the hands of the State Councils.

The Woman's Committee was formed shortly after America entered the war and has performed a remarkable work in organizing the woman-power of the country for the Nation's defense. There will be merged into the Field Division the 15,732 units which the Woman's Committee has built up throughout the United States. The present amalgamation is in effect a tribute to the contribution of the Woman's Committee to the war.





To the Patriotic Women of Mississippi:

I bring you loving greetings and hearty good wishes for our great work of service to our Governent during this crisis. Never was there a time when it was so necessary that we stand together in one solid phalanx and remember that it is the "everlasting team work that counts."

Will you read carefully the "Why a Woman's Committee," and "Objects of Plan," in this little pamphlet? Also familiarize yourself with your County and Sectional Division. Attend these meetings if possible. Know your chairmen, and what Departments are represented in the Woman's Committee. The Chairman of Education is planning to have training classes in every county, so that we have an efficient force that will be a real factor for service. The business connected with these Departments will constitute the normal activities of the State Division; but when the Government, in pursuance of its plan for mobilizing the economic force of the nation, shall issue any information or instruction to the women for their co-operation, such information or instruction shall have the right of way through the State, County Chairmen and Committees, so that the intelligent co-operation of all patriotic women may be secured with the least possible delay.

OBJECTS OF THE PLAN.

The Woman's Committee of the Council National Defense was appointed April 21st, 1917, by the Council of National Defense. (The Council of National Defense was created by Act of Congress and approved August 29th, 1916. It is composed of the Secretaries of War, Navy, Interior, Agriculture. Commerce and Labor). to:

- 1. Co-ordinate and centralize the organized forces of the women of the country.
- 2. Enlist the co-operation of the unorganized women of the country, in order to—
- (a) Ascertain and report the patriotic work now being done by women and women's organizations:
- (b) Secure greater efficiency in the defense work which women may do for the Nation:
- (c) Secure the co-operation of all the women of the country in the economic measures which the Government inaugurates from time to time;

- 1. By furnishing a direct and speedy channel between the different departments of the Government and the women of the country; and
- 2. By impressing upon them the vital importance of these weapons of economic warfare in the winning of the war.

For the purpose of accomplishing these objects the Woman's Committee has organized

STATE DIVISIONS in each State of the Union, in the District of Columbia and in Alaska and Hawaii.

First Steps in County Organization of Woman's Committee Council National Defense.

- 1. Have good notice in the papers about the origin and purpose of this undertaking. (Refer to "Objects of the Plan," and make extracts from same.)
- 2. Prepare a very comprehensive list of all Women's organizations in County. Try to reach the head of every local Woman's organization, whether it has any State connection or not. Invite the heads of the Statewide organizations and of all religious (Protestant, Catholic and Jewish) and Fraternal organizations, Women's Trade Unions, social and sewing clubs, etc.
- 3. Select a date and place in the County for meeting, and send out notices a few days in advance to the executive heads of all the organizations. Have more notices in the local papers, such as the names of the organizations invited, purposes of meeting, etc.
 - 4. Call up the women invited, the morning of

the meeting, and urge them to attend as a patriotic duty; to be there when the meeting begins and to stay until it is over.

5. Make a brief patriotic talk, getting the war setting of our effort, and making the appeal to the women to do their part.

Then elect a Permanent Chairman, a Vice-Chairman, a Secretary and Treasurer.

APPOINT CHAIRMEN TO CORRESPOND TO THE STATE CHAIRMAN. (Send list to State Chairman.)

Call a meeting once a month and have reports from all officers and chairmen. Announce the date of this meeting at the organization. Write to your Sectional Vice Chairman, a State Department Chairman, or to the State Chairman, Mrs. Edward McGehee, Como, for any information. A letter from every County Chairman is expected once a month, telling of the work.

The sum of One Dollar should be assessed each organization in the County Council to defray expenses of postage, etc.

The Red Cross w.ll also raise funds to carry on relief work for the families of soldiers and sailors, who may be left in need by the mobilization of troops. To further this work and to prepare women for service with the Red Cross, it conducts classes in first aid to the injured, in elementary hygiene and home care of the s.ck, in dietetics, and in surgical dressings. The Amrican Red Cross, moreover, in the case of flood, famine or pestilence, is supposed to act in such emergency and organize the relief necessary in such disasters."

The main activities of the Woman's Committee lie entirely outside of these functions, and, therefore, there can be no overlapping or duplication of effort. The Woman's Committee is concerned, through its different Departments. with the registration of women for general service: with food production and conservation; with child welfare and industrial conditions concerning women and children; the education of women along all lines outside of the Red Cross service; with the maintenance of all existing social agencies, and the safe-guarding of the moral and spiritual forces of the Nation so that these inner defenses of our Nation may not be broken down in the period of the war. The work of these Departments to be carried on through co-operating organizations, where such exist.

The Woman's Committee is in every way sympathetic to the alms and purposes of the American Red Cross. It will urge women everywhere to join in the making of hospital supplies and garments for the civilian population in the

WHY A WOMAN'S COMMITTEE?

To the State Chairmen:

The question is often asked, "Why was it necessary to create a Woman's Committee with Government sanction, when the Red Cross, so largely concerned with women's work, already existed with the authorization of Congress and the Convention of Geneva establishing its international status?"

The answer is found in the acceptance of the fact that to the American Red Cross is assigned definite duties, the limits of which are clearly defined. The Woman's Committee is given direction of the work for women outside the field of the Red Cross. The following statement is made by Mr. Elliot Wadsworth, Chairman of the National American Red Cross:

"The American Red Cross is charged with the duty of helping to provide the troops with comforts and necessities when in the field; helping them in transit, and assisting the Army Medical Corps in taking care of the sick and wounded.
