Mayor elect: Polarized community needs to heal

Polly Sierer was elected mayor of Newark on Tuesday night, bringing to a close one of the city's most publicized and highly-charged races in re-

cent memory.

Despite rainy and cold weather conditions, a record-setting 3,695 voters cast their ballots during the day at the six polling places around Newark.

Looming large in many voters' minds was the controversy over the proposed data center and power plant on the University of Delaware's STAR Campus.

Sierer captured 1,506 votes (41 percent), and Amy Roe finished second with 1,391. Rounding out the field was Rebecca Powers at 487, Mark More-head at 148, Don DelCollo at 108, Matthew Vento at 41 and Robyn Harland

Sierer is a Christianstead resident

who serves as president of the Newark Area Welfare Committee and has volunteered around the city for more than two decades. She was endorsed by many in the business community and several veterans of city politics, including former mayor Vance A. Funk III and Deputy Mayor Jerry Clifton. Sierer said Tuesday night she is excited to be Newark's mayor and is

Fire guts Newark townhome, kills dog

Fire ripped through a townhouse in the Williamsburg Village neighborhood Monday night, gutting one home and killing a family pet.

The blaze broke out at 7:56 p.m. in the 200 block of King William Street, according to John H. Farrell IV, a spokesman for Aetna Hose Hook and Ladder Co.

Editor's note: Volunteers at the Pencader Heritage Museum have been digitizing old Newark City Council meeting minutes. They share excerpts with Newark Post readers in a weekly column.

June 1880: gutters were ordered cleaned in front of the Misses Motherwell's and the bridge at Lewis' to be repaired immediately; Theo Armstrong notified not to block the sidewalk while unloading wagons.

October brought a dispute as paving began in front of the Wright and Pilling properties. Mr. Pilling claimed Main Street should be 40 feet wide. A committee sent to the courthouse in New Castle would find no reference concerning street width. Choate Street was graveled and a crossing ordered on Chapel Street near Jacob

Kurtz's shoe shop.

Town charter changes were being considered: town financial statement to be published and a town voter had to be current on taxes

The 1881 board consisted of J. H. Williamson, John R. Hill, James Hossinger, Joseph B. Lutton, George Williams. Peter Legates was appointed town bailiff, provided he move into town limits

Edward Wilson contracted to provide stone from his quarry at 35 cents per 2-horse cart load delivered to the streets. John Pemberton was approached concerning the "awful stench constantly arising from his slaughterhouse.' George Lindsey was paid \$4 cash for Newark shinplasters

from Neil Walls. (Note: Shinplaster was slang for any paper money worth less than one dollar. Samples can be seen at Pencader Museum.)

The Delaware legislature passed a law stating towns should set up boards of health. Those appointed to Newark's board were Dr. C. Henry, Theo Armstrong, D. W. Caskey, Samuel J.







PAC spent \$45,000 promoting Sierer

Mayor elect disavows group

Documents released late Monday afternoon reveal that a political action committee supporting Polly Sierer is funded by Delaware Jobs Now, the group that has been a leader in supporting the proposed data center and power plant project slated for the University of Delaware's STAR Campus.

The group is the PAC's sole donor, providing \$45,000, which was used in part to create the website ILikePollys-Plan.com and distribute fliers in Newark, both by mail and in person.

The pamphlets include a photo of Sierer with former mayor Vance A. Funk III and promote "Polly's plan," which the fliers claim will bring thousands of jobs to Newark and "diversify the City's tax base like the STAR Campus."

Sierer has disavowed the group's actions.

A filing with the state election department shows that the PAC's chairman is Vince D'Anna, a real estate agent from the Evergreen neighborhood of Newark. D'Anna also donated \$100 to Sierer's official campaign, which the mayor elect said will be returned.

According to the documents, Delaware Jobs Now is in care of Delawareans for Environmental and Economic Development, which is described on its website as "a unique coalition of Delaware labor and business leaders" that "have in common [a] belief that economic growth and environmental protection are not mutually exclusive."

The group lists as its contact information a phone number for Richard Heffron, interim president of the Delaware State Chamber of Commerce. Among its founding board members is Andrew Lubin, UD's real estate director, who is responsible for the development of the STAR Campus.

Delaware Jobs Now and its website, delawarejobsnow.org, voice support for the proposed data center and power plant, and the group has distributed leaflets door-to-door advocating for the project.

In both an interview Monday and a statement issued

demned the PAC.

"I value transparency and have high ethical standards, which makes the actions of whomever is behind this very disappointing to me. Let me be clear. This is from an outside group and was done without my knowledge, approval, or involvement." Sierer said.

"If I can send a message to whomever is orchestrating this, it is to stop. Information has been lifted from my campaign materials and is being used out of context, which is disrespectful to me and, more importantly, to the residents of Newark who are trying to educate themselves before they head to the polls Tuesday," she continued.

She reiterated those comments after the election.

"I'm thoroughly upset and disappointed that this has even entered the city of Newark election," Sierer said. "It's not acceptable, I will investigate it and I will find out how it occurred and make sure those folks don't let this happen

again."
"If there were things done illegally, I will be looking at hir-ing an attorney," she added. Sierer would not comment

on whether the PAC's literature accurately describes her

"I'm not going to get into specifics," she said Monday.

The source of the PAC's funding was unknown until Monday, when former city councilman Ezra Temko filed a complaint against the PAC, arguing in his letter to Election Commissioner Elaine Manlove that the group is violating state law by not disclosing its

"When there's big money trying to influence a local election, the voters deserve to know where that money is coming from," said Temko, who endorsed Rebecca Powers for mayor.

He filed the complaint under the Delaware Elections Disclosure Act, passed in 2012, which requires that third parties that spend \$500 or more on campaign advertisements disclose their donors within 24 hours.

Manlove said her office spoke to someone affiliated with the PAC and that person agreed to submit the required paperwork.

Michael Mullen, of Cambridge Drive. In 2008, Mullen ran for city council, losing to Temko.

The phone number listed on the PAC registration matches the cell phone number Mullen used in 2008, but was not in service Monday afternoon.
Sierer said Monday that she

does not know Mullen and has not spoken to him.

Mullen is listed as a co-host of a fundraiser for Sierer, according to an invitation emailed to Sierer supporters by Bob Ashby. The fundraiser was held Friday at The Deer Park Tavern.

Sierer said the fundraiser was organized by a group of business owners and, although she attended, she did not talk to Mullen.

Funk is also listed as a host of the fundraiser, but said Monday that his name was included without his knowledge.

Funk, who endorsed Sierer, said that he agreed to pose for photos for Sierer's campaign literature but was not aware of the PAC

Maryland man gets 50 years in prison for Newark-area shootings

A Maryland man who committed a pair of shootings in the Newark area in 2011 received a 50year prison sentence last

Superior Court Judge Charles H. Toliver IV imposed the sentence on Alan Lee Fowler, 23, of Elkton, prosecutors said, noting that they had asked the judge to sentence Fowler to 100 years.

Fowler stood convicted of two counts each of attempted murder and reckless endangerment, guilty verdicts returned by a jury after a trial in May, prosecutors said. But the judge dismissed one of those attempted murder convictions at sentencing, opining that evidence of Fowler's intent was lacking, prosecutors added.

"He's a menace," Dep-uty Attorney General Jamie McCloskey said Tuesday. "The shootings he did here resemble the shootings he did in Maryland. It's what he does; he gets angry and he grabs a

"It's so fortunate that he didn't kill somebody. This could very easily have been a first-degree murder case," McCloskey

The first occurred on July 2, 2011, after Fowler and an acquaintance had a heated argument over woman and, before hanging up their phones, agreed to meet for a fistfight to settle the dispute.

Fowler arrived at the predetermined spot, outside a home in Robscott Manor, where he saw his rival and other people on the front porch. midnight on July 31, 2011, when he was stabbed during a fight at the Deer Park Tavern on Main Street.

An irate Fowler went to a home on Martindale Drive in Brookside at about 4 a.m., some three hours after the stab-bing, erroneously believing it was the address of his brother's assailant. his intended target had

moved out of the house months earlier, however, and that a woman and her two children - a son, 4, and a daughter, 10 - had moved into the place.

After Fowler and an unidentified man failed to kick open the door, he fired 12 to 15 rounds at the front of the house. Two of those bullets ripped through the house and hit the mother in the leg and arm as she slept in a front bedroom.

The woman's two children were sleeping in that same room but they were not struck by the bullets, although one struck near the head of one child.

Fowler, who had fled to Florida in the wake of his second shooting, was arrested after he returned to this area in August 2011.

This marks the third time that Fowler has been sentenced for shootingrelated convictions, with the first two occurring in Cecil County Circuit Fowler was unaware that Court in August and October 2009 when he re-

30-month terms.

In one of those cases, Fowler stood accused of firing three 9mm bullets into the passenger side of Honda Civic occupied by a 20-year-old man in Elkton. Two of the bullets struck the Honda's door while the third struck the victim's hand.

Police later charged Fowler and his older brother, Kenneth Wayne Fowler, then 25 — the same brother Alan Fowler wanted to avenge in his ill-planned shooting in Brookside in 2011.

The other Cecil County case stems from a December 2008 incident in which Fowler stood accused of firing gunshots from his passenger seat in a moving 2002 Honda Accord near North East.

Both of Alan Fowler's shootings in Cecil County related to a feud between the victim in the December 2008 shooting and his friends and the Fowler brothers, police reported at the time.



Rookie head coach Dave Brock preached from the day he was hired that the Blue Hens wanted to play meaningful football games in November.

Well, they did in 2013. But, unfortunately, Delaware (7-5, 4-4 CAA) lost all three of them as fans watched what was once a somewhat promising season before daylight saving time, have the lights go out on it during a three-game stretch over a period of 15

The Hens' playoff chances were slim going into the Villanova game. And then Saturday's epic fourth-quarter collapse at PPL Park sealed the team's fate. The loss was the secondworst fourth-quarter collapse in team history, top-ping only the Hens' 36-33 loss to Villanova in 1969. The Hens led 33-7 in that

Delaware misses the playoffs for the third consecutive season, marking a three-year drought not suffered since 1983-85.

"Certainly a disappointing end to the season," Brock said in his opening statement at Monday's press luncheon. "We had put ourselves in position to play meaningful games

and weren't able win those games and put ourselves in the postseason, which is where, ultimately, Delaware belongs.

It was a bitter ending to a season that started with cautious optimism under the new regime.

After going an expected 3-1 through the first four games of the season - all three wins were against teams that finished with losing records, the loss to BCS Navy — the Hens' 29-22 come-from-behind win against then-No. 14 James Madison gave fans hope that maybe Brock would lead UD back to the playoffs for the first time since

But a blowout loss at Maine the following week quickly brought even the most optimistic supporters back to earth. And if that didn't, the nail-biting, last-second home win over Albany (1-11) the following week did.

The Hens took care of business in Rhode Island, picking up their first win in New England in what seemed like since the May-flower landed. The Hens then traveled to Towson and pulled off the biggest fourth-quarter comeback in school history, rallying from a 21-point deficit to upset the seventh-ranked



"[When I came here] I gave the players my word that I would do things a certain way [for a year]," Brock said. "I kept my word. ... That year is up. And now we are going to go about the business of starting an offseason program. The way we are going to do it, we are going to implement some things that will be different than they were last year."

Brock has preached all season long about the need to establish depth at every position, stating that the roster is "out of balance," including having just two scholarship running backs on going into the 2014 spring practice and UD having only recruited two defensive backs from 2010-

"There is nothing going on [in this program] that recruiting can't fix," he said. "At [the University of Delaware], you should be able to attract a top-level student, a top-level football player, and a top-level per-

son from the high school ranks.'


Brock refused to pin the shortcomings of this year's team on one particular unit, instead reverting back to the issue of player develop-

Cooperative Extension: For next year's garden, consider edible plants

It's time to put your garden to bed, enjoy the holiday season and start planning for

Amidst blustery winds, cold temperatures and potentially snow-covered landscapes, spend the quiet winter months planning to improve your garden. Be prepared in late winter and early spring, when the snow slowly melts away to reveal the early growth of bulbs, perennial plants and the eventual blooms of flowering trees and shrubs, to work effectively in your garden.

Spring will welcome warm

forever new products and plant selections. Have a well thought-out plan in hand as you venture outside, and take advantage of local plant sales like those at Ag Day, on the College of Agriculture and Natural Resources' campus, to select plants appropriately.

This year, while shopping, consider edible plants. Edible plants are multifunctional; they are attractive, and at the same time, produce fruits and vegetables for your use. Take a look at your landscape; do you already have edible plants? Fruit trees? Black walnut, serviceberry, or paw-paw trees? Blueberry or choke-berry shrubs? Raspberries weather and a flurry of berry shrubs? Raspberries gardening excitement with or blackberries? Your gar-

den may already offer more than you've realized. Identify what you have, and then add more.

Use edible plants in a variety of ways. Designate a space solely for growing edible plants, like a vegetable garden or a berry patch. Inter-plant your ornamental garden with attractive edible plants. For example, try inter-planting your or-namental garden beds with attractive, low-maintenance, and reliable vegetables and herbs. Herbs like dill, basil, oregano and rosemary are attractive and also tend to attract important beneficial insects to the garden to help discourage insect pests.

Greens like collards, kale, lettuce and chards are easily tucked into an ornamental garden, and have a variety of colors, textures, and forms. Vining varieties of edible plants like peas, beans, cucumbers and tomatoes can grow vertically, with sup-port, in an ornamental gar-

Depending on the vigor of the plant, you might decide to use the support of strong ornamental plants, allowing the vines to carefully grow up and throughout, and produce fruit in your garden. Or, use containers. For example, brightly-colored sweet peppers grow well, and provide pizzazz, in containers on your back porch, while the colorful blooms and fragrant foliage of herbs are easily incorporated into

any design.

Containers can be fun and provide a lot of flexibility; however, be particularly careful to choose and plant more compact varieties (often labeled as well-suited for container growing) and place your containers, on your stoop, porch, deck, or in the garden, where they'll receive enough sunlight and have easy access to water. Containers do dry out quickly and require slightly more attention.



W.L. Gore to invest \$6.3 million in vacant property

By CHERYL MATTIX Special to the Post

W.L. Gore & Associates, Inc., is in the midst of investing \$6.3 million in renovations to an uncompleted building in Elkton, Md., just over the state line.

The building shell is at 101 Lovett Drive off of Elkton Road. It was built in 1997 but never occupied, according to Jenny Maher, a spokeswoman for the Newarkbased company.

The project is the first phase of a three-phase plant expansion for the company's core Polytetrafluoroethylene (PTFE) technology manufacturing process, which is used in all of Gore's products. The main manufacturing plant is currently located nearby off of Airport Road in Elkton.

Maher said the company will be moving some employees from existing plants to the newly renovated hub, and eventually, over the five-year, three-phase build out, may hire more employees.

"There are no immediate plans to hire more employees though," Maher clarified.

The company has already started renovations to 121,000 square feet of the 233,000 square-foot building. It hopes to complete construction in January and move into the building in 2014, Maher

Gore has applied for tax credits from the Cecil County govern-

The property is located in one of the county's enterprise zones, which makes it eligible for tax

If approved, Gore would receive an abatement on the difference between the current assessment on the empty building and the new assessment after improvements have been made.

The abatement is 80 percent for the first five years and decreases after that by 10 percent a year each year until it ends in year 10.




Through talking with participants at Saturday's food drive Miller said he's noticed the face of needy has certainly changed.
