

Council approves apartment additions

More units to be added to Pomeroy Station, Madeline Crossing

On Monday night, city council gave a developer the go-ahead to add apartments onto the existing buildings at Pomeroy Station on East Main Street and Madeline Crossing on South Main Street.

Jeff Lang, of Lang Development Group, asked that council allow 1.84 acres currently occupied by a portion of the Pomeroy Station parking lot to be turned into a three-story building containing four three-bedroom townhouse-style apartments with parking underneath.

Council unanimously voted in favor of the project, and the new apartments will be added to the side of the existing Pomeroy Station

"It was cold and it was wet and he was shaking, but he wouldn't leave the sidelines," Simpson recalled. "He was still trying to dry off the balls and get them in.

Of course, Simpson wasn't surprised.

Nearing age 90 at the time, Clarence "Shorty" Yoder had volunteered to hold the down markers and manage the footballs during Yellowjacket games for more than 40 years. But more than that, Shorty was the team's unofficial mascot, its good luck charm and its "heartbeat," as Simpson termed it.

Shorty was a fixture on the sidelines until last season when health problems relegated him to the bleachers.

In July, he died at the age of miming throwing penalty flags. 92. His family buried him in his signature referee uniform that he wore during games while signaling touchdowns and

At Newark's first game of the season last Friday, the Yellowjackets paid tribute to Shorty in a pre-game ceremony. The players presented a No. 1 jersey to Shorty's wife, Lois, and his children, and the family accompanied the captains to midfield for the coin toss.

As the P.A. announcer introduced the tribute and called "Newark's greatest Shorty fan," a hush came over the crowd.

"When that place went silent, I couldn't believe how quiet it was and the respect they were giving him," Shorty's youngest son, Matthew Yoder, said. "Having the coach do what he did for us and for my dad, words can't do it justice.

Born in Windber, Pa., in 1922, Shorty served in the 83rd Infantry during World War II and earned two Purple Hearts. When he was in his 20s, he moved to Newark, where he found work as a custodian at the University of Delaware.

For many years, Shorty lived in George Read Village, just across Delaware Avenue from Newark High, where all four of his children attended school.

"He just loved this school and loved this team," Yoder said. "The team took to him like a mascot almost. He was their unofficial good luck charm.

Shorty never played football himself, Yoder noted.

"He earned the name Shorty - we could use his head as an arm rest," he said. "He was not a football player. I think he lived vicariously through them."

Shorty's involvement with the Yellowjackets pre-dated even the venerable Coach Simpson.

"Me and the short guy rode the bus together to every away game for 38 years," Simpson said. "The family would call me and ask what time the bus

is leaving. They'd drop Shorty off because even though they were going to the game, he insisted upon riding the bus. And that was fine with me."

Shorty was with the team during its good times - like the back-to-back state championships in the late '90s and early 2000s - and the bad times like 2012, when the team went 1-9. But he never stopped smiling and encouraging the play-

"I don't know that there was anybody else who was more upbeat in life than Shorty," Simpson said. "It was always smile and a good feeling. He made you feel good to be around him and never seemed to have a bad day. I don't even know if he had bad moments.

"You feel blessed that he lived to be 92. We'd all love to have Shorty's life in the big picture.



Police are looking into a break-in that occurred last week at a home on South College Avenue, officers say.

Teens arrested in beating of mentally disabled man

Incident was recorded, posted on social media

Newark-area teens have been arrested in connection to the beating of a mentally disabled man that was recorded and posted to social me-

The victim was a 26-yearold man who has a neurodevelopmental disorder, said Ofc. Tracey Duffy, a spokeswoman for the New Castle County Police De-

partment.
Police believe the videos, which drew attention over the weekend after being posted to Instagram and YouTube, were filmed several weeks ago.

One of the videos, which appears to have been shot outside the Harbor Club Apartments on Cheswold Boulevard, east of Newark, shows a group of at least five teens throwing

the man to the ground and repeatedly punching him.
A second video depicts

another attack in a wooded area.

The first two teens were arrested Saturday at NC-CPD headquarters. One is a 14-year-old boy from the unit block of Kollman Drive in Brookside. The other is a 13-year-old boy from Pride Courts Apartments on Red Mill Road. Police did not release their names.

The third, a 14-year-old boy who lives in the unit block of Patrick Henry Court in the Cherry Hill Manor neighborhood of Newark, turned himself in Monday, police said.

All three teens were charged with offensive touching, assault of a vulnerable adult and thirddegree conspiracy.

The teens were released on bail and ordered not to have contact with the vic-

Police say the victim was treated and released from the hospital.





Mandated by 29 Delaware Code, §8409, the hearings are designed to ensure that the public has ample opportunity to participate in the planning process. The Council on Transportation is composed of citizen representatives from each county in the state. Members are appointed by the Governor.

The meeting locations are accessible to persons having disabilities. Any person having special needs or requiring special aid, such as an interpreter for the hearing impaired, is requested to contact DelDOT by phone or mail one week in advance of the planned event. Don't forget the warm-up

Someone once told me that if you don't like it, then you probably actually need it.

While this is not true for everything - like eating liver, cleaning the house or doing laundry - it is almost always true when it comes to a proper fitness

Think about it for a minute. When it comes to exercise, what do you normally do? Stretch a little bit, maybe do a couple jumping jacks and then, bam!

You start your workout. Unfortunately, a proper warm-up is something that people often avoid when it comes to fitness. There are plenty of reasons why - maybe they don't know how to properly warm up, they don't think it's important, they are limited on the amount of time they have or perhaps they don't enjoy it. I know when I am crunched for time the warm up is the last thing on my mind.

But exercising without warming up is like brushing your teeth without toothpaste. You go through the motions but forget the most important part. (And you wonder why nobody at work wants to talk to you?)

Let's take a look at some of the reasons people should make the time and effort - to warm up before they exercise. Here's what happens when vou warm up:

1. It increases your body temperature.

2. It activates your nervous system. 3. Your range of motion increases.

4. It helps correct any limitations.

These seem like pretty important things when it comes to exercise, wouldn't you say? Something as simple as warming up can help reduce the risk of injury and help provide better

So what's the best way to do it? You should know the warm up has changed over the years. In the past, trainers would tell you to jump on a treadmill for five minutes. That is not enough to get your body ready for a workout.

A proper warm up should last 10 to 15 minutes and should leave you hot and sweaty. For some people, the warm up we perform with clients could be the entire workout.

Here's a warm up to try the next time you exercise. Aim for about 30 seconds of each exercise in a row and repeat

1. Jumping jacks

Alternating reverse lunges

3. Pushups

Bird dogs

5. Planks

6. Alternating knee grabs

Squats

8. Inchworms

Spending the extra time before a workout will help prevent injury over the years, keeping you in the game longer. I always tell my clients if you are injured, you cannot achieve results.

Out of the Attic

Map of Newark — 1858


This week's Out of the Attic item is a map of Newark from 1858 showing a village that had grown over two centuries along a road between the Delaware and Susquehanna rivers, today's Route 273.

Most settlers raised crops or cattle, some mined iron or clay and some provided services to support the farmers, miners, and others. At least 12 grist or sawmills were in the area. Trades-men clustered their homes and shops along the road. The area reflected the lifestyles and customs brought from their homelands by the Scotch, Welsh, English, Dutch, German and other immigrants.

Orienting the map as it is pictured here, west is to the top, east is to the bottom, north is to the right and south is to the left.

Let's take a walking tour through town starting at the east edge.

On our right is the Village Presbyterian Church built in 1843. The cross street is Chapel Street (not named for the Village Church but for the Methodist Chapel that was further north from 1811 to 1851). As we stroll west on Newark Street (as it was once called) we pass a hotel on the right and another hotel on the left. This second one was the Washington House Hotel (1825-2006) built on the site of the Market authorized by King George II in 1758. Next door is the 1840 Newark Academy brick building erected replacing frame. In 1842 a separate dormitory was built.



come to the Methodist Episcopal Church on the left (1851 to date) and next door is the Odd Fellows Lodge hall (1850 to date). A walkway to the left leads to the First Presbyterian Church (1843 to 1872) The little building sitting out from the church was the first one room public school (1831-1884). At the intersection (Depot Road) is a third hotel. Across the corner is Newark College that opened in 1834 and later became Delaware College, and then the University of Delaware (1921 to date). At the threeway intersection, the build- 19715-0711.

ing to the right is our fourth to date) built to replace St. Patrick's Inn (1747-1848).

Learn more at the Newark History Museum located on South College Avenue beside the bridge. It is open Sundays from 2 to 5 now through November. 
