In obedience to Section 5 of the Act of the General Assembly, providing a Public Lands Commission for the State of Dela-

ware, passed at Dover, 1913, I have the honor to report as follows:

During the two years ending January 1, 1925 your Commission held five meetings, most of them being held in the Public Lands at Rehoboth.

Eleven lots were sold at "Indian Beach" in 1924, ten of them to John Wedderburn and one to Laura A. and Edward R. Messick, each paying Forty Dollars (\$40.00) each for the said lots, which monies, the sum of Four Hundred and Forty Dollars (\$440.00), deposited with other monies of the Commission in the Delaware Trust Company at Lewes, Delaware. The sum now in deposit in the said Bank is \$3,316.47 as per certificate of Joseph L. Marshall, Manager of said Company, which is hereto attached.

The Commission respectfully calls your attention to its recommendations in its report to the General Assembly of 1923 as to the natural oyster beds in Asawaman Bay, and also to the violation of the Laws of this State making all Public Lands and Waters in the State bird sanctuaries.

My Dear Governor:

I thank you for your courteous letter of the 17th instant in response to my telegram of the 15th.

I wish to emphasize the importance of the coming Sesquicentennial of American Independence, not alone from its patriotic aspect, but from the educational, commercial, religious, scientific and historical viewpoints, and to call your attention to the fact that a duly authorized commission from the State of New Jersey today announced that that great commonwealth would spend the sum of \$100,000 for the erection on the exposition site of a replica of the British Barracks Building captured by General Washington during the battle of Trenton.

I am attaching hereto a copy of the tentative ground plan for the Exposition, the details of which are now being worked out. The Stadium as you see, occupying the south center of the plan, will have a seating capacity of 100,000 persons, and will be the scene of many great historical pageants, religious festivals, orchestral, band and singing concerts, international and national athletic contests. North of the Stadium is the proposed Industrial Arts Pavilion, with an exhibit capacity of two million square feet of space, in which will be housed some of the greatest commercial and scientific exhibits of modern times. The section to the west of the buildings just described is devoted entirely to foreign governments and the governments of the various states of our Union. The northern half of the eastern section will be devoted to wholesome amusement devices designed for the entertainment of visitors, while the southern half has been reserved for such great exhibits as the development of radio, wireless, telegraphy, electrical progress, the steel and other great industries.

We had proposed, and it has received the approval of President Coolidge, to invite units of the navies of the world to anchor in the Delaware all during the life of the Exposition and up to the present writing we have secured more than 160 conventions of national organizations to be held during the period of the celebration in and about the Exposition.

It is intended to open the Exposition on Flag Day, June 14, 1926, and to close on November 1st of the same year, and we want to set apart the most appropriate day during that period as Delaware Day, and in this connection we cordially invite you, as chief executive of that great State, to be present as a guest of the City of Philadelphia, to deliver an address to the thousands of Delawareans who will undoubtedly be here at that time.

It is certain now that June 14th, 1926, will find a greater number of foreign countries represented at the Sesquicentennial of American Independence than has ever before been gathèred at an Exposition, a fact which the State governments cannot afford to overlook.

The State of Delaware, if for no other reason than a purely commercial one, should erect a pavillion at our Exposition to be used to house the two members of your State comprising the Advisory Committee, as a meeting place for Delaware citizens, and for an extensive exhibit of Delaware's resources and chief industries.

This celebration of the 150th anniversary of our Nation is a patriotic duty as well as a commercial necessity, and I am confident that Delaware will want to be fittingly represented.

Thanking you for your efforts in helping us to make this the greatest patriotic event in the history of the United States.
