## JOB DRIVE FOR STATE'S DISABLED TO START OCT. 5

### "Employ The Handicapped Week" Plans Are Listed

Every club, organization, veterans' group, church and individual in this area has a responsibility as an American citizen during the week of October 5-11, it was pointed out today. The 7-day period has been proclaimed by President Truman and Governor Walter W. Bacon as "Employ the Handicapped Week."

Its two-fold purpose in Delaware was disclosed yesterday in a statement by the Governor's committee. "First, employers are urged to hire handicapped persons wherever possible, as they have done so admirably in the past."

Second, and perhaps even more important, all groups and individuals are asked to refer to U. S. Employment Service offices or to the Vocational Rehabilitation Clinics of the State Board for Vocational Education, all persons with disabilities.

"Send to either of the offices the names of such individuals; for, if they cannot come to us, we will go to them," said Albert Stetser, chairman of the Governor's committee for "Employ the Handicapped Week."

Working with Mr. Stetser are representatives of more than a dozen state agencies, such as the American Legion, Veterans of Foreign Wars, Disabled American Veterans, Veterans Administration, newspapers, radio, and motion picture theatres, and the Chamber of Commerce.

Throughout the week, efforts will be made to acquaint every citizen of Delaware with the story of handicapped persons. Little known fact is that men and women do not have to remain objects of charity or family care and pity.

"Every handicapped person can be placed in some kind of job to fit his or her ability; it isn't what's missing that matters—it's what is left that counts," a spokesman for the committee asserted.

Medical and surgical treatment may be needed in some cases; hospitalization in others; artificial appliances can make a world of difference in a few instances; and as for the rest, training and guidance into fields of activity which the disabled can do as well as the whole person, plus selective placement into industry, office or home work projects, is a year-round program in Delaware to restore the handicapped person to a paid job and independence.

Many Delaware employers have established excellent records for employing disabled men and women, it was pointed out, and throughout the week of October 5-11 they will be asked to extend this program even more.

However, unless the disabled and handicapped person can be found and helped to overcome the handicap and ready himself for satisfactory employment, the first phase of the week's program will be unsuccessful, it was pointed out.

To prevent this, clinics will be held throughout the state during the week by the Vocational Rehabilitation Division to seek out, advise and guide the disabled to independence and jobs.

In the New Castle County area, such a clinic will be open to all handicapped seeking information and help at the Rehabilitation Center, 11 Concord Avenue, in Wilmington, each day from 10 a. m. to 4 p. m. from October 6 to October 10 inclusive.

## RECTOR TO LEAVE SOON

The Rev. William Henry Hanckel will conduct his last service as rector of St. Thomas Episcopal Church this Sunday. Next week he will leave to assume his new duties as assistant rector of St. James the Less Episcopal Church in Scarsdale, N. Y.

Mr. Hanckel has scheduled the usual order of services for this Sunday, beginning with Holy Communion at 8 a. m., followed by Church School at 9 a. m. and concluding with Morning Prayer and Sermon at 11 a. m. Nursery Kindergarten will be held at the latter hour.

No successor for Mr. Hanckel has been selected as yet. Dr. J. F. Daugherty, senior warden of the Vestry, said this week. But, despite the lack of a full-time rector, a full schedule of services will be offered each Sunday at St. Thomas, with guest ministers assisting.

Additional grandstands were ready for the crowds for the event which is growing in popularity every year. A new and larger ring, offering a greater challenge to the skill of the riders, was also in use for the first time.

### Advanced Sale At Box Office For Members Set For Tomorrow and Sat.

The rollicking farce, "Room Service," rings up the curtain for the 1947-48 season of the University Drama Group. The play will be presented in Mitchell Hall at 8:15 on two nights—Thursday, October 9th, and Friday, October 10th.

## TO ELIMINATE 4:41 P. M. STOP BY B.&O. HERE

### New Schedule Is Effective This Sunday

The southbound Baltimore and Ohio train stop here at 4:41 p. m. standard time daily will be discontinued effective this Sunday.

Elimination of the stop was disclosed this week with the publication of the new schedule which goes into effect with the resumption of Standard Time this Sunday.

The stop is being discontinued in order to step up service on the train through to St. Louis, officials said.

Commuters from Wilmington will be offered two trains to Newark: The 2:40, which arrives in Newark at 2:54 and the 9:12 which arrives at 9:25, both on standard time.

The new westbound schedule from Wilmington through Newark beginning Sept. 23 will have the following trains: Wilmington, 8:30 a. m. arriving Newark, 8:43 a. m.; 9:50 a. m., arriving 10:03 a. m.; 2:40 p. m., arriving 2:54 p. m., and 9:12 p. m., arriving 9:25 p. m.

At the present time, the following schedule is in effect: Wilmington, 7:30 a. m., arriving Newark, 7:45; 1:45 p. m. from Wilmington arriving 2:09; 4:27 p. m. arriving Newark, 4:41 (the through train to St. Louis which will cancel its Newark stop) and 9:12 p. m., arriving 9:25 p. m.

The eastbound schedule from Newark to Wilmington will have one new stop when daylight time ends. The new listings will be: Newark, 8:46 a. m., arriving Wilmington 9 a. m.; 12:24 p. m., arriving Wilmington 1:38 p. m.; 6:39 p. m., arriving in Wilmington 6:53 p. m., and the 8:19 p. m. from Newark, arriving in Wilmington at 8:33 p. m.

## Lions Hear First-Hand Facts On A-Bomb Damage

A vivid picture of the damage caused by U. S. bombs in Japan during the latter part of the war was drawn by Russell Ames, DuPont engineer, in a talk at the Newark Lions Club on Monday night.

Mr. Ames recently returned from a inspection tour of Japanese cities, including Nagasaki and Hiroshima, where the atomic bombs fell. Pin-point bombing by night flights was often ineffective, the evidence shows, he said, but the atomic bombs caused indescribable devastation.

The death toll at Nagasaki was 35,000 with 35,000 injured, he said, while at Hiroshima 70,000 were killed and 70,000 injured.

## UNFINISHED REPAIRS AT NHS TOTAL OVER \$9000

### Some Work Still To Be Completed, Board Hears At September Meet

The delayed repair program at the Newark High School has cost \$9,342.95 to date with some work still uncompleted, Supt. Wilmer E. Shue reported at the September meeting of the Newark School Board last week. Total cost of the broad-scale project, which covers repairs delayed through the war period, will be around \$12,500, he said.

Tax receipts for August from the local district amounted to \$6,747.59, it was further reported.

Principal item of business at the session was the authorization of funds for new equipment in the Home Economics Department. A refrigerator, an electric stove and washer will be purchased to aid the training of girls in home-making.

The board was also informed that the Modern Dance Group at the high school has been invited to perform at the fall meeting of the Delaware State Education Association in P. S. duPont High School on October 9 and 10. The board agreed to provide funds for bus transportation for the group.

Voting delegates from the local faculty to the DSEA parley will be selected at a staff meeting here today. The faculty will also choose a steering committee, which will aid directly in the school administration.

Two new faculty appointments were also approved by the board at its September session. Gilmore Ott, graduate of Shippenberg State Teachers College and an Air Corps veteran, who formerly taught at Mechanicsburg, Pa., High School, was named science instructor. Miss Esther Fenton, graduate of West Chester State Teachers College with teaching experience in Lebanon County, was appointed elementary music supervisor.

## APPEAL FOR FUNDS MADE IN DRIVE FOR GERM LAMPS

### Campaign Launched Year Ago Still Far Short Of Goal

A renewed appeal for contributions in the drive to purchase germicidal lamps for installation in the Delaware Avenue school building here was issued this week by Earl Wyatt, chairman.

The lamps, which resemble ordinary fluorescent tubes but which emit ultraviolet rays designed to sterilize the atmosphere and curb the spread of colds and other airborne infections, will be installed as soon as sufficient funds are secured, Mr. Wyatt said.

Plans call for placing the lamps in all eight classrooms as well as the corridors of the Delaware Avenue building.

A total of \$309.10 has been raised to date toward the estimated \$800 needed for their purchase. At the start of the fund drive last year it was estimated that a \$4 contribution from every family with children attending the local schools would cover the cost. To date, exactly fifty-eight residents have contributed.

Officials hope to install the device before cold weather brings on the annual epidemic of colds among the younger school children. Figures show that student absence due to colds is greatly reduced in schools where the lamps have been placed in operation. A P-T-A. committee, appointed to study the effectiveness of the devices, has recommended after considerable investigation that they be installed here.

Contributions should be mailed or brought to the School Offices, attention Supt. Wilmer E. Shue, who will pass the funds over to Donald Armstrong, treasurer of the drive. George Haney is also assisting Mr. Wyatt in the campaign.

Jack Lacher, president, presided, and made an appeal for contributions towards purchase of the germicidal lamps proposed for the Delaware Avenue building. Dr. A. P. Colburn was program chairman and announced that the next meeting of the P-T-A. has been scheduled for Thursday, October 16.

Highlighting of the meeting were informal discussions among parents and teachers on school problems. The elementary teachers were stationed in their classrooms where they talked with parents. High school instructors remained in the auditorium for interviews with parents. Refreshments were served in the school cafeteria by a committee of parents. Mrs. Doughty's third grade was awarded a prize for the highest percentage of parents in attendance at the meeting.

The elementary school is leading in the current P-T-A. membership drive, it was announced by Miss Mary Melvin, chairman. Mrs. Laura Nichols' sixth grade heads the list with 43 parents enrolled, and Mrs. H. L. Miller's sixth grade is second with 41 new members.

In the junior-senior high school, Miss Ann Stauters group of seniors is leading with 16 members, and Miss Ann Gallagher's class is second with 11. In the Delaware Avenue building, Mrs. John Justin's grade one leads with 44 new members, followed by Mrs. Frederick Spasato's grade two with 42.

Approximately 57,000 bushels of seed oysters were taken from Delaware Bay in the 35-day season set aside by the Delaware Commission of Shell Fisheries from May 1 to June 6, and approximately 75 per cent of these oysters were planted in Delaware Bay oyster-bed areas, according to the commission's annual report submitted to Gov. Walter W. Bacon.

The report also stated that the commission believes that the work done on Flogger Bed last year, along with certain restrictions made by the commission, will result in an at least 25 per cent improvement in the condition of the beds at the season's opening next year.

The commission's report mentioned the purchase of 25,000 bushels of oyster shells to be planted in the bay to catch growth of small oysters, and planting of 150,000 bushels of oysters in Rehoboth Bay during the past year. The report said that unfavorable weather conditions caused a high salinity in the water of Rehoboth Bay, making feeding conditions unfavorable for the oysters, and causing a great deal of oyster growth.

## HOME FOODS PRESERVING TEST OPENS

### All Women Of State Eligible For Contest

Entry blanks are now available to Delaware homemakers wishing to enter the 1947 Home Food Preservation Contest.

The contest, sponsored nationally by the National Garden Institute and accepted in Delaware by the State Board of Agriculture, is open to any homemaker in the state who has preserved food for home use since January 1, 1947. A silver pitcher will be awarded to the homemaker whom the judges select as 1947 Food Preservation Champion. The award will be based upon the quantity of food preserved, quality and appearance of food, variety of food processed adequately for family needs and type of storage space provided for preserved foods.

This contest gives recognition to the Delaware woman who has done an outstanding job of preserving foods for family use during the winter months. With food prices currently higher, homemakers who have access to fresh fruits and vegetables in season realize the value of home preserved foods to insure an adequate year-round diet.

Mrs. John A. Redding, Newark, who was named State food preservation champion in 1946, preserved a total of 46 quarts and 1,244 pounds of food for home use.

This year's contest closes October 31. Entry blanks may be obtained from the Extension offices in Georgetown, Dover and Newark; the canning center at Caesar Rodney High School; Miss Mary Davenport, nutritionist for the State Board of Health, Dover; Miss Emily King, supervisor of Vocational Education, Dover; Mrs. Lula B. Wilson, home economics chairman, Delaware State College; Mrs. Wilbur Jump, representative of the Delaware Power and Light Company; and Mrs. Ethel Hunter, home economist for the Delaware Power and Light Company.

## DELAWARE FARM FRONT THIS WEEK

### Dairy Feed Situation May Be Handicap

The feed situation may or may not handicap Delaware dairymen in milk production in the months ahead. Delmar Young, extension dairy specialist, says dairymen who have their silos filled, who have a good supply of good legume hay and bins filled or to be filled with home grown grains, should not have too many worries. These dairymen can balance their daily ration and maintain economical production from these feeds.

To those dairymen who have poor quality hay, Young suggests that they would be wise to purchase some top quality hay and feed it liberally during the coming months. With the feeding of top quality hay the amount of grain fed can be reduced to one pound of grain to three pounds of milk produced.

President Truman has proclaimed the week of October 5 to 11 as Fire Prevention Week.

Now is the time to find out the cause of fires and to eliminate them. Public enemy No. 1 is the careless smoker. He smokes in bed and in the barn. He guards lighted cigarettes and matches. The thoughtless housewife ranks second on the list. She stacks papers, magazines, old clothing and discarded furniture in the attic, the closets and the basement. This debris is perfect tinder for any spark.

To control mites in the laying house it is important to give the house a thorough cleaning. Carbolineum or old crack case oil should be applied to roosts, nests and other movable equipment. Apply the material thick enough to get into all cracks and crevices.

### New Drug Increases Penicillin's Powers

A new drug which promises to increase the effectiveness of penicillin is reported by six physicians in the American Journal of Medicine.

Used in conjunction with penicillin the drug—named "statidin"—temporarily blocks the loss of penicillin through the kidneys, thus providing higher concentrations of penicillin in the blood for longer periods of time they said.

This combination, the report said, is expected better to combat diseases in which penicillin alone has been relatively ineffective, such as typhoid fever, the bone disease osteomyelitis and subacute bacterial endocarditis, a heart ailment.

## New Chemical Makes Cotton Cloth "Wrinkless"

George A. Harris, president of Dan River Mills announced recently the development of a new chemical process that makes cotton goods "wrinkle resistant," and said the first garments treated with the new finish would be on the market by November or December.

The process renders cotton fabrics equally wrinkle resistant with worsted and woolen goods and is the result of four years intensive research in collaboration with Monsanto Chemical Co.

At a news conference at which tested and untreated fabrics were exhibited, Harris said the process was based on Monsanto's "Resolun C," a secret synthetic resin formula which previously had been applied successfully to woolen fabrics so as to make them washable.

## FEED COSTS FOR POULTRY STILL RISING

With continued high feed prices, poultrymen are expressing increased concern about production costs and what to do in an effort to get the greatest possible returns from their money spent for feed. During a recent talk by Delaware's Extension Poultryman, Frank Gordy, egg producers were urged to "Take every possible step to obtain maximum feed intake."

"We should remember," Gordy continued, "that it takes feed to make eggs, regardless of how high its price may become."

Admitting that there are many other essentials and contributing factors in the manufacture of eggs, Gordy emphasized, however, that feed is the primary raw material for the egg producing factory.

As feed intake increases, rate of production becomes greater and not only takes less time to fill a case of eggs, but also requires fewer pounds of feed.

He pointed out that 100 birds laying 60 eggs a day instead of only 40 will fill a case of eggs—30 dozen—in three days less time and with 48 pounds less feed.

Other suggestions offered to increase rate of production and to reach greater efficiency in production were constant culling, use of lights, maintaining a proper rate of mash—grain intake, and saving feed by controlling rats and not filling feed troughs more than one-third to one-half full.

## Nurse Exams Applications Are Sought By October 21

General Staff Nurse and Head Nurse positions, at salaries of \$2,644 and \$3,397 a year, will be filled from an examination announced recently by the U. S. Civil Service Commission. Nurses are needed to fill vacancies in these positions in Washington, D. C., throughout the United States, in Alaska, and in the Panama Canal Zone.

To qualify in the examination, all competitors must pass a written test and must also have completed a 3-year course of study in an approved school of nursing or a time-equivalent combination of such study and nursing experience. Applicants for Head Nurse positions must have had additional experience in nursing. The age limit for Panama Canal Service positions is 35 years, for Indian Service positions, 40 years, and for other positions, 62 years. These age limits are waived (up to 62 years for the Panama Canal Service and without limitation for other agencies) for persons entitled to veteran preference.

Further information and application forms may be secured from the Commission's Local Secretary, Mr. W. S. Sings, located at Newark Post Office, from most first- or second-class post offices, from Civil Service regional offices, or from the U. S. Civil Service Commission, Washington 25, D. C. Applications must be on file in the Commission's Washington office not later than October 21, 1947.

## MRS. TURNER GUEST OF "WOMEN OF ST. THOMAS"

The women of St. Thomas Church, Newark, were formally organized Monday evening, September 22, at a meeting in the Parish House, addressed by Mrs. Paul F. Turner, Diocesan Director of Episcopal Women's Auxiliaries, in a move to pattern the local group more closely after the type of organization that is increasingly favored by the women of parishes throughout the Protestant Episcopal Church.

As outlined by Mrs. Turner, the basic type of women's church organization consists of a central, or executive, committee, which is the governing body of the entire organization. Responsible to this group are chairmen of various departments or sub-groups that will be engaged in carrying out the functions into which the large organization is to be divided. The number of these activity groups and the fields of interest involved are usually determined initially by a questionnaire submitted to all the women of the parish.

Details of organization and operation are shaped by the characteristics of the individual parishes, but generally speaking, the principles outlined above form the basis of a large number of Episcopal women's organizations now in successful operation throughout the country. Advantages of this plan include: active participation by more women and in work in which they have an opportunity to express interest; elimination of overlapping meetings and activities; control of finances by a central treasury.

The first group of executive officers will be appointed by the Reverend William H. Hanckel, rector of St. Thomas, before he assumes his new duties, and will be announced next week. Mr. Hanckel has long expressed a desire to have the women of St. Thomas Church organize along these lines. At the meeting Monday evening he expressed his great pleasure that the action is now at hand, and stated his faith in its ultimate success.

Invitations will be issued soon to all the women of St. Thomas for a semi-social meeting to get acquainted with the new plan. Work will then proceed towards organizing the activity and study group in which it is hoped all the women of the parish will wish to participate.

"The Women of St. Thomas" was formally adopted as the name of the organization.

But Silent Bill said nothing as he returned to sleep.

Although Bill said nothing, University of Delaware alumni and thousands of other Blue Hen football fans everywhere are talking excitedly, hopefully and somewhat fearfully about this year's Blue and Gold gridgers and their chances of overcoming the eight opponents on the toughest schedule ever rigged for the Newark eleven. Few deny that the Hens do face their heaviest schedule. All three opponents who were beaten by fifty points or more last season have been dropped. To which there comes the ready response, haven't you ever heard of burly Joe Coady and Tony's brother Mariano (Nine) Stalloni, a mighty fine pair of fullbacks? And how can you forget wingbacks as "Doc" Doherty, the Irishman known as "Dutch," Bill Cole and Tony Storti? Yes, and in the quarterback slot, there's bruising Buck Buchanan and Spiz Sposato, whose outstanding blocking resulted in his being shifted from half to quarter.

Thus the talk goes on as Delawareans anxiously await the initial fray against a respected and rebuilt Pennsylvania Military College football machine in Wilmington Park come this Saturday night. Somewhere along the line, it is conceded, the Hens may drop from the ranks of the undefeated. "So what?" is the challenge laid down. No team can win forever. And further more, it is added, any conqueror of this year's Blue Hen grid aggregation who is looking forward to enjoying a chicken dinner had better change his mind—for after the battle he'll be in such a condition that even a chicken broth may be too much for him to digest.

## TEACH CHILD SAFETY RULE

### Traffic Hazards

According to the Delaware Safety Council, keeping play vehicles off the roadway should be one of the toddler's first lessons in safety. Nearly all children are exposed to traffic hazards almost as soon as they can walk. Therefore the teaching of safe behavior on the street properly begins at the parent's knee.

Patience and perseverance are required to implant the seeds of safety in impulsive young minds. To the preschool tot, the first tricycle is a magic carpet inviting the soul to distant adventure. But the well-trained child knows that beyond the sidewalk lies the Land of Accident and Disaster.

Bicycles are not only a source of youthful recreation; they are an important means of transport. The teenage cyclist must cope with the manifold dangers of modern traffic. Every inducement of home and school should be brought to bear in preparing him to use his bicycle safely and sanely.

Step-by-step progress in safety during the formative years of childhood prepares our youth for the ultimate challenge—the safe operation of a motor car. Here the high school can aid in completing the educational task with classroom and road courses in driving. With an ingrained respect for law and the rights of others, and a proficiency learned from experts, the high school trained driver is Delaware's best hope for eliminating the menace of traffic accidents.

## FARM HOME SUGGESTIONS

### Laying Out Farm Dwelling

Farmhouse visitors who come directly into the kitchen may have no other choice if the driveway leads them to the kitchen door. When the back entrance of the house leads directly into the kitchen it makes this room the main highway to every other room.

Visitors can be led to a front or side entrance just as readily as to the kitchen door if the driveway is planned with such an entrance in mind. Says Miss Louise Whitcomb, home management specialist for the Delaware Agricultural Extension Service. Improving traffic indoors and out when you plan to remodel your farm home will save many a step and make life easier for the homemaker. Four devices particularly useful in improving indoor traffic when you remodel are relocation of doors, relocation of stairs, changing the use of a room and providing better storage spaces.

When doors are too numerous and leave no wall space for placing equipment, close up one or two of them temporarily by placing equipment in front of them. Only when tested and found unnecessary for convenient traffic should the closing off of a door be made permanent.

Sometimes, changing the use of a room makes a better traffic route through the house. Living rooms and dining rooms can be shifted. Downstairs bedrooms may be changed to the other side of the house. Just because a room has always been used for a certain purpose doesn't mean that it can't be changed if more useful for another purpose. Adequate storage space of the type needed in each room also relieves traffic jams.

## HOMEMAKERS SUGGESTIONS

### Varnishing Furniture

"If your varnished or oiled furniture has a stickiness or bloom it is probably because you are using too much furniture polish and not following each application of polish with another rub using a clean cloth," says Louise R. Whitcomb, Home Management Specialist for the Extension Service, University of Delaware. Furniture and floor polishes contain oil that attract dirt unless they are thoroughly rubbed off after each application.

When furniture does get badly soiled or sticky, wash it. Not with ordinary soap and water but a mixture of one tablespoon of turpentine and three tablespoons of linseed oil added to a quart of boiling water. Keep the water hot in a double boiler away from the flame. Do not add the turpentine and oil until the double boiler has been removed from the stove.

A sponge is excellent to use for this washing. Squeeze out as much liquid as possible before starting in. Go over the wood and give it a good scrubbing. Then polish with a clean cloth. After washing, the wood can be gone over with either wax or a good furniture polish. If the wood surface has been waxed, do not clean or treat it with oil until the wax is removed. An oily dust cloth should not be used on a waxed surface.

The above is one of the many household helps appearing in Extension circular No. 23, "Time Savers for Housecleaning Days." A copy can be obtained free from Extension Offices in Newark, Dover, and Georgetown.

## 600 FROSH WELCOMED IN TALK BY U. OF D. HEAD

**No Let Down In Academic Standards, Dr. Carlson Says**

Filling "every cranny" on the University of Delaware's campus this year, and utilizing virtually every available hour has resulted in some physical inconveniences, but no lowering of academic standards, President William S. Carlson informed more than 600 freshmen last week in a Freshman Week welcome address at Mitchell Hall, Newark.

After pointing out that two years ago the university's enrollment was 478, and that it was equipped to handle 1,000 students comfortably, Dr. Carlson said that "this year we have contracted to take care of 1,100 more than that—and they're all welcome."

"In the struggle with numbers," he said, "we have not lost sight of quality, especially in the case of the faculty, where the calibre of the past has been maintained. You will find that the faculty, old and new alike, is qualified to put you in touch with the best."

"The faculty has taken the attitude—and I think rightly so—that we should fill every cranny on the campus and fill every hour with work. If you may at times feel that you are inconvenienced, remember that by a bit of sacrifice on your part we have been able to accommodate another of your classmates."

Dr. Carlson told the freshmen that in coming to the university they had "acquired a new status, but not without sacrifice on the part of parents and the taxpayers of Delaware."

"You have accepted a responsibility," he cautioned, "and you are now obligated to enrich the lives of those who have opened the doors for you."

The university's faculty and administration, he stated, has the single objective of giving the students every possible assistance in obtaining the most from their education.

"We at Delaware look on education as an individual problem, not a mass problem," Dr. Carlson said. "Freshman Week is designed to help you find yourself in your future work, and we want you to find yourselves—to select from the university's rich offering of the studies and activities which will make the greatest contribution to your development."

"The University of Delaware is no institution in a lifeless sense, no place for you to be swallowed up without identity. You won't be just a name in a professor's gradebook, a number in a file."

Freshman Week included a solid schedule of tests, meetings, and social events for the Class of 1951, concluding with the convocation exercises on Sept. 24. Classes were scheduled to start Thursday, Sept. 25, for all students. Registration was held in the first three days of this week.

## SAVINGS BY FARMERS IN STATE DROP

**Study Shows Less Is Saved Than In War**

Delaware farm families as a whole saved less last year than during the war years.

This was evident in a study of 30 farm records recently completed by Miss Louise Whitcomb, extension home management specialist for the University of Delaware.

The average saving per family dropped off to \$533, as compared with \$1202 the previous year. Miss Whitcomb gives several reasons for the decline. Farm expenses went up in 1946, due to higher cost of feed and labor. Food and clothing costs took a larger share of the family money.

Many families invested heavily in repairing their homes and purchasing new equipment. This was to be expected, explains Miss Whitcomb, because people had been waiting for the time when materials and equipment were again available and were putting money aside for just this purpose.

These record-keeping families were wise in continuing life insurance protection and in some cases increasing it. Health insurance was carried by two-thirds of the group. Most of them were cautious about running heavily into new debts or starting in any new business venture.

While the number of records studied is too small to represent typical spending, Whitcomb emphasizes that it does show some of all Delaware farm families. Miss Whitcomb's summary of Family Spending in 1946 may be obtained from extension offices in Newark, Dover or Georgetown.

## Boxcar Shortage Continues High

The backlog of railroad and private carline orders for new freight cars reached 118,117 as of Aug. 1, the Association of American Railroads announced recently. The total "on order" July 1 was 109,117.

Class 1 railroads also hand out-standing orders on Aug. 1 for 815 new locomotives, including 29 steam, four electric and 782 Diesel.

The report said the class 1 roads put 26,174 new freight cars and 482 new locomotives into service in the first seven months of this year, but they were forced to retire 32,191 freight cars in the period.

The Office of Defense Transportation said recently that such retirements of worn-out cars were steadily running ahead of deliveries from the manufacturers, thus contributing to the continued car shortage in the country.

## HIGH LIVING STANDARD ON DEL. FARMS

**State Ranks Tenth In U. S., Bausman Says**

Delaware has the tenth highest farm standard of living of any state in the nation. It is exceeded only by California, Connecticut, Illinois, Iowa, Massachusetts, New Hampshire, New Jersey, New York, Rhode Island, and Washington.

Dr. R. O. Bausman, head of the department of marketing and farm management of the University of Delaware, explains that the standard of living in this comparison is based upon percentage of farm dwellings having electricity, percentage of farm dwellings having telephones, percentage of farms with automobiles, and the average cash income per farm.

In 1945, Delaware had the sixth highest net income per farm in the country, Sussex County has the second highest cash farm income for counties east of the Mississippi River.

In a recent pamphlet prepared by Dr. Bausman on the cash farm income by counties and commodities for the period 1941 to 1946 it is shown that Delaware agriculture has undergone some phenomenal changes during the war and post-war period. For example, in New Castle County, the sale of broilers amounted to \$212,000 or about five per cent of the cash farm income, but in 1946, New Castle County had slightly less than a \$1,000,000 broiler industry which amounted to nine per cent of the total cash farm income.

The increases in the broiler industry in Kent and Sussex Counties are even more phenomenal. In 1946, the cash farm income from the sale of broilers amounted to 17 per cent and 78 per cent respectively.

In Kent County in 1941, the sale of truck crops amounted to about \$496,000 or 7 per cent of the total cash farm income. In 1946, the sale of truck crops amounted to almost \$2,000,000 or about 12 per cent of the total cash farm income.

## 1948 WHEAT GOAL SET AT RECORD HIGH

**Planting Quota Tops War Mark**

A 1948 wheat planting goal which exceeds those of the war or any previous post-war year has been set by the U. S. government, which foresees at least two more years of grain shortages.

The Agriculture Department called upon farmers to seed at least 75,000,000 acres to the bread grain to permit this country to continue large shipments to shortage areas abroad at least until the fall harvests of 1949. The planting season for winter wheat is only a few weeks away.

Next year's goal compares with the 1947 target of 70,700,000 acres and with around 50,000,000 acres actually planted in the years immediately before the war. Farmers, however, exceeded the 1947 goal by about 7,000,000 acres—a development which helped produce the largest wheat crop in the nation's history.

In boosting next year's objective over the acreage originally asked for this year, the government postponed, somewhat reluctantly, plans to urge farmers to retire much over worked wheat lands to grass, pasture and other non-crop uses for the sake of soil conservation.

In announcing the new goal, Secretary of Agriculture Anderson said that under "normal peacetime conditions" a much smaller acreage would be desirable.

"Because the need for exports to meet world shortages continues urgent, however," his statement added, "it appears desirable to maintain a high United States acreage in 1948."

## HOME CLUB DAY IS SET

The fall meeting of the New Castle County Home Demonstration Council was held on Friday, September 19th, in Wolf Hall, University of Delaware, Newark. Mrs. S. B. Collins, president of the council, presided at the meeting. The purpose of the meeting was to plan the New Castle County Home Demonstration 1947 Achievement Day program. The date set for the Achievement Day will be November 6th, 1947, in the Newark Methodist Church, Newark.

Besides the committees appointed for Achievement Day, Mrs. Collins also named a committee to form some rules and resolutions to be used by the home demonstration clubs which will be submitted to the council at their next meeting. Many interesting suggestions were given for the 1948 program, but no definite plans were made.

Miss M. Gertrude Holloway, state home demonstration leader and Miss M. Katherine Jones, New Castle County home demonstration agent were present at the meeting in an advisory capacity.

The following clubs were represented at the meeting: Friendly Neighbors, Port Penn, Townsend, Middletown, Glasgow, Odessa, Three-In-One, Bear, Talleville, Wimodausis, and State Road.

### VOCATIONAL AID STRESSED
