BE IT FURTHER RESOLVED that if, after such investigation the members of said committee shall feel that said deferment or deferments are improper and contrary to the intent, purpose and provisions of the National Selective Service Act, said committee shall forthwith forward the results of such findings to such Selective Service authority either within the State of Delaware or in Washington as to said committee shall seem proper together with any recommendations which said committee shall have and,

BE IT FURTHER RESOLVED that it is the purpose of this Resolution not to interfere with the said National Selective Service Act or any part thereof, insofar as the same is fairly administered, but it is the intended purpose of this resolution and the authority herein conferred to further effective and fair administration thereof.
