this report I have been obliged to temporarily borrow from the school fund large sums of money, all of which, including the '94 balance, have been repaid and the said general fund shows at this date a balance of over \$15,000, with no payments in arrears. My predecessor in his last report strongly urged upon the General Assembly the absolute necessity of legislation looking to the increase of receipts for the general fund which was not favorably acted upon. I, however, am compelled to reiterate his recommendations on account of the unusually large demands which will be made upon the Treasury during the year iust begun. The expenses of the Constitutional Convention will necessarily be large, and the expenses and appropriations by the Legislature can only be approximately estimated, while, from the growth of the Hospital at Farnhurst, its appropriation will likely be increased instead of diminished; all of which expenditures are payable from the general fund. Unless its receipts are in some way increased it will be impossible to meet the demands upon it, and the questionable expedient of temporary loans from the school fund will not be avalible, for the revenues of the general fund will certainly not be such as to enable it to reimburse the school fund in time for the annual distribution thereof. As to how this increase in revenue shall be accomplished I have no recommendation to make, but would strongly urge its early consideration by the Ways and Means Committee of the next House of Representatives, to whom I will gladly give any information in my possession.

SINKING FUND.

The depressed condition of the oyster industry during 1895, from which this fund is entirely derived, has reduced the balance in this fund about \$600.00 during the last year. Continued depression and recent governmental legislation has further reduced the receipts of the oyster revenue collector during 1896, so that he was compelled to call upon me in November for money to pay the expenses of the guard boat. There being no legislation authorizing such payment I declined to do so, and recommended him to lay the facts before the General Assembly for its consideration. Such legislation as will avoid such trouble in future is imperatively demanded,

SCHOOL FUND.

The receipts and expenditures of this fund have not materially changed during the period embraced by this report except that the annual appropriation to the colored schools has been increased from \$9,000 to \$15,000. There are, however, some apparent inequalities in the apportionment of this fund among the schools of the State which the General Assembly would do well to carefully consider and pass remedial legislation.

FREE TEXT BOOKS.

During the past two years the "Free Text Book Law" has worked with very little friction. The contracts for books were in the main renewed and contracts for supplementary books were entered into. During 1895 the entire cost of books was \$6,964.14, and in 1896 it was \$7,241.64. I see no reason why there should be any material change in the expenditures for this purpose luring the coming two years.

INDIGENT SOLDIERS, SAILORS, AND MARINES.

During the year 1895 there were drawn on the Treasury 37 warrants for the burial of indigent soldiers, sailors, and marines, and during 1896 21 warrants, making a total of 58. The total expenditure in the eight years of the operation of the law aggregates \$5,775.00.

STATE HOUSE.

The completion of the State Library addition to the State House and the removal of the State Library thereto, which has hitherto occupied such a large part of the first floor of the State, House, now renders it possible to so arrange the first floor of said building as to afford suitable quarters for all the officials now having offices therein. It has long been recognized that the present quarters of the Treasurer and Auditor are wholly unsuitable and inadequate for the transaction of their business, and in 1893 there was a law passed authorizing the State Treasurer to make some alterations therein. The proposed alterations, however, were so strenuously opposed by the officials

whose quarters would have been altered thereby that provisions of said law were never carried into effect, but now when opportunity presents itself to make the necessary alterations without serious inconvenience to any one and with as little expense to the State as possible I would suggest and urgently recommend that a special committee be appointed by the General Assembly to take this matter into consideration, and devise plans by which this much needed change may be properly, economically, and expeditiously made.

PRINTING.

Chapter 215, Volume 20, provides for the payment of claims for printing done by order of duly authorized officers of the State, and I have paid claims certified under its provisions to a considerable amount. The law is plain and one that is badly needed, but its practical operations are extremely unsatisfactory both to the State Auditor and myself to whom are committed the carrying into effect of its provisions. I would suggest that the General Assembly so amend the present law, or pass a new one, that the abuses possible under the present law may be done away with or the responsibility therefor committed to some one, who will have sufficient information concerning the payments to be made thereunder, as to prevent them.

I desire to acknowledge the uniform courtesy and kindness of the various State officials with whom I have come in contact during my term of office, and to thank them for the many favors they have shown me.

Pursuant to the provisions of Chapter 337, Volume 19, I shall, immediately upon settlement with the Legislative Committee, present my report in detail, in manuscript, to the General Assembly for their information and guidance.

Gentlemen of the Senate and House of Representatives of the State of Delaware, in General Assembly met:

Pursuant to the statute in that behalf, I hereby render to your honorable bodies my report relative to the distribution of the Direct Tax Fund.

I received from my predecessor, Hon. Robert J. Reynolds, the sum of eight thousand, six hundred and sixty-five dollars and eighteen cents, the then undistributed balance of the said fund.

The statement hereunto annexed will show the number of claims passed upon and allowed during my administration, with two exceptions, which I will explain as follows: My predecessor had issued two checks, one payable to the order of S. W. and J. A. McCaulley, executors, for one hundred and six dollars and fifty-seven cents; the other check was issued payable to the order of D. M. Ridgely and H. C. Conrad, executors, for the sum of one dollar and twenty-five cents, which had not been presented to the bank for payment at the time the balance to his credit was ascertained, but which were paid out of the balance to my account.

From the foregoing statement it appears that there is an undistributed balance of the said fund amounting to eight thousand, four hundred and fifty dollars and twenty-one cents, which balance I have paid over to my successor in office, Hon. Ebe W. Tunnell, and whose receipt for said amount I hold, subject to your inspection at any time.
