

Curbside recycling arrives

The City of Newark is kicking off its own curbside recycling program and the vast majority of residents have signed on.

Those participating in the curbside recycling program will begin to receive their new recycling carts this week.

The first recycling collections will take place the week of June 15, 2009. Delaware Solid Waste Authority (DSWA) will discontinue their curbside recycling services in the city of Newark at that time. If residents are currently subscribed to the DSWA, they will continue to use those carts and the City will collect their recyclables.

Newark residents currently have two days of refuse pickupper week. With the start of the curbside recycling program, refuse collection will be cut down to one day per week and the second day will be used for collection of recyclables.

Those residents who did not sign up for the curbside recycling program will have only one day of refuse collection per week.

Approximately 5,000 of the cty's 6,400 residential refuse collection customers have

Police honored for savings professor's life

"They were like angels that came out of the sky." That's how Lee Anderson, Maxwell P. and Mildred H. Harrington Professor of Marine Studies. described three Newark Police

Department officers who answered a 911 call and saved his life.

Master Corporal Dennis Aniunas, a 1991 graduate of UD, and Corporals Andrew Pagnotti and Jerry Bryda, all of the Newark Police Department, received Life-saving Awards from the New Castle County Paramedics at a ceremony on May 18. Anderson and his wife


emony.

Anderson suffered cardiac arrest when his heart suddenly stopped beating. His wife called 911 and then applied CPR until the police officers

"They were mystery people to me because I was unconscious for days, but they were fast and efficient and applied the paddles until the medics arrived and got me to the hospital. I am very grateful," Anderson said.

Anderson was treated by hypothermia, immersion in

Football player stabbing victim

A University of Delaware football player reported he was attacked and stabbed Saturday. The Newark Police Department was summoned to the Christiana Hospital Emergency Room for a report of a stabbing victim. The incident reportedly occurred in the area of East Cleveland Avenue near North Chapel Street. The victim, a 22-year-old UD student and football player, told officers that he was walking in the area of East Cleveland Avenue and North Chapel Street when he was attacked by four white males. During the incident, the victim was stabbed once in the right rib area and once in the neck area. The victim was treated and released from the hospital.

One suspect is described as a white male in his early 20's, heavy set, approximately 6'01" and 240 lbs., with short hair and wearing a white t-shirt. The other three suspects were only described as white males around the same age but smaller in stature.

Collision and attempted robbery

Early Monday morning the Newark police responded to a vehicle collision into a light pole in the intersection of East Main Street and Library Avenue.

Police found no one with the vehicle. Several hours later NPD Dispatch received a call from a male who stated that he was driving that vehicle and he crashed after he was almost robbed at gunpoint.

The 21-year-old male stated that he was stopped at the traffic light of Library Avenue N/B at East Main Street, when a newer model black Honda with tinted windows pulled up next to him. There were two males in this vehicle. The victim stated that the driver of the black Honda then pulled out a handgun and demanded money from him while speaking Spanish. The victim stated that fearing for his safety; he floored his vehicle. attempted to turn left-onto East Main Street and then struck a light pole. The victim stated that he fled on foot as he heard the suspect vehicle coming after

The one suspect driving the vehicle can only be described

as a Hispanic male, 23 to 24 years old.

The Newark Police are seeking the public's assistance in locating witnesses to the attempted robbery or the vehicle collision.

Graffiti found on Main St. businesses

Newark Police are investigating multiple graffiti tags spray painted on the building that comprises Two Brothers restaurant, Sassy Cupcake, Margherita Pizza and Panera Bread. The owner of the complex, Dannemann & Danneman LLC, reported that tags had been painted on various portions of the building and that the graf-fiti had not been there the week before. A representative of the owner stated that she performs a visual inspection of the building complex every weekend and that the last inspection was performed on May 16. A report was filed with police on May 24.

Alleged robbery turns into revenge

On May 25 at 2:56 p.m., Newark Police were dispatched to the Quality Inn, located at 1120 S. College Ave. for an in-progress argument. After questioning the arguing parties, police discovered that Angel Conrad, 22, and Danielle Ortiz, 17, both of Elkton, Md., had been detained against their will and beaten in a room in the hotel by Shannon Wheeler, 21, Shellie Owens, 28, both also of Elkton and a friend of Owens, Chakara Interviews showed that Wheeler, an alleged crack/ heroin dealer, had discovered some drug money was missing and blamed his girlfriend, Ortiz. Wheeler called his sister, Owens, and tracked Ortiz and

Wheeler and Owens held Ortiz and Conrad against their will until they paid Wheeler back. Owens, who had brought her two children with her, proceeded to take cell phones and prescription medicine from Conrad and Ortiz. Owens and Hollis beat upon Conrad while Conrad was holding her fourmonth-old daughter.

Accomplices of Wheeler arrived to drop him off back in Elkton. Wheeler is being investigated by Elkton police for a recent shoot out in Hollingsworth Manor. All present parties were taken into custody. Charges are pending further investigation.

Home invasion in Brookside

New Castle County Police are investigating a home invasion and armed robbery of seven Hispanic men who were socializing at a Brookside home early Sunday morning. During the robbery, three armed suspects forced their way into the home and held the victims at gunpoint while they ransacked the dwelling and removed cash and other items of value.

On Sunday at 2:40 a.m., County Police responded to a home in the unit block of Kenmar Drive for a report of a home invasion that just occurred. When police arrived, they contacted one of the adult male victims who reported he was socializing with friends inside the home when three armed suspects forced their way inside.

The men, who were each wearing dark clothing and had their faces concealed, pointed handguns at the victim and forced them to all lay face down on the floor. The suspects proceeded to remove cash from each victim and then ransack

the home before fleeing in an unknown make/model vehicle.

Identity theft

Last week, officers responded to an identity theft report from Terry Gibbs, 58, of Newark. Gibbs stated that he had been contacted by Caroline County, Md. police for a traffic summons. Gibbs has been declared legally blind and has not held a driver's license since 1991. The operator of the vehicle had presented a Delaware learner's permit with Gibbs' name and address. Gibbs was notified to contact the police after he advised the Delaware DMV of his situation. The photo on the license of the driver was not the same as Gibbs.

During an interview, Gibbs stated that about a month ago, a friend of Gibbs, Robert Grocki, and an associate of Grocki's named Sam had visited Gibbs for a dinner party. Sam, later identified as Salvatore Vogl, had asked to use the bathroom, next to Gibbs' bedroom. Gibbs told police that he keeps all of his personal information in his bedroom dresser.

Grocki was shown the picture of the ticketed driver and positively identified him as Salvatore Vogl. Vogl has been picked up on outstanding war-

Wampler's Twin Towers to premier on June 12th

win Towers, an original play by Damian Wampler and directed by Angela Astle, will premiere at The Planet Connections Theater Festivity on Friday, June 12th through Sunday, June 28th for six performances only at the Robert Moss Theater at 440 Studios, 440 Lafayette, in New York's East Village. Wampler grew up in Newark.

Proceeds from the play will benefit the non-profit ENACT, where actors use role-play and drama therapy techniques to help New York City students learn emotional and social skills. Set in the Bush Era, Twin Towers explores the struggle between natural law and positive law - what we know in our hearts to be right versus what society and our government tell us, according to Wampler.

The play, set in the Bronx, focuses on the lives of two best friends who have chosen very different life paths. Trevor and Jamal, the Twin Towers of the title, were once inseparable schoolyard buddies. Now, years later, Trevor has returned from Iraq a war hero, while Jamal has returned



from years of overseas work in the Peace Corps searching for purpose.

The two clash as the fantasy of their childhood innocence fades to reveal the truth of their character.

Twin Towers is a coming of age story not only for two young men but for our country as well, criticizing what Wampler sees as a moral vacuum our country experienced during the last eight years.

Twin Towers will incorporate music, dance, a Brazilian dance-like martial art called Capoeira and a primarily African American ensemble cast. Capoeira is woven into the play to illustrate the complex relationships and emotional upheaval in the play because it flirts between fighting and dancing, as do the main characters throughout the play.

Wampler is a returned Peace Corps volunteer who spent five years overseas as an educator, researcher and community developer. Many of his best friends from high school joined the military and are currently serving in Iraq and Afghanistan.

"When I came home, I realized that not only had my country changed, but I had changed as well. I had a greater understanding of who I was and what was right and wrong; an understanding that I had come to through my own personal journey."

"This play will impact Peace Corps volunteers and Iraq war veterans, African Americans and anyone who has stood up for something they knew was right, even though everyone

Twin Towers will incorpoe music, dance, a Brazilian around them told them it was wrong," Wampler says.

"Damian infuses music and dance into almost every scene, creating a lyrical piece that is both realistic of an urban neighborhood and whimsical as the characters try to hold on to their childhoods," says director Angela Astle, "but finding actors who could sing. dance Tango and Capoeira was a challenge, regardless of race."

There will be a reception to meet the author and cast of Twin Towers on June 12th at 7:00pm in the lounge of 440 Studios, directly following the world premiere.



Youth and teachers volunteer to promote buckling up

e read so much negative news lately. There are budget deficits, people having to take forced pay

cuts or furloughs, people losing jobs, and people losing homes. It also seems that too often we read about negative incidents related to our youth and young adults. In similar style, I think we are too quick to criticize the

teachers that educate our youth and young adults. So, I thought I would like to share some positive news about some youth, parents, and teachers, who gave up their time after a long week at school and other obligations. to assist me. They helped me to remind others that wearing their seatbelt is a "No-Brainer" for everyone. Seat belts save lives, prevents injuries, and save the country, state, county, city, and every person from economic

It was a very hot and humid afternoon in late April when eight Delcastle members of the Youth to Eliminate Loss of Life (YELL) and the Kick Butts Generation (KBG) chapters came out to remind students and faculty to buckle up. The students, family members, and teacher chapter advisors met at the school to paint buckle up stencils at the entrance/exits to the parking lots of Delcastle High School. The students concluded the activity by sharing one thing they enjoyed, one thing they learned, and one way they would spread the message of seatbelt safety.

The students enjoyed the opportunity to spend time together outside of the classroom on the weekend. (Although this day air conditioning would have helped. I think it hit 90 degrees that day---drinking water to stay hydrated was a must and all of us were dripping wet from the heat!) Students felt good about

getting to do the actual painting of the stencil and being part of a project that has the potential to save lives of fellow students, family members, and teachers by reminding them to wear their seatbelt. One of the students was spotted not wearing her seat belt as she arrived to help and admitted her forgetfulness. After the stencil was finished and she learned about traffic safety statistics and the results of not wearing her seatbelt, she stated she won't forget to wear her seatbelt again. Another student mentioned he did not realize that the driver could be fined if his passengers were not buckled The students also committed to continue to spread the word about how important it is

to buckle up by being a good role model and wearing their seatbelts, hanging seatbelt safety posters at the school, at local stores, and having a display table at the school's Wellness Center Health Fair.

This community service project is coordinated through the University of Delaware Cooperative Extension Traffic Safety Program and funded by the Delaware Office of Highway Safety. The "buckle up" stencil has been painted at 25 schools in New Castle County including Newark, Dickinson, McKean, Padua, and Appoquinimink with the help of School Resource Officers and other student

Campaign in Delaware, which is part of a national initiative orchestrated by the National Highway Traffic Safety Administration that promotes enforcement of seatbelt and child restraint laws. States all across the country conducting education, awareness, and enforcement during the month of May. These efforts we targeted to reduce the number of deaths and injuries on our roadways due to motor vehicle crashes. The federal government holds Delaware and all states accountable for increasing seatbelt use and reducing deaths and injuries on our roadways. The federal government can penalize states by reducing important transportation funding when improvement in traffic safety is not met.

So do your part to spread the "Buckle Up" message. It is a "No Brainer" that seatbelts save lives and prevent injuries. Wearing seatbelts also saves all of us money in medical and insurance costs, workman's compensation, loss of wages or productivity, and physical and emotional stress. In Delaware alone, we could save \$400 million dollars a year spent on motor vehicle crash deaths and injuries. 





Family fun will abe at annual Newark

about that one night of the year when downtown Newark transforms from its daily hectic scene into the lively street festival that has come to be known as Newark Nite.
