**Introduction**: At the beginning of the year, Franklin joined the Freemasons. He had done business with one Mason, Thomas Hart, bricklayer, in 1730, but in 1731 Freemasons William Allen, Isaac Brown, William Button, William Pringle, and Josiah Rolfe, all turn up in his accounts, as does the Lodge itself on St John's Day, 24 June. A good friend and original Junto member, William Parsons, first appears on 2 Jan. Franklin sent his journeyman printer Thomas Whitemarsh to Carolina to open a printing shop (9 Sept) and regularly supplied Whitemarsh with printing supplies (13 Oct). Franklin began doing business with his brother James Franklin, who was now in Newport, RI. BF recorded under 30 Oct (though some of the entries must be later) sending publications to James: 100 Watts (Miller 2), 36 The Spirit's Teaching Man's Sure Guide (Miller 12), 24 Short Discourse Proving the Jewish Sabbeth is repealed (Miller 7), 12 of his own Modest Enquiry into the Nature and Necessity of a Paper Currency (Miller 4), 100 Godfrey's almanacs (Miller 35), 100 Godfrey's sheet almanacs (Miller 36) and 36 copies of Ralph Sandiford's Mystery of Iniquity (Miller 31, or possibly Sandiford's earlier Brief Examination of the Practice of the Times, Miller 11). The exchange was reciprocal. BF advertised James Franklin's edition of Robert Barclay's An Apology for the True Christian Divinity, 21 Dec.

Also under 30 Oct, BF recorded a series of transactions with his partner Thomas Whitemarsh: "100 Book Almanacks" (Godfrey's? If so, Miller 35); "100 Sheet Almanacks" (Godfrey's? If so, Miller 36); "36 Watts Psalms unbound" (Miller 2, who mistakenly has 40 copies); "1 Doz. Watts Psalms" (bound? Miller 2); and "50 Nature of Riches" (By Joseph Morgan; Miller 56; dated 1732 on title-page). BF recorded charges for 500 copies of two sheets of the Nature of Riches. Another brother, the sailor Peter Franklin, carried printed works and supplies between Benjamin and James.

The major on-going expense was paper. In 1731, Franklin's supplier became William Allen. One transaction, recorded under 10 July, shows Franklin paying £124.15.0 to Allen for paper. In September, Franklin recorded paying the firm Mogridge and Cassel £6 "on Acct. of the Press." Was this a part payment for the printing press that Simon Meredith had ordered for his son and Franklin to start printing? Or was it another press? If so, the part payment was for the press that he sent with Thomas Whitemarsh to South Carolina.

Franklin continued to accept payment in barter: brushes from John Wilkinson (13 July); meat from the Widow Wragg (4 Aug); "a Hautboy"/oboe and eggs & bacon from James Wilmot (1731); horse hire from William Biddle (10 April) and Joseph Scull (21 June), chairs from Caleb Ranstead (20 Sept) and Thomas Skelton (1731); and a saddle and whip from Nicholas Reddish (1731). Some items he no doubt sold; others, he kept for his own use. William Button, "Left in my Care his Flute," perhaps as security (1731). From other sources, we know that BF owned and played the oboe, but it is not known whether or not he played the flute, though some ability with the flute was a common attainment in colonial times. A mysterious debtor is Deborah's "My Madman," who shows up on 27 Aug and 27 Nov and who is never identified; he did, however, not only pay his debt but bought a Hemphill tract in 1735.

The 1731 accounts show an increase in binding jobs. They also document Franklin's payment of monthly dues to the Masonic lodge (cf. 5 July, 6 Sept, 4 Oct, 1 Nov, 6 Dec). During the year, BF experimented with making ink. On 17 June, he tested three different inks (his own, Joseph Breintnall's and one "very different"); on 19 June, he experimented with Persian ink made by James Austin; on 22 June, with a "Japan Ink"; and on 3 Aug, with his own "New Ink," noting it was "Pale when first wrote." He selected one or more of these for bottling in large quantities (cf. 20 Aug, 12 Oct). Oil was an essential ingredient in making ink, and the shop was

selling oil by 12 May (William Mogridge).

Imprints. Numerous details of Franklin's printing appear in the accounts. The Votes and Proceedings are printed and recorded by sessions of the Assembly (see 1 Jan; Miller 44 misdates the account 1731/2, but it is 1730/1, and should be for Miller 43, as listed below). Other references to printing the Votes and the Laws occur on 14 Jan, 1 June, Sept; 14 Dec, and year end. The accounts provide a date for the separate printing of the 12 Jan naturalization act (Miller 25), which BF referred to as "Palatines" (1 June). They disclose the date (1 July) by which BF finished and billed the trustees of the loan office for printing the paper currency emission of 10 April (Miller 42), as well as the specifics of his charges. Surprisingly, of the £114.13.5, he abated £14.13.5. Many printers charged more than they were paid by Pennsylvania and other provinces, and not infrequently, printers tried to charge the province more at a later time. This is the only instance I know where Franklin changed a charge. Perhaps Bradford said he would have printed the notes for £100 or perhaps Franklin was so pleased with the job that he abated the £14.13.5 on his own. No evidence explains the change.

The accounts often reveal when a publication appeared (of course an imprint could have appeared some time before someone bought a copy on credit). Robert Nevet bought a copy of George Webb's <u>Batchelors-Hall</u> (Miller 46) on 28 April. And William Davis bought a copy of the first part of Alexander Arscot's <u>Considerations</u> (Miller 33) 1 May. Details on BF's charges for printing Pennsylvania's <u>Votes</u> and <u>Laws</u> are given on 1 and 14 Jan; Sept; 14 Dec, and year-end. Since both Miller 26 and 27 are simply cited as "Law" or "Laws," I discriminate between the two by the price, the former sold for 6d and the latter for 2s. BF's charge for printing a Pennsylvania proclamation is recorded under 27 Aug. Godfrey's almanac was evidently published by 28 Oct, when Isaac Norris bought 500 copies wholesale. It is likely that Godfrey's

sheet almanac was published at the same time. According to a note in Ledger A&B, p. 369 (given as the last entry for 1731), BF printed 639 copies of the sheet almanac. In the same place BF recorded that Thomas Godfrey bought six copies (Miller 36), Owen Owen bought one, William Webb bought one, and John Wright bought one.

At the end of the year, BF charged James Logan for printing Alexander Arscot's <u>Some Considerations Relating to the Present State of the Christian Religion</u>, part 1 (Miller 33), and charged Logan and Israel Pemberton for printing both parts (Miller 33 and 47). He also, at the year's end, recorded additional books sent to Whitemarsh in Charleston: "100 Sh[eet]. Alm[anacks]" (Godfrey's? Miller 36?); "12 Watts Psalms" (Miller 2); "150 [Joseph Morgan], Nature Riches" (Miller 56); "50 [Honour of the] Gout Books" (Miller 62); "20 [William] Bow[man]. Ser." (The Traditions of the Clergy destructive of Religion; Miller 49); and "50 Catechisms" (David Evans? <u>A Short Plain Help for Parents</u>? Miller 51?).

The accounts show that having partners and relatives in the business was a boon. Franklin sent them tens and hundreds of his publications unasked. If they sold them, wonderful! If not, they could (and often did) return them.

Franklin continued his job printing. On 2 Jan, he printed 6 quires of tobacco papers for Nathaniel Edgecomb (Miller A34); on 14 Jan, 100 declarations for J. Trent (A45); on 1 March, 100 Welsh Tickets for Dr. (Evan) Jones (A40a); on 5 April, 1 quire of tobacco paper for N. Edgecomb (A35) and 1000 writs for Capt. Foster (A36); on 1 May, 300 mortgages, 300 bonds, and 150 warrants for C. Brockden (A31, A32, A33); on 12 June, 150 deputations for C. Read (A43); on 1 July, 240 mortgages for J. Lawrence (A 41); on 13 July, 10 license bonds, 100 excise bonds, 140 excise certificates, and 100 licenses for A. Hamilton (A37, A38, A39, A40); on 4 Sept, 200 licenses for R. Charles (A42); on 7 Sept, 200 bail bonds for N. Scull (A44); and on 13

Oct, 6 quires of warrants, summonses, executions, etc., for F. Bowes (A30). These items only enumerate the job printings recorded by Miller. For a list of additions, possible additions, and corrections, see Appendix One.

Stephen Potts, the bookbinder who lived with the Franklins, could do press work (18 Feb), and BF occasionally employed him. Potts (or, perhaps, William Davis) bound two of Isaac Norris's books on 14 May. (Unfortunately neither title occurs in The Books of Isaac Norris at Dickinson College, ed. Marie Elena Korey.) In this early year of business, BF revealed his disgust with the occasional person who swindled him. On 12 Oct, he annotated John Owen's account with "Cheater" and noted on the same day that Richard Wright "won't pay." Though some persons gradually came to owe him dozens of pounds--many of whom never paid their bills--BF never afterward recorded his exasperation in the accounts. The charge of 1.17.6 to John Lloyd for "Elegies," 19 Jan, is a puzzle: could BF have printed an elegy or elegies for Lloyd? It may have some connection with "John's Verses" at the year-end. The sale for 3s of four dozen copies of a ballad to John Carteret, 12 June, is also puzzling; perhaps this was for one of BF's Welsh ballads (Miller 17 or 22)?

Franklin had started making small cash loans to friends, employees, and customers the previous year. In 1731 he started taking small notes of exchange: on 26 Oct, John Pigot gave him a note of exchange on Mrs. Peter Loyd.

On p. 365 of Ledger A&B Franklin noted by last name only a series of 34 charges for advertisements in the <u>Pennsylvania Gazette</u>. Half way down the list he put "No. 153" beside the name "Bringhurst." John Bringhurst advertised for a strayed or stolen horse in <u>PG</u> #153, 28 Oct 1731. Using that date, the other names can be identified with particular advertisements, for the ads are listed in chronological order. The second, third, and fourth names in the list are

"Williams," "Baynton," and "Capt Gould." All appear in PG #148, 23 Sept. Lawrence Williams, merchant, advertised an especially long list of goods for sale. Peter Baynton, merchant, advertised "Slit or Rod Iron for Nails and other Uses." And Captain James Gould at Trenton listed a plantation for sale. Of the 34 entries, I have some uncertainties about 4. The first name in the list is "Esq. Owen." I believe this is Sheriff John Owen of Chester County who advertised for three escaped prisoners beginning on 30 Sept (BF called him "Esq Owen of Chester" on the following Ledger A&B page, 366). A second dubiousness concerns "Starch." Since the charge is 5.0., I believe it refers to Nathaniel Palmer's advertisements for starch. Palmer advertised on 2 Sept and repeatedly thereafter; though John Clifton advertised at least once, 23 September. (Clifton's shorter ad probably cost only 3s.)

A third uncertainty concerns the "Shoemaker's Boy." It follows the entries "Davis & Hart," "Mankin," and precedes the entry "Reynolds." The other three entries all first occur in PG #151, 14 Oct. The advertisement by Thomas Hart and William Davies for runaway servants is followed by an ad by "Mrs. Mankin" for good Madera wine. That in turn is followed by "A Likely Servant Lad's Time for near Seven Years, to be disposed of; He is fit for Town or Country Business. Enquire of the Printer hereof." Two notices later there is an advertisement by Lawrence Reynolds for the return of items stolen from his home. It seems that "Shoemaker's Boy" entry refers to the "Likely Servant Lad." Evidently he was an apprentice or an indentured servant whose time was owned by a local shoemaker. The entry "Crossthwaite" follows "Fisher," who is charged 5.0., and precedes "Pegg D." Joseph Fisher, master of the Snow Lowther, has two advertisements in PG #155, 11 Nov (reprinted, as usual, in the next two issues); and Daniel Pegg has an advertisement for a strayed horse on 18 Nov. All the advertisements for the preceding and following gazettes carry the names of the advertisers,

except for the advertisement immediately before Daniel Pegg's. That announcement is "To be SOLD, A Likely Negro Wench ... Enquire of the Printer hereof." I suspect that (William) Crossthwaite advertised (18 Nov) the slave for sale. The formula "Enquire of the Printer hereof" was commonly used by printers throughout the colonies. It meant that more information was available at the printer's office.

The Shop. While Franklin printed upstairs, Deborah (and, for six months, her mother) managed the shop on the ground floor. Though remaining primarily a stationery store, the shop gradually assumed some aspects of a general merchandise store. The shop sold "Bohea Tea and Sug[ar]" (28 Sept), "Spectacles" (Aug, 28 Nov), and medicinal herbs: "Snake root" (9 Sept) and "Gentian Root" (13 Oct). Deborah's mother, Sarah Read, began boarding with the Franklins in the latter part of June (6 Jan 1731/2), and on 2 July, she rented one side of the shop at £6 a year (7 July). She sold items for BF when neither he nor Deborah was available (numerous entries post 7 July) and received a commission on these sales (6 Jan 1731/2). Stephen Potts, bookbinder, began renting part of the shop on 1 Nov and began boarding with the Franklins on 21 Dec (7 Jan 1731/2).
