Introduction: Franklin's good friends William Coleman (1732) and Anthony Nicholas (11 July), both of whom belonged to the Junto and the Library Company, first appear in the accounts in 1732. Along with Robert Grace, Coleman aided Franklin in buying out Hugh Meredith in 1730. Coleman and Franklin remained lifelong friends despite political differences, and when Coleman went to London for surgery in 1768, Franklin looked out for him. Present too are freemasons James Bingham (14 Sept), Septimus Robinson (16 Sept), and Lewis Timothy (17 Oct). Timothy (d. 1738) was the first Librarian of the Library Company and later Franklin's printing partner in Charleston, SC. Franklin's Presbyterian minister, the Rev. Jedidiah Andrews (28 March), the joiner and Library Company member Nicholas Cassel (Feb), and the increasingly important merchant John Reynell (4 May) also bought on credit.

Imprints: On 27 Jan, John Pigot purchased a copy of Alexander Arscot's Some Considerations (Miller 47); under Feb, BF charged the Rev. David Evans £4.1.3 for printing 3 and a quarter sheets of his catechism, A Short Plain Help (Miller 51), at 25s a sheet; on 13 April, Thomas Shaw bought a dozen Bowman's sermons, The Traditions of the Clergy (Miller 49); on 8 April, Samuel Eckerling paid £10 toward printing Beissel's hymnal, Vorspiel der neuen-welt (Miller 48); on 22 May, Richard Treat paid £5 toward printing the Rev. David Evans, Minister of Christ (Miller 50); on 20 June, BF charged his partner Thomas Whitemarsh (now often spelling his name Whitmarsh) for 50 Honour of the Gout (Miller 62), 20 Bowman's Traditions of the Clergy (Miller 49), and 50 catechisms (Evans's Short Plain Help, Miller 51); on 23 Aug, William Saunders purchased the Votes and Proceedings (Miller 59); on 14 Sept, James Bingham bought Honour of the Gout (Miller 62); ante 6 Oct, BF noted that he had finished Beissel's hymnal (Miller 48) and been paid by Samuel Eckerling; on 6 Oct Richard Treat completed paying for

printing the Rev. David Evans's sermon, Minister of Christ (Miller 50; Miller has 9 Oct): "for Printing 4 Sheets at 25s and 1 half Sheet at 20s, 6.0.0.; for Paper 4 Ream and 1/4 a 16s, 3.8.0.; for Binding 400 a 4d per, 6.13.4; total 16.1.4"; and on 16 Dec, the Rev. David Evans bought a copy of his own sermon (Miller 50). To judge from the surviving accounts, the edition of Barclay's Apology that BF imported from his brother James continued to sell well (12 Jan [2 copies], 21 Jan, 20 June [6 to Whitemarsh], 23 Aug, and 14 Oct).

Various job printings are recorded. Under Feb, BF charged Joseph Breintnal and Charles Brockden twice for 86 mortages (Miller A47 and A48), once for 86 bonds and judgments (Miller A49), and once for 86 bonds (cf. A50); also under Feb, BF charged the loan office for advertisements (A51); on 1 March, Dr. Jones paid for Welsh tickets (cf. A40a); on 8 May, John Spence paid for a half ream of tobacco papers (A56); on 11 July Nicholas Scull paid for 200 bail bonds (A53; cf. Miller A52); on 23 Aug, Francis Bowes paid for 500 writs (A46); and on 20 Oct, Nicholas Scull paid for 200 bail bonds (A55) and 200 deputations (A54).

The Shop: To the list of products for sale at the printing office, Franklin and Deborah added goose feathers on 31 July and sealing wax on 12 Sept. Though skins first appeared in 1731, they became frequent in March 1732--BF bought and sold them for binding and for parchment documents. As usual, he loaned his neighbor Mrs. Staples wood during the winter (1 Dec). BF's 7 Jan entry notes that Stephen Potts was still boarding with the Franklins and was now renting a shop, evidently beginning in Nov 1731. BF continued to run a tab for him, evidently charging no commission for the binding and pasting that Potts did for BF's customers (I. Norris, 11 Aug), perhaps because he thought this service increased his other business. In barter, John Reynall paid his account in pepper (4 May). BF settled his accounts with his partner Timothy (whose name he still usually spelled "Timothee") on 8 April and 6 Oct. (Louis

Timothee changed his name to Lewis Timothy when he moved to South Carolina.) Edward Nichols received credit from BF "For turning my Screw" (1732), presumably adjusting BF's printing press.
