



#### \*FIRST LEGISLATIVE DAY

Dover, Delaware, May 18, 1937

Senate convened in Special Session with President Edward W. Cooch presiding.

Prayer by the Rev. W. E. Matthews.

Mr. Chandler moved that W. Harry Dawson be appointed Temporary Secretary of the Special Session of the Senate.

Motion prevailed.

W. Harry Dawson was seated.

The President requested that the Temporary Secretary call the roll.

Which being done showed the following members present: Messrs. Chandler, Davis, Hannam, Kelly, Maloney, Marshall, Matthews, Moody, Moore, Poore, Simonton, Steele, Sylvester, Thomas, Walls, Wright—16.

A constitutional majority being present the Senate proceeded.

The President called attention to the State Constitution, Section 7, Article 2, and after reviewing same, ruled that the duly elected President Pro Tem of the Regular 106th General Assembly would become the President Pro Tem of this Special Session.

On motion for leave, Mr. Chandler introduced Senate Resolution No. 1, entitled:

#### SENATE CONCURRENT RESOLUTION NO. 1

#### COMMITTEE TO NOTIFY THE GOVERNOR

BE IT RESOLVED by the Senate, the House of Representatives concurring therein:

That the Presiding Officer is hereby authorized and directed to appoint a Committee of Two on the part of the Senate to act with a like Committee on the part of the House of Representatives, to notify the Governor that both Branches of the General Assembly are duly organized and ready to receive any communication he may have; and the Secretary of the Senate is hereby instructed to notify the House of Representatives of the adoption of this Resolution and the names of the Senate members of the said Committee.

Upon motion the resolution was taken up for consideration in order to pass the Senate.

On the question, "Shall the Resolution pass the Senate?"

The yeas and nays were ordered, which being taken, were as follows:

#### SENATE CONCURRENT RESOLUTION NO. 2

#### THE PUBLISHING OF FALSE AND LIBELOUS REPORTS

WHEREAS, certain out-of-State Newspapers and Magazines have been publishing false and libelous reports concerning the conduct of the Members of this General Assembly during the closing hours of the Regular Biennial Session; and

WHEREAS, the members of this General Assembly are satisfied that these false reports did not originate with any of the Members of the Press, who are regular attendants at the Sessions of the Delaware Legislature, but undoubtedly eminated from one or more scandal mongers who snook around the Legislative Building seeking notoriety for themselves by attempting to assassinate the character of people far above their own low state in life; therefore

BE IT RESOLVED by the Senate of the State of Delaware, the House of Representatives concurring therein, that the Members of this General Assembly hereby condemn in the strongest terms the unscrupulous conduct of these scandal mongers and notice is hereby given to each and all of them, if there be more than one of them, that their presence here is very offensive to all of us, and they are warned to apply their nefarious trait elsewhere; and

BE IT FURTHER RESOLVED, that we strongly condemn the unseemly conduct of the newspapers and magazines that published such false reports without taking the trouble to find out the truth or falsity of such reports.

Upon motion the resolution was taken up for consideration in order to pass the Senate.

On the question, "Shall the Resolution pass the Senate?"

The yeas and nays were ordered, which being taken, were as follows:

## STATE OF DELAWARE EXECUTIVE DEPARTMENT

#### PROCLAMATION

By virtue of the authority vested in me by the provisions of Section 16 of Article III of the Constitution of the State of Delaware, whereby "He (the Governor) may on extraordinary occasions convene the General Assembly by proclamation,"

I, Richard C. McMullen, Governor of the State of Delaware, do issue this my proclamation:

That the One Hundred and Sixth General Assembly of the State of Delaware shall convene at Dover, the Capital of the State, on Tuesday, the eighteenth day of May, A. D. 1937, at eleven o'clock in the morning, to consider and act upon the following matters:

- 1—To enact legislation providing for an appropriation for the School Budget for the years beginning respectively July 1, 1937 and July 1, 1938 and ending respectively June 30, 1938 and June 30, 1939.
- 2—To enact legislation which will provide for the diversion or transfer of future Franchise Tax receipts to the General Fund, to be used to meet the appropriations required of the State for the University of Delaware, the State College for Colored Students and the State Tax Department, for the biennium beginning July 1, 1937 and ending June 30, 1939.

IN WITNESS WHEREOF, I, Richard C. McMullen, Governor of the State of Delaware, have hereunto set my hand and caused the Great Seal of the said State to be hereunto affixed this fourth day of May, in the year of our Lord one thousand nine hundred and thirty-seven and of the Independence of the United States of America, the one hundred and sixty-first. ## STATE OF DELAWARE EXECUTIVE DEPARTMENT

May 18, 1937

To the Honorable, the Members of the Senate, The 106th General Assembly, State of Delaware, Dover, Delaware.

#### Gentlemen:

You have been called together in Special Session in order to consider legislation necessary to enable the State of Delaware to carry out its duties to our citizens during the next biennium.

It is my recommendation that you consider the following matters:

- 1. To enact legislation providing for an appropriation for the School Budget for the years beginning respectively July 1, 1937 and July 1, 1938 and ending respectively June 30, 1938 and June 30, 1939.
- 2. To enact legislation which will provide for the diversion or transfer of future Franchise Tax receipts to the General Fund, to be used to meet the appropriations required of the State for the University of Delaware, the State College for Colored Students and the State Tax Department, for the biennium beginning July 1, 1937 and ending June 30, 1939.
- 3. To enact legislation appropriating the sum of \$19,000.00 for the indigent deaf, blind, dumb and crippled children of the State for each of the two fiscal years ending June 30, 1938 and June 30, 1939.




