Zero tolerance issue not going away

Family may continue campaign against stringent codes

Zachary Christie will be going back to school, but it's unlikely to halt intense criticism over the Christina School District's zero tolerance conduct policy.

The Board of Education

hastily approved an amendment to the district's code of conduct that ended Christie's suspension for carrying a piece of camping gear into Newark's Downes Elementary School.

The suspension created a furor that helped fill up the multi-purpose room at the newly opened Porter Road Elementary School in Bear. It also brought mobile units from every Philadelphia TV station to the school near Route 40.

The furor followed a story in the New York Times

on Monday and coverage by national TV networks.

Zachary's mother, Debbie, and fiancé, Lee Irving, set up a website, www.helpzachary.com that gained worldwide attention and could end up being a launching pad to opposition to zero tolerance discipline policies. Indeed, an e mail arrived at the Newark Post Wednesday from a British group praising the school board decision.

Christie was initially suspended for 45 days and ordered to attend an alternative program for troubled students that was quickly dubbed by critics as "reform school." The suspension came despite criticism

last week from legislators who had earlier passed a bill giving administrators more discretion. However, the bill did not cover Christie's case, which was not an expulsion.

Debbie chose instead to home school Zachary.

Zachary was not present at the meeting, but his mother and Irving were present to voice their displeasure with the policy, calling Tuesday night's action only a first step and taking the board to task for the zero tolerance policy, claiming there is no evidence it improves school safety.

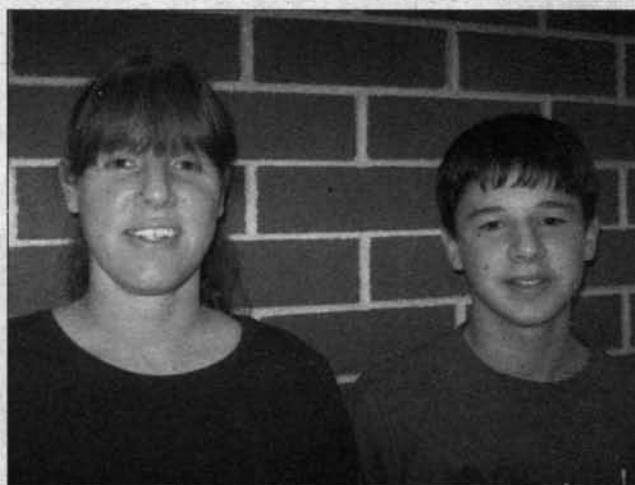

But that did not stop the 13-year-old and his mother Dodi from the taking the Christina Board of Education and middle school administrators to task at the board meeting Tuesday night. The Bear residents told board members a story of the straight A student being kicked, punched and otherwise bullied throughout the previous school year.

Complaints were met by advice from school administrators to fight back, which, if true, runs counter to policies of most school districts.

Newark man in wheelchair robbed

New Castle County Police are currently investigating a burglary that occurred Thursday morning in the community of Windy Hills adjacent to the city of Newark.

At 10:51 a.m., County Police responded to a home in the 200 block of North Dillwyn Road for a report of a burglary in progress.

When police arrived at the home, they contacted the 70 year-old male victim who was confined to a wheelchair. The victim indicated he received a knock at the front door and found two well dressed white males standing outside.

The subjects told the victim they had to cut back some trees that were interfering with the electric lines and asked the victim to allow them to come inside so they could turn off the power. Once inside, one subject distracted the victim as the other went to his bedroom and removed an undisclosed amount of cash.

Witnesses reported seeing the suspects fleeing the scene in a black newer model Chevrolet Suburban with tinted windows.

Youth caught breaking into cars

Newark Police have apprehended a 13 year-old minor who has been charged with Theft Under \$1,500 for unlawfully entering vehicles and removing items from them. Several witnesses identified the youth as a black male wearing a blue sweatshirt, red hat, and a drawstring backpack. One of the victims observed the minor rummaging through his car when it was parked outside of a store on Haines Street. The youth ran when the victim confronted him. Two witnesses later saw the 13 year-old attempting to break into a Lexus and a Dodge truck that were parked in the parking lot for Ali Baba Restaurant, located off of South Chapel Street. A Newark policeman finally witnessed the male as he was in the rear passenger side of a Ford Taurus in an adjoining parking lot. A nearby Volkswagen Jetta showed that its CD faceplate was removed.

After being taken to the police station for questioning, the youth admitted to breaking into the cars over a two-day period and to an attempted break-in of another vehicle: a Chevrolet Tahoe. The male

admitted to taking all of the following items, which included a Sony Xplod head unit and remote, several jewelry pieces, a Verizon LG cell phone and charger, a Sirius satellite radio, Apple iPod earbuds, a check for \$1,094.21, an unknown charger, a pair of Old Mill blue shorts, a car alarm lock unit, and several other minor items. The youth was released on \$550 unsecured bail and into the custody of his father.

Copper stolen from Louviers FCU

Approximately 60 feet of 1 1/2 inch, brand new, commercial grade copper pipe and accompanying copper fittings were taken from the Louviers Federal Credit Union construction project on Elkton and Apple Roads. The total value of the copper is over \$1,200.

The copper piping was forcibly removed from a second floor location by bending it back and forth until it broke. The remaining section of pipe showed a pinched end where it was removed. Representatives of the project stated that the site is fenced and gated and that any access to the building is secured at night.

Police contacted Elkton Recycling, on Dogwood Road in Elkton, MD, to see if anyone had brought in any copper to sell. A 20+ foot section, of a similar grade and diameter as the stolen copper and bearing

a pinched end, was located at the business. Though paperwork has not been found so far for the transaction, Elkton Recycling is providing assistance to Newark Police in the case.

Police: Girlfriend's car sold for drugs

A Newark man has been accused of stealing his girlfriend's car in return for receiving drugs.

Charged was Andrew Pruitt, 26, of Paper Mill Road. On Sept. 16th, at around 10:00 a.m., Troopers were called by Pruitt who advised officers that he was in the parking lot of the Gulf Station, 2603 Capitol Trail, when he was approached by three or four male subjects. Pruitt claimed he was assaulted and his wallet and cell phone were stolen.

Pruitt had an injury to his face; however, witnesses contacted at the scene advised they saw no such altercation. Troopers took the report and continued to investigate Pruitt's claim.

On October 10th, Troopers were called to a Paper Mill Road address in reference to an Unauthorized Use of a Motor

Vehicle report. In this case, it was determined that Andrew Pruitt had taken his girlfriend's vehicle, a 2004 Subaru Legacy, without her permission and fled the home.

Officers went on to look for the vehicle. While officers were out canvassing the vicinity, they got a call from the vehicle's owner who advised Pruitt was back at the home, however, he could not advise where the missing car was. Before officers could respond and apprehend him, he left the house again.

The following morning, October 11th, Troopers received a tip call advising Pruitt was at a residence in Newark. A computer check revealed Pruitt was currently wanted for failing to appear in a Court of Common Pleas, so Troopers responded to this Newark home and took him into custody without incident. He was transported back to Troop 6 for questioning.

Pruitt told officers he had actually traded his girlfriend's car in exchange for drugs in the City of Wilmington. He did not know where the car currently was and did not know who he traded it to.

After learning this information, Troopers re-interviewed Pruitt about the original robbery report from September (it turned out the same shift that working the day the robbery claim was made was working

School Board to review practices

They were joined by other speakers, one of whom claimed the board was "on auto pilot" in handing out expulsions without seriously considering each case.

The amendment, passed by the board, would limit suspensions to five days and is retroactive to the start of school, meaning that Christie already served his suspension.

Board member John Young

said the amendment is a starting point, but added that the entire code needs to be reviewed.

Board member David Resler also asked whether the most stringent aspects of the code should be reviewed for all grades in the district.

Clearly on the defensive was long-time Board President George Evans, who said the issue was to have been discussed in November, but seemed to indicate that the pace of events made the change necessary.

He also pointed a finger at the Delaware General Assembly for requiring such measures. That claim was disputed by State Rep. John Kowalko, D-Newark, who attended the meeting. Kowalko said he was angered by the remark from Evans, who he considers to be a friend. Kowalko said he understands challenges facing school boards, but claimed nothing coming out of Dover required the suspension.

The board is expected to take up the issue again at a

workshop in November.

Christie and Irving made it clear on their website that the board needs to do much more.

"Unfortunately, while the school board did act to ensure that the youngest children in the Christina School District won't fall victim to zero-tolerance policies, they did nothing to address older students. There is no evidence that zero-tolerance policies do anything to reduce school violence, and there is significant evidence that these policies harm students," they wrote on the website.

"It is our hope that by work-

ing with the school board and local lawmakers, we'll be able to overturn and do away with all zero-tolerance policies and put into place policies that will take into consideration a student's age, intent, disciplinary history, and other circumstances that arise on a case by case basis. Additionally, it is not only the Christina School District that is using these draconian policies. We have heard stories from families all over the country who have had children who were victims of these policies. We will work with advocacy groups and educators

anywhere we can to make sure that zero tolerance policies are no longer used in our schools," they stated.

In other action, members of the AFSCME union said the district has not agreed to meet with union representatives about a contract. The public employees union is organizing bus drivers in the district.

A district teacher and union representative also told board members that computer equipment in the district is in poor condition, with a machine at the Newark High School library being out of order since July.

Things came to a head when one student dropped a knife in Kyle's lap, with police quickly informed that he was in possession of the potential instrument and he was suspended.

Kyle, an eighth-grader, is currently being home schooled. However, Dodi Hebert has been

working to clear his record and charged school administrators and board with doing nothing for five months.

Dodi said she chose not take her case to the media, but after witnessing the outrage arising from suspension of Zachary Christie, decided to speak out.

Kyle told the board he hoped to one day look back that his travails "happened for a reason

and not a bad reason."

Dodi Hebert says Kyle didn't have problems in the Christina District prior to entering Kirk.

The Christina District did not respond to a request for comment on the matter.

She says another child, currently enrolled in the district, will not attend middle school.

Thus, this is a very relaxing time of the year. It's a time for families to enjoy the cool fall breeze, appreciate the beauty in the colorful changing leaves, and the smell of spice cookies. Fall also offers numerous opportunities for your family to bond through very creative and exciting hands-on activities, which provide all of us with a little trick or treat.

One activity that is not only fun for the kids, but also the kids at heart, is to go to a local orchard or store to pick out a pumpkin for carving. The following two websites offer a

Move to drop water rate study criticized

The League of Women Voters of New Castle County, with over twenty-five members residing within the city limits of Newark, supports "resource conservation and environmentally sound policies that reduce energy growth rates and emphasize energy conservation."

It was distressing to observe at the August 24, 2009, City Council meeting that once again the study of Newark's rate structure for water will not occur this year because staff decided to defer the study due to budget constraints.



This simply is not acceptable.

The League of Women Voters is asking the City to embark on the water rate study as well as the electrical rate study this fiscal year. The current rate structures for water and electricity do not encourage conservation the least bit.

The League was extremely disappointed that Council did not tie a rate study to the vote in support of the water hike. We urge Council to direct City staff to complete the rate structure studies for both water and

electricity by the end of 2010.

We would like the rate studies to address:

- Declining consumption effects on city revenues
- Reducing negative impacts on low to moderate income families
- Meeting the state requirements to comply with conservation (as the rate is currently calculated this will have a devastating effect on the entire City)
- Transparency in the explanation of billing
- Hearings open to the public on the results of the rate studies prior to a vote by City Council.

League members understand that electricity and water conservation will impact city revenue. Therefore, a comprehensive study of city finances and revenue sources should also be considered.

The City of Newark has been developing public use properties since the mid-1900s. Tax amnesty nearing close

Gov. Jack Markell and state finance officials reminded taxpayers that they have less than three weeks to take advantage

of the state's Voluntary Tax Compliance Initiative that will allow individuals and businesses to pay outstanding State of Delaware tax lia-

bilities without penalty. The deadline for enrolling in the program is Oct. 30.

"This amnesty program is generating crucial funding to

help government meet its core commitments, such as teachers in the classroom, police on the street and care for our most vulnerable citizens,

while also benefiting taxpayers," Markell said.

The Voluntary Tax Compliance Initiative is a one-time tax amnesty pro-

gram designed for individuals and businesses to pay their outstanding State of Delaware tax liabilities, free of penalty and interest.

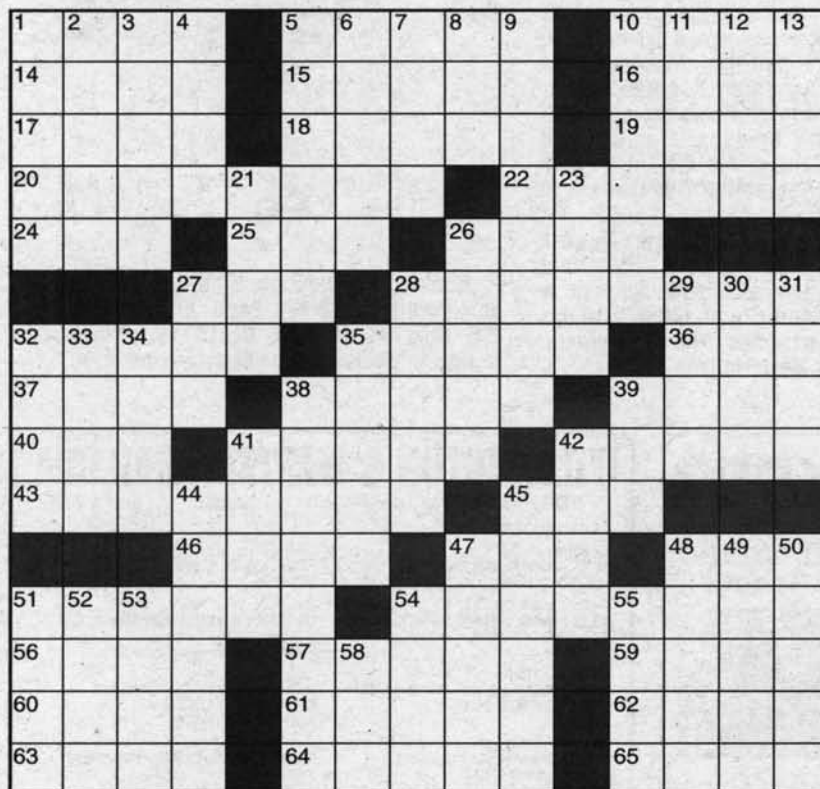
All balances must then be paid in full by June 30. The Division of Revenue also expects a number of its accounts - some more than a decade old - will be paid in full this year, which decreases Revenue's in-house collection costs.

"Enrolling in this program allows taxpayers to avoid costly penalties and fees while making their balances smaller and easier to manage," said Acting Secretary of Finance Tom Cook.

To take advantage of the tax amnesty program, taxpayers must register with the State of Delaware by Oct. 30. To register, call (877) 551-5233 or visit www.delaware.gov.

"We want everyone to know that they only have until October 30, to register," said Division of Revenue Director Patrick Carter. "After that, penalty and interest fees remain, and tax liability balances will be significantly higher than they are right now."

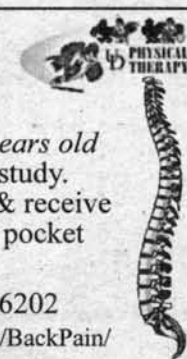

Newark hopes to tap into ticket program

Newark hopes to eventually earn a deal with state government that would tie unpaid parking tickets to registration of vehicles.

The State of Delaware struck a deal with the City of Wilmington that bars motorists with too many unpaid tickets from renewing their registrations, until those fines are paid.

Carol Houck, assistant to the Newark City Manager said the Wilmington initiative is a pilot program.

Should it succeed, the city would be eager to get on board, Houck said.

Houck says she understands that when news of the program broke last week, municipalities in the state were quick to make inquiries to the Department of Motor Vehicles.

The agency may be a little gun-shy about widening the pilot, she notes. The City of Newark also wants to make sure that its computer systems can handle any interchange of information with the state.

The city currently has unpaid tickets from Delaware-registered vehicles that amount to several hundred thousand dollars, Houck says.

Collecting the ticket revenues would add a boost to battered municipal budgets in the state, including Newark, which faces a shortfall of a few million dollars.

on this day as well and troopers remembered him).

He admitted lying to police about the robbery and advised he was beaten up in the City of Wilmington by a group of males who thought he had drugs or money on him. He concocted the robbery story to cover his tracks.

Businesses victims of vandals

Police are investigating multiple counts of criminal mischief in the 100 block of Sandy Drive, Newark. Video footage shows two

individuals: one wearing a dark jacket, another wearing a light-colored sweat jacket. Both suspects have their jacket hoods pulled over their heads. A time stamp on the footage shows the crimes being committed between 1 am and 1:30 am on Thursday, October 8.

Trailer taken from site

An investigation is ongoing into the theft of a 24-foot trailer stored in the fenced-in lot at E-Z Lift at 132 Sandy Drive. The owner told police that he arrived at the lot to find that the front gate was open and that his trailer was missing. The trailer weighs 1,900 pounds and is valued at \$4,600.

A video surveillance camera shows an individual in a light colored, older model Ford Bronco or Chevy Blazer pulling up to the gate and manipulating the lock. Several minutes later, the same individual opens the gate, backs the vehicle up to the trailer, and is seen hooking the trailer up. After a few more minutes, the vehicle leaves the lot with the trailer.

Additional businesses have been contacted in an attempt to recover additional footage. Police also conducted a search of nearby neighborhoods in an attempt to locate the trailer. So far, the search has produced negative results.

Graffiti found on Barksdale

Newark Police officers were dispatched to Elan Park for a graffiti complaint. Several signs and trash cans displayed the tags DEEP, PB, BBUD, and EAGER. The tags PB and BBUD were seen on signs on Barksdale Road. PB has also been seen on the sign for

Abbotsford and on a sign in Country Hills. Police have taken photos of all graffiti evidence and have entered them into a VeriPic database for further review.

Teens break arm of robbery suspect

New Castle County Police Sunday arrested a Penns Grove, N.J. man for attempting to rob two teen-agers who had just withdrawn money from an ATM machine. Police arrested Michael Wells, 31, after he attempted to rob two teenage male victims at gunpoint.

On Sunday at 7:52 p.m., County Police responded to the Brookside Shopping Center for a report of a fight in progress between individuals who were armed with a gun and a baseball bat. When the officers arrived, they found a number of persons who appeared to be attempting to break up a fight. Two males were treated by paramedics at the scene and transported to the Christiana Hospital where they were treated for injuries.

The investigation revealed that two teenage male victims had just removed money from the automatic teller machine in the shopping center and had returned to their car. Wells then approached and attempted to start a conversation at which time he brandished a handgun and pointed it at the victims.

Wells was able to remove some cash from one of the victims who grabbed the gun, which resulted in a struggle. The other victim then exited the car and armed himself with a baseball bat. He proceeded to strike the would-be robber with the bat as the three struggled with the gun. In the end, one of the victims sustained a laceration to his face that required sutures. Wells sustained a broken arm. The handgun turned out to be a BB gun that resembled a real semi-automatic weapon.

Wells has been charged with robbery in the first degree, attempted robbery in the first degree, possession of heroin and possession of heroin within 1,000 feet of a school. He has been arraigned and committed

to the Howard Young Prison after failing to post \$31,500 secured bail.

State Police were called to Delaware Park for a report of a 12-year-old child who was left in the car alone in the parking lot.

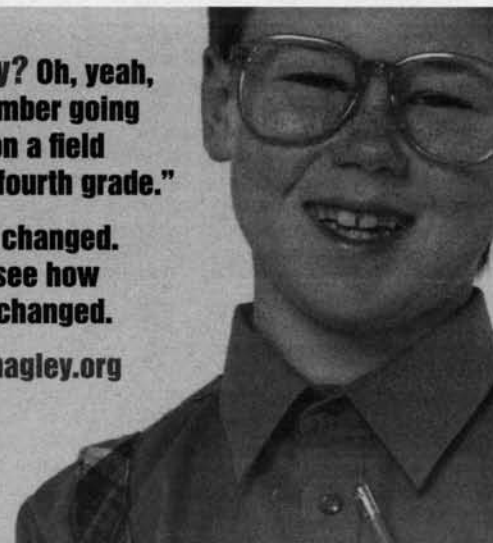

would be able to see the child from inside the facility.

The boy was taken back to the security office and troopers were called in to investigate. It was ultimately determined that the boy and his mother arrived at this location at approximately 6:30 p.m. The mom went into the facility and left her son alone in the parking lot for over two hours.

The boy's mother was located in the main building and brought to the security office. She told authorities that she came to Delaware Park to win some money to take her son to the movies.

The Division of Family Services was contacted and advised of the incident.

The mother was released on a \$500.00 unsecured bond. The boy was turned over to a family member. Her identity was not released to protect the identity of the child.

Boy killed by train

A boy was killed west of Elkon, Sunday, when he was struck by an Acela Amtrak train. The accident came less than a week after a Newark woman was killed by a CSX freight train on the west side of Newark.

The boy lived with his family in the Whispering Pines trailer park off of Route 7, about a half-mile from where he was struck.

Police reported that an Amtrak Acela 2035 train struck the boy about 5:15 p.m. Sunday as he crossed a straightaway section of tracks near Patriotic Lane, an access road that is a short distance south of the railroad bridge on Route 7.

Student robber sought

The University of Delaware Police Department is seeking the public's help in locating Jesse James Manwaring, 30.

**Manwaring**

University Police have arrest warrants for Manwaring for his role in a theft from a UD student. UD police allege that Manwaring, along with two accomplices, met a UD student at a local bar and offered him a ride home.

While at the student's residence hall room, it is alleged that Manwaring and one of

the accomplices took property exceeding \$1,500, belonging to the student and his roommate. UDPD Detectives, along with New Castle County Police Operation Safe Street team, have arrested the two other subjects involved. Manwaring, who resides in the Milltown area of Kirkwood Highway, is 5 feet 7 inches tall, weighs 150 pounds and has brown hair and blue eyes. Anyone who knows Manwaring's location should contact UD Police at (302) 831-2222, or call 911 for their local police agency.

Dumping suspect caught on camera

A digital surveillance camera helped the DNREC Environmental Crimes Unit identify and arrest a Newark-area man for illegal dumping.

After 2008 legislation was passed to crack down on illegal dumping in Delaware, cameras have been deployed to monitor various sites statewide. The cameras are regularly checked and maintained by DNREC Environmental Protection officers (EPOs) with the Environmental Crimes Unit.

On Oct. 5, EPOs checked the camera at Garashces Lane in Wilmington and found it had recorded a dump truck - including its license plate - emptying a load of roofing

materials at the site on Oct. 3.

Following an investigation, EPOs arrested the driver, Egar Tapia, 43, of 203 Coventry Lane in the Ogletown area, and charged him with illegal dumping.

Tapia was arraigned, pled guilty and was fined a total of \$637. As part of the restitution, he was ordered to clean up the materials dumped at the site.

To report possible illegal dumping or other environmental crimes, citizens may call DNREC's toll-free, 24-hour environmental complaint line, 800-662-8802. Verizon wireless customers in Delaware can reach the complaint line by calling #367 on their cell phones. Citizens are also encouraged to reported locations used for suspected illegal dumping to be investigated and considered for camera placement.

Store robbed

Delaware State Police are investigating an early morning robbery at a 7-11 store, east of Newark on Red Mill road.

At approximately 12:30 a.m., a black male suspect entered the store, confronted the clerk, produced a "butcher" style knife and demanded money. The clerk complied and turned over an undisclosed amount of cash to the suspect

before he fled on foot.

Two charged with burglaries

New Castle County Police have arrested two male subjects and charged them with burglary related offenses after an off duty police lieutenant observed the suspects running through the woods away from a home while wearing gloves. The officer followed the suspects in his personal vehicle and called for patrol units who later stopped the two suspects and recovered stolen goods from the trunk of their car. Both suspects have been linked to a total of five residential burglaries so far, however, additional charges are pending.

Since the end of August, County Police Detectives have been investigating a series of burglaries that had occurred in the Winterthur, Mount Cuba and Centerville areas of Delaware. Based on information gleaned from the investigation, witnesses reported seeing a green colored Cadillac that was occupied by two white male subjects in the area around the times of one of the break-ins.

On Friday, October 2, at

1:35 p.m., the son of a county police detective called his father and told him he had just witnessed two white male subjects who had parked a car (green Cadillac) on Paper Mill Road. He indicated he watched the subjects as they walked into the wooded area toward the community of Chestnut Valley. While detectives were en route to the suspicious car, off duty police lieutenant (Gerard Donovan) and his son were traveling along Paper Mill Road when they observed two subjects running out of the woods and getting into a green Cadillac.

Lieutenant Donovan was aware of the recent burglary trend and was familiar with the green Cadillac that was sought by detectives, so he followed the car and called 911. Assisting county officers then moved in and stopped the car on Kirkwood Highway near the Red Mill Shopping Center. Both occupants were detained and later arrested for two counts of burglary after police recovered stolen goods from the trunk.

The suspects have been identified as Joseph R. Blevins, a 26 year old male who resides in the Woodland Apartments in Wilmington and Christopher Miller, a 27 year old male who resides in the Murray Manor Trailer Park.

Both Blevins and Miller

were arrested for two counts of burglary and related offenses on Friday, October 2nd. They were both committed to the Howard Young Prison after failing to post \$22,500 secured bail. Blevins has since posted bail and has been released. He is now wanted again for the additional three burglaries (listed below) based on arrest warrants that were signed on Monday. Miller remains in prison.

As a result of several search warrants and the recovery of multiple stolen items, detectives were able to link the suspects to at least three other burglaries that occurred over the past few weeks at the following addresses:

- A home in the unit block of Ascension Drive in Wilmington,

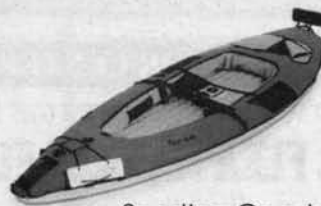

Demo of Gilbert Hall to be finished in early '10

The demolition of the University of Delaware's Gilbert residence hall complex managed by Whiting Turner Contracting Co., of Wilmington, is slated for completion early in 2010.

ABHA Associates of Wilmington is the architect for the Gilbert project.

"This involved a good deal of pre-planning and coordination with the city of Newark," Penny Person, assistant director of facilities planning and construction, said. "There also are several issues involved, including safety and environmental concerns."

The demolition of the 1960s structures involved asbestos abatement and the removal of six three-story buildings constructed of concrete, masonry, asphalt and metals. More than 90 percent of the demolished material is being recycled.

"To ensure safety of adjacent spaces and pedestrians, we planned for safety fencing, site-adequate lighting around the perimeter, and provided sediment and storm water

management control," Person said.

Person said that a feasibility study for new student residences on East Campus is being developed, with the goal of providing sufficient housing to replace some of the existing residence hall complexes located on UD's West Campus.

As part of its Path to Prominence Initiative for the Planet, the University is currently evaluating options for hosting 2-megawatts of ground and roof-mounted solar panel arrays in various campus locations.

The potential installation of solar panel arrays reflects a sustainability effort that includes reducing UD's carbon footprint and promoting renewable energy technologies in the state.

Completed summer construction projects included:

- Roof replacement projects for the UD Bookstore and Center for Counseling and Student Development in the Perkins Student Center. Contractor was Stocum Contracting Co., of West Chester, Pa. Hartshorn Hall also received a roof replacement, with Whiting Turner as the contractor.

- The softball fields located

southeast of the Bob Carpenter Center adjacent to Route 4 underwent renovations that included expanding dugouts, miscellaneous site work to add handicapped parking, and increased seating capacity to about 500. The project also included a new press box and a

new storage facility. Contractor is Whiting Turner, and architect is Tetra Tech Associates of Newark.

- The entire HVAC system for Smith Hall was replaced. Nason Construction Co. of Wilmington was the contractor with STV Inc., of Pennsylvania,

the design engineer.

Upcoming projects include the renovation of Alison Hall East, slated to begin in the summer of 2010.

The three-phase project will include the replacement of mechanical, electrical and plumbing systems. A new

fire protection system will be installed, and architectural changes will include a new roof, upgraded interior finishes and modifications to accommodate ADA building access. Architect is Tevebaugh Associates of Wilmington.

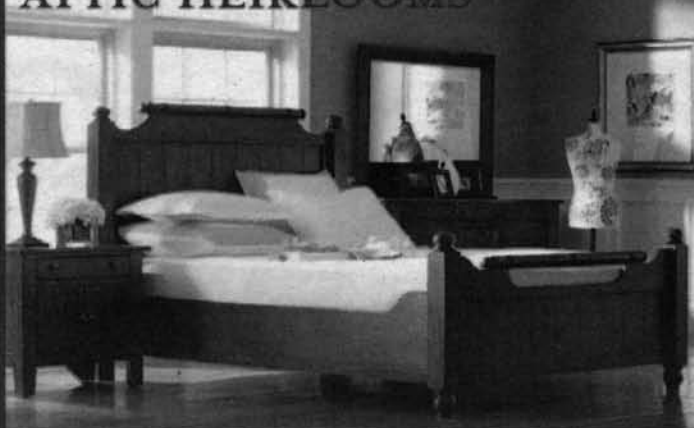

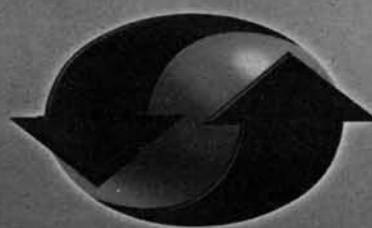
