

**Introduction:** Colonial America's most famous confidence man, Tom Bell, turns up in the accounts when Mr. Crosdale paid for an ad concerning him (7 July). Daniel Benezet (25 Aug), a fellow member of the Union Fire Company and of the Philadelphia Corporation, and Lyndford Lardner (25 March), a lawyer and another member of the Philadelphia Corporation, both charged items with BF in 1743. So too did the Philadelphia almanac maker William Birkett (17 Sept) and schoolteacher Charles Peale (4 June), father of the artist Charles Wilson Peale. Two Boston connections make an appearance: the bookseller Joshua Blanchard (9 July) and the postmaster Ellis Huske (17 Feb). Old William Bradford (1663-1752) of New York, with whom the impecunious BF sought employment when he ran away from home in 1723, borrowed £6 from the young printer sometime before 17 March, when he repaid it. The account with Robert Grace on 17 Nov may suggest that the ironmonger was already making and selling versions of Franklin's Pennsylvania stoves. BF employed his brother-in-law Captain Robert Holmes to ship goods to the Boston bookbinder and bookseller Charles Harrison: on 31 May BF sent "to bind 100 Pens. Laws. [Miller 288]; 175 first & last Sheets of Watts Hymns [Miller 266] & 39 Tate & Brady's Psalms; Dr. for 350 Alleins Alarms [Miller 225] & 250 Row's Joseph [Miller 178]." BF's accounts with the Virginia printer William Parks (27 Aug) reveal that Theophilus Grew was making the mathematical part of the Virginia almanacs for Parks. Another printer, the German Christopher Saur (6 Oct), bought type, which he could return if it were unsatisfactory. In barter, BF took a walnut table (9 April) from John Read, his brother-in-law, a carpenter.

**Imprints.** Writing for the revivalists among the Presbterians, Samuel Finley

(Miller 322) published a refutation of John Thomson's Old Side Presbyterian attack. Miller noted that the Rev. Samuel Blair bought 63 copies (19 Nov) but did not mention that BF sent 100 copies to the Boston binder and bookseller Charles Harrison on 13 June, nor that John Boyd (with James Boyd and James Coghran) purchased 150 copies on 31 Aug and paid 11.15.0 toward the price on 7 Dec. Franklin's second Indian treaty (Miller 337) sold well locally and was twice reprinted. On its publication, 9 March, Thomas Griffiths and Samuel McCall each bought a copy. Richard Hill (16 March), Charles Norris, and Samuel Norris bought copies on 17 March, and Peter Bieler, William Morris, Jr., and Joseph Wharton did on 24 March. Thomas Penn bought six copies on 23 April; and Lyndford Lardner bought one on 22 Sept. Perhaps Franklin finished printing Pamela in 1743, for one set of the two volumes (Miller 293 and 338) was evidently purchased on credit by Robert Grace, 1 Nov.

The Pennsylvania Assembly paid Franklin the remaining £211.0.0 for printing the complete laws (Miller 288) and £154.6.4 as clerk and for printing the votes, etc. (13 Aug). The latter pay probably did not include his old civic project, A Bill for the better Regulating the Night Watch (post 11 Aug): not only was it [Miller 335] probably printed after the payment made on the last day (13 Aug) of the 1742-43 assembly, but BF made a note of the "city bill" on 29 Jan 1744. BF finished printing the Delaware Laws (Miller 232), charging a total of 90.12.6 (6 July), but three pounds was an error, making the total 87.12.6. The papermaker Matthias Muris / Meuris, who first appeared in the accounts in 1742, became a major supplier to BF. Meuris bought "Rages 1650 [pounds] (30 March) and "A Pair Paper Molds" (6 April) from BF and paid on 23 May by credit for a variety of papers. The 27 Jan account with Isaiah Warner reveals that Franklin

previously printed the Pennsylvania Gazette on paper made by the Dewees family.

**The Shop.** New or unusual items sold by Franklin in 1743's accounts include "a fountain pen" (4 Jan), veal (8 March), "White Chappel Needles" (10 July), varnish (20 July), gold lace (24 Aug), billiard balls (3 Sept), "Earthen Potts" (4 Oct), and "A Sconce" worth 3.10.0. (23 Nov). Franklin accepted for credit 107 pounds of pork from Peter Hastings (29 Feb), and "3/4 of a Cord of Hickry" for "A Bible to be paid in Wood" from Mrs. Ann Waln (5 March).

**Bookseller.** The Accounts for ante Feb 1743 contain a "Bill for Books," which includes several volumes edited by Clark ("Erasmus," "Florus," and "Ovid"), "Longinus on the Sublime," and "Mead on Poison," as well as a list of shipping and handling charges complete with "Cases" for the books and "Insurance of £165."
