Legislators, advocates mark launch of new foreclosure mediation program

Attorney General Beau Biden was joined by a bipartisan coalition of legislators and advocates to mark the launch of Delaware's mandatory foreclosure mediation program. The program, which became operational on January 19, was established last year as part of a legislative package developed by Biden's office and legislators to respond to the foreclosure crisis in Delaware. It is modeled after successful programs in other states and jurisdictions, including the City of Philadelphia and the state of Connecticut.

"The foreclosure crisis has impacted Delaware families up and down the state," Attorney General Biden said. "Losing a home to foreclosure can be devastating, and borrowers deserve the opportunity to meet face-to-face with their lender and explore all available alternatives. Mandatory mediation can help people stay in their

homes, and that's better for families, lenders and the community."

Recent years have seen a record pace of foreclosures in Delaware, with more than 25,000 foreclosure filings since 2007. The state experienced a record-setting year in 2010, with more than 6,400 filings. Biden's office and legislators produced a package of bills, passed during the last legislative session, that address Delaware's foreclosure crisis. That legislation strengthened the state's existing voluntary mediation program in several key ways:

- Mediation is no longer voluntary. When a bank files a foreclosure complaint, the law now requires that lenders and borrowers sit down one-on-one and have a meaningful conversation about a payment plan or other options before a foreclosure can proceed.

- It eliminates the income qualification for homeowners.

- It establishes a filing fee, paid by the lender, to fund the program.

- It extends the time a homeowner has to respond to a foreclosure complaint. Previously, homeowners had 20 days to respond to a foreclosure complaint. Under the new program, the foreclosure process is put on hold when a mediation conference is scheduled, and a lender cannot seek judgment until after the mediation conference takes place.

The mandatory foreclosure mediation program serves Delawareans who own a one- to four-unit home, who reside in the home as their primary residence, and whose mortgage is foreclosed upon on or after January 19, 2012. The program runs through January 2014.

Rep. Helene M. Keeley, D-Wilmington South, noted that several of her constituents are facing foreclosure. She said that the initial voluntary mediation process

was a great first step, but requiring that lenders and homeowners sit down to work out an agreement will help more people stay in their homes.

"Losing your biggest investment — your home — is nothing short of catastrophic for a person. By providing this additional step, we are ensuring that more homeowners will have the opportunity to stay in their homes and keep a roof over their heads," Rep. Keeley

said. "We hope that this mortgage mediation program will address the issue of a record number of foreclosures and that in a couple years, when this program sunsets, there will not be a need for it."

"This process provides a lifeline for many homeowners who are facing the possibility of losing their homes and need to find a solution to possibly keep a roof over their

Bill would raise minimum school attendance age to 18 years

The age at which students must attend school would be increased to 18 under legislation introduced last Thursday afternoon.

Sponsored by Rep. Debra J. Heffernan, House Bill 244 would raise the age requirement for compulsory school attendance in Delaware from 16 to 18 over a two-year period. Currently, a student who is 16 years old or older is not legally required to be enrolled in school.

"Times have changed. In the 21st century, a high school diploma is no longer optional if we want our young people and our state's

economy to be successful, we need our students to graduate," said Rep. Heffernan, D-Brandywine Hundred South. "Not completing high school puts them at a severe, lifelong disadvantage for getting a well-paying job. A high school diploma is really the minimum education for young people today who want economic success and independence."

According to a National Conference of State Legislatures report, Delaware lags behind surrounding states for average graduation rate for the 2007-08 school year. High

Newark man injured in single vehicle crash

The Delaware State Police are currently investigating a single vehicle crash in which a Newark man was injured that occurred on Tuesday morning.

The crash happened on January 24 at approximately 2:15 a.m. as Jacob Kennedy, 19, was operating a 1988 Chevrolet S-10 and was traveling southbound on Glasgow Avenue. For an unknown reason Kennedy's vehicle left the roadway and struck a pole where it came to rest.

Kennedy was trapped in his vehicle until he could be freed by responding Emergency Medical Services personnel. He was then removed from the scene and transported to the Christiana Hospital Trauma Center where he was admitted for his non life threatening injuries.

The ramp from Southbound DE Rt. 896 onto Glasgow Avenue was closed for approximately 50 minutes as the crash was investigated and cleared.

This crash remains under investigation at this time.

Police seek assistance with identifying two suspects who damaged surveillance cameras

New Castle County Police are currently investigating a criminal mischief incident that occurred over the



weekend, to an office building in the community of Meadowood in Newark.

On Tuesday, January 24 at 10:41 a.m., County Police responded to the unit block of Meadowood Drive for a report of a criminal mischief that occurred over the weekend. When the officer arrived, he learned that two unknown male subjects had damaged two surveillance cameras that were attached to the exterior of the office building on Sunday night between 9:45 and 10:35 p.m.

The suspects are described as two white males, 17 to 19 years of age, one wearing a navy blue hooded sweatshirt with black jeans and a Pittsburgh Pirates baseball cap with dark sneakers, and the second suspect is wearing a gray hooded sweatshirt with the number 12, blue jeans and white sneakers.

Claymont man arrested for indecent exposure

On January 20, the Newark Police Department arrested 40 year-old John M. Krok, of Claymont, for one count of Indecent Exposure after he exposed himself on East Main Street to a 21 year-old female University of Delaware student from Wilmington.

At approximately 5:45 p.m. the suspect pulled his vehicle, a black Mercedes Benz, over onto the shoulder of East Main Street at Academy Street. The suspect then asked the victim, who was walking on the sidewalk, for directions. When the victim looked into the vehicle she observed that the suspect was exposing his genitalia. The victim then walked away from the vehicle which pulled away westbound on East Main Street. The victim then reported the incident to Newark Police.

Several hours later, at 8 p.m., an officer on patrol observed the suspect vehicle, again traveling on East Main Street, and initiated a traffic stop. The driver was taken into custody for questioning and was positively identified by the victim.

Krok was charged and released on \$250 unsecured bond.

Police investigate multiple criminal mischief incidents to motor vehicles

New Castle County Police are currently investigating a series of incidents where vehicle tires have been damaged throughout the community of Windy Hills in Newark.

The Delaware State Police are currently investigating the armed robbery of a Newark area store that occurred Saturday night.

The incident happened at approximately 7:45 p.m. on January 21, as a male suspect armed with a handgun entered the Metro PCS Store located in the 700 block of Pulaski Highway, Newark. The suspect then confronted a 19 year-old female employee who was standing behind the sales counter and demanded money from the register. The clerk complied with the suspect's demands and turned over an undisclosed amount of money to the suspect. The suspect then fled from the store in an unknown direction. The employee was not injured.

The suspect is listed as a

black male, 5'10"-6'00" tall, 150-180 lbs. He was last seen wearing a dark grey or black hooded sweatshirt, blue jeans, black gloves, and a black ski mask. He was also armed with a revolver style handgun.

Police investigate multiple thefts from vehicles and sheds

The Newark Police Department is investigating 12 weekend incidents of theft from unsecured vehicles, sheds and yards in the community of Nottingham Green. In all instances, entry was gained through unsecured shed or vehicle doors. After gaining entry, the suspect(s) removed items including a power generator, snow blower, gasoline, hunting equip-

ment, several wallets, a digital camera, CDs and loose change. In total over \$6,000 in property was stolen.

Newark Police investigate two strong arm robberies

The Newark Police are investigating two strong arm robberies which occurred in the early morning hours of January 18 in the City of Newark.

The first incident occurred at approximately 1:40 a.m. at the intersection of Cleveland Avenue and Kershaw Street. During this incident the victims, a 21 year-old female from Newark and a 21 year-old male University of Delaware exchange student from Portugal, were walking on the sidewalk of Cleveland Avenue when they were approached by three black male suspects. One of the suspects, wearing a black hooded sweatshirt with red lettering, grabbed the female and then forcibly removed her small clutch-style purse. The female victim attempted to retain her clutch during the incident and suffered a minor cut to her finger. A second suspect removed the male victim's wallet from his pants pocket. All three sus-

pects then ran to a vehicle parked on Kershaw Street and fled the scene.

The three suspects were all described as black males 18 to 25 years of age, wearing black clothing with hoods over their heads. One suspect, as described above, had red lettering on his black hooded sweatshirt. The vehicle was described as an older model tan boxy style vehicle, possibly a Cadillac. There was no tag displayed on the vehicle.

The second incident occurred several minutes later at approximately 2 a.m. at 700 Scholar Drive, University Courtyard Apartments. During this incident a 21 year-old female University of Delaware Student from Dumont, New Jersey had just entered into the apartment building which is a controlled access building. Upon entering the building lobby she heard a knock at the door and observed a black male wearing a black or grey hooded sweatshirt with red lettering standing outside the door. She opened the door for the suspect and

then turned her back to walk away. The suspect immediately grabbed her from behind, forced her to the ground, and then removed her purse before fleeing out of the apartment building. The victim was uninjured during the incident.

The suspect in this incident is described as a black male 18 to 25 years of age, wearing a black or grey hooded sweatshirt with red lettering.

Investigators are working to determine if the two incidents were committed by the same individuals and are asking for the public's assistance in identifying the suspects.

DIAA must allow Red Lion transfers to play immediately

By now if you read this column you most likely have heard about the Red Lion Christian Academy sports situation.

In a nutshell, last year the football and men's basketball programs were granted permission by the Delaware Interscholastic Athletic Association to become associate members, allowing them to circumvent some of the established DIAA rules — including enabling them to offer athletic scholarships — but in turn not be part of any conference or participate in the state tournament in either sport.

This past fall the football team played against national powerhouses in Ohio (twice), Florida, Maryland and New Jersey.

Shortly after the season ended, the church and school was taken over by nearby Glasgow Church after incurring a debt of nearly \$6 million, and Glasgow's associate pastor, Chuck L. Betters, was named head master of Red Lion Christian Academy.

Last Thursday, Betters appeared before the DIAA asking to be reinstated as full members, vowing to return the school's sports program into complete compliance with DIAA rules. Betters reported that the entire football staff and two other programs affiliated with the program — FLASH Training (Faithful Leaders Always Serving Him) and FOCAS (Financially Obedient Christians Assisting Students) — are no longer part of the school. David Needs, who previously coached at Mount Pleasant and Caravel Academy, has been hired as head coach.

The DIAA has not rendered a decision, but instead chose to form a committee to work with the school to resolve the issues that must be addressed before reinstatement as a full member is considered.

As of last Friday, 35 students, 30 of whom are football players, had withdrawn from the school following the completion of the second semester.

"We did everything we

could to keep these students at Red Lion, including allowing them to stay until the end of the year regardless of whether or not [their scholarship] was fully paid," Betters said.

While there is speculation as to where some students might end up — "You'll have to direct that question to [former Red Lion head coach] Dwayne Thomas," junior Kenny Bigelow told me when I asked if he would finish out the year at Red Lion — the bottom line is nothing has been finalized. However, one thing the DIAA must decide, and quickly since it might impact decisions, is whether or not to let any departing players compete next season at another Delaware high school.

This is where a very complicated situation and process gets very simple: The DIAA must allow these kids to play again.

The naysayers will claim that the students and their parents — or in some cases, a family relative or caregiver — chose to accept the athletic scholarships and therefore the players should not be allowed to play for a DIAA team again.

I ask you this: If you are a parent in a less-than-ideal financial situation, or even an OK one, and someone offers to give your football-playing child a free private school education with an opportunity to play on a team that is going to play a national-caliber schedule that will undoubtedly attract the attention of college scouts and potential scholarships, what would you do?

Angelo Blackson was living in the city of Wilmington, having been raised since the age of 7 by his aunt, when Red Lion offered him a scholarship that, at the time, was based on financial need. It was a no-brainer for him.

"More than anywhere else, Red Lion has helped me," Blackson said during a 2010 interview. He's now getting a college education while on a full football scholarship at Auburn University.

He isn't the only example of a naive kid making a decision even the most mature and well-off teenager might make. But what those students were promised when they chose to attend Red Lion has now been taken away, through no fault of their own. And that's why they should

not be punished, even for one season. It's not as if they can go "back" to and make up the time.

So DIAA, here's how to do it to make it fair.

For one football or basketball season, those former Red Lion players should be allowed to play football or basketball for the public-high school — note I said public, not charter or private — in the district in which they reside. In other words, play for the team at the school they most likely would have attended if they had never chosen to attend Red Lion. If they truly want to play football for the sport itself, this should be an acceptable option for them.

After that one year, they can then do as many players do and choose to go play at a different school, but also must follow the transfer rules put in place by the DIAA.

Educators always preach they are in it for the kids. This is a decision that has to be made for just that reason.

It really is a no-brainer.

Newark resident earns UAA Athlete of the Week Honors



Washington University in St. Louis senior Erica Jackey, of Newark (Archmere Academy), was selected as the University Athletic Association (UAA) Women's Indoor Track and Field Athlete of the Week, as announced by the Association.

Jackey earned the Women's Athlete of the Week honor after a record-setting performance at the Illinois Wesleyan Triangular on Jan. 21. Jackey also raced to a first-place finish in the mile (5:06.40) to lead the Washington U. women to a narrow two-point win over Illinois Wesleyan University in the triangular. Jackey's time in the 800 is the third-fastest time in NCAA Division III this season, while her mile time ranks fifth on the Division III performance list.

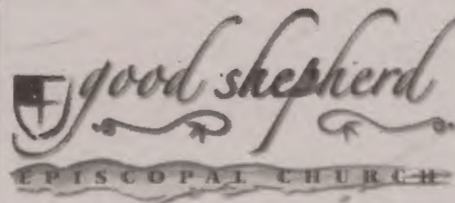

Low-tech quality time for your family

Now that the holidays are behind us, it's time to look at your family's daily use of technology. Whether it is texting on a new phone, gaming on Wii, or watching movies on a handheld tablet, many families find that they

are more digitally wired for more hours of every day than ever before. It might be time to evaluate and manage your family "media diet" by purposefully unplugging for a portion of the day. By unplugging, you can make sure time is spent in socializing with others, playing out-

side in a natural environment, and holding meaningful conversations, perhaps while eating a healthy meal together. While our smart phones and devices have brought us closer to the rest of humanity, it is the family time that really brings us closer with shared experiences and time spent together.

With a little planning, you can balance your family's tech activities with much-needed face time. By setting stricter time limits for yourself and your children, you can downsize your reliance on technology in order to create more quality family time. Make a list of activities to include in your daily and weekly schedule and agree

on use of devices with time limits.

Make sure the kids have plenty of input in the planning so that family time includes suggestions from everyone. » **FORECLOSURE**, from page 1 heads," said Sen. Bethany Hall-Long, D-Middletown. "It's not only vital for the people facing a foreclosure action, it's also vital when it comes to maintaining healthy communities and I'm honored to have been a part of this effort."

"This program will provide a renewed resilience for homeowners faced with the loss of their most prized and personal possession — their home," said Rep. John A. Kowalko, D-Newark. "There is no way to exaggerate the needs of families who are struggling in these desperate times. Their safety and security are in jeopardy and it is the state's responsibility to provide resources

and expertise so that families can stay in their homes. This process being implemented today is a huge step in the right direction to help them."

State Representative Mike Ramone, R-Middle Run Valley, a prime House sponsor of the bill establishing the foreclosure mediation program, said, "I am thrilled that we are rolling out this very important program. As I have stated before, the foreclosure process is our new reality, unfortunately. This program is vital to providing those many families faced with the painful prospect of losing their homes with the opportunity of working with a mediator — something they may not normally had the

chance to do prior to this bill being enacted last year. Mediation has been a viable option in helping families in other areas. It is my hope that Delawareans in a similar situation will find the help they need with this new program."

The legislation was also sponsored by House Speaker Rep. Robert F. Gilligan, D-Sherwood Park.

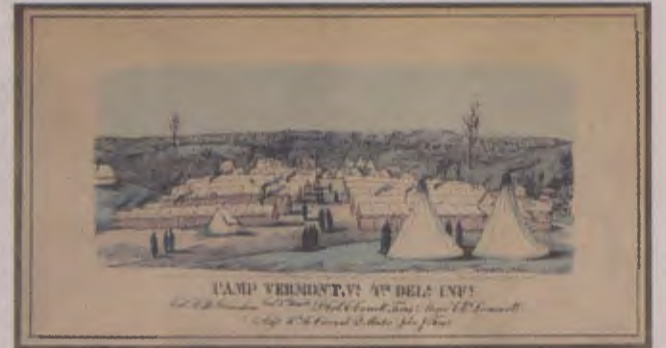

University of Delaware Library exhibition highlights Delaware during the Civil War

The University of Delaware Library has announced a new exhibition entitled "A State Divided: Delaware During the Civil War," which will be on view in the Lincoln Exhibit Case adjacent to the Special Collections Exhibition Gallery from Tuesday, Jan. 24, through Thursday, Dec. 20.

The year 2011 marked the 150th anniversary of the start of the American Civil War (1861-1865). The sesquicentennial celebration (2011-2015) is set to continue over the next three years in cultural institutions around the country to commemorate the nation's greatest conflict fought on its own soil.

As one of five border states -- states that remained in the Union but which bordered states that joined the Confederacy -- Delaware represented a microcosm of the nation as a whole on matters of states' rights, slavery, and support for the Union cause. Politics were generally

defined geographically: urban centers like Wilmington in northern New Castle County favored Republicanism, while southern agrarian Kent and Sussex counties were Democratic strongholds.

"A State Divided: Delaware During the Civil War" offers items from Special Collections including books, prints, postcards, speeches, sermons, soldiers' letters, memoirs, and other documents showcasing the

state at a social, economic, and political crossroads.

The exhibition can be viewed during the regular hours of the Morris Library. The curator of the exhibition is Maureen Cech, assistant librarian in the Special Collections Department in the University of Delaware Library.

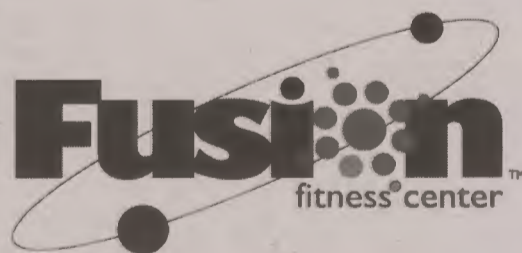

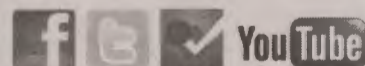

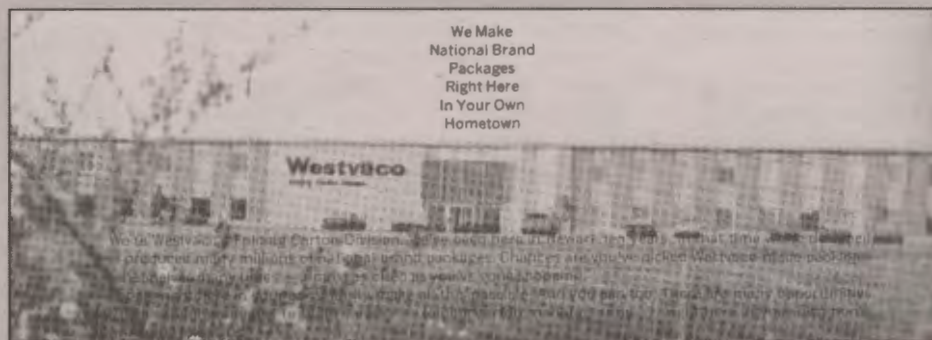

We Make National Brand Packages Right Here In Your Own Hometown

This week's Out of the Attic item is a 1975 picture of the Westvaco Plant on Ogletown Road (Route 273) east of Newark. The picture appeared in the 1975 Krawen, the Newark High School student yearbook. Fifty years ago the stretch of the two-lane Ogletown Road from the edge of town to the railroad underpass was mostly open farm fields punctuated with a few houses and barns. By the mid-1960's the picture changed to an area of light industry, distribution, and some retail. The Stafford Farm remained as the lone sentry from the past. Names such as Motor Wheel Corporation, General Foods, Southern States, R. C. Peoples, FNC Corporation, Avon Products, Morton Salt, Shep's Burgers, A & P Supermarket, U. S. Post Office, Aetna Hose, Hook, and Ladder Company, 84 Lumber Company, Thrifty Rent A Car, State Services Center, and more became the scenery, the employers, and the economic engine along the east gateway to the town. Westvaco, a division of the West Virginia Pulp and Paper Company, described its business in the overprint of the yearbook picture that reads, "Westvaco National Brand Packages Right Here in Your Own Hometown. We're Westvaco's Folding Carton Division, we've been here in Newark ten years. In that time we've designed and produced many millions of national brand pack-

ages. Chances are you've picked Westvaco-made packages off the shelves many times - almost as often as you've gone shopping. People right here in your community made all this possible, and you can too. There are many opportunities for high school graduates to build careers in folding carton manufacturing... right here in your own home town. Come talk to us."
