The 1963 fund drive to carry on the humanitarian service of the Red Cross begins this Friday in Delaware, and J. Fenton Daugherty of Newark, chairman of home area one, has announced a goal of \$329,488 for a month-long campaign.

New High School Facilities Cited By Principal Ott

Christiana High School To Open Next September Topic For PTA Meeting

Newark's new Christiana High School will open next September with most everything for its 1,155 students — from conveyor belts to band uniforms — parents were told last week by Principal Gilmore B. Ott.

Conveyor belts will be used in the cafeteria to carry meals on trays in what Ott described as a "speed line for students who wish to buy food quickly."

Band uniforms are among the multitude of items and extracurricular activities which Ott predicted will be ready when students arrive next fall.

There were 450 persons at Oglethorpe Junior High School auditorium to hear the principal describe the new school.

The \$2.5 million, 40-classroom building is at Chopin and Salem Church Roads, three-quarters of a mile west of Oglethorpe.

Ott said it will have a staff of 82, of whom 40 are now working at other jobs in the district. Eight have been hired and the remaining 14 are to be hired before school opens.

The building with a capacity of 1,200, will be operating near that level for the first year as ninth graders will go there for a year until the adjacent Christiana Junior High School is finished in mid-1964.

Ott said the school's program will parallel that at Newark High School.

The new school is not going to stress business or vocational education as has been rumored, the principal said.

Municipal Property Tax Rate Reduced From 80 To 75 Cents

Council Approves Fiscal Year Budget Of \$1,882,270 Less Anticipated Surplus Of \$97,620 With Five Cent Tax Reduction; Municipal Code Of Ethics Established

A five-cent reduction in the municipal tax rate, and a budget of \$1,882,270 for the fiscal year 1963 were approved at the regular meeting of Newark City Council last Tuesday night.

The reduction in the tax rate from 80 to 75 cents per \$100 assessed property valuation, is expected to provide a year-end surplus of \$97,620 with budgeted expenditures of \$1,784,650 for the fiscal year.

The municipal budget approved unanimously, but Councilman William M. Coverdale opposed the five cent tax cut in the 6-1 vote.

Coverdale urged that electricity rates rather than property taxes be reduced for greater equity, and objected to the proposed tax cut as a possible election campaign material.

"I don't know why anyone on council should take credit for this," Councilman Russell E. Bing replied in reference to the five cent reduction in taxes. "Give credit to Mr. Nemo," he said.

Mayor Carl S. Rankin added that any comparable reduction in electricity rates would be too small to be practical.

Comparable Rates "I feel our utility rates should be comparable with private utilities," City Manager J. Francis Neide stated, "and they compare favorably now." He recommended that relief be given to property owners with the five cent tax cut.

Ordinances establishing a \$630-\$800 monthly salary scale for planning director, and adopting a municipal code of ethics, were passed at second and final readings over Coverdale's objections.

Councilman Coverdale opposed the creation of a board of ethics, citing such a board as "superfluous" and in contradiction to PAS Report recommendations for a reduction in municipal committees.

The ordinance prepared for a second reading is to be revised to include a board of three members to be appointed by council for terms of one year each, and is to be re-advertised.

A proposed ordinance to establish an equipment sinking fund to be replenished annually for estimated depreciation and reserve was approved unanimously at a first reading when Coverdale was assured that such a fund would require no increase in taxes.

Commendation Mayor Rankin read a letter of commendation from L. D. Booth, president of the College Town, Inc., for service provided by Newark Policeman Paul Morrison with his investigation of petit larceny at the College Town Club Apartments.

"We don't get much commendation," the mayor said, "so I shall read this with pleasure."

A resolution was prepared for the vacating of a part of Winfield Drive in Fairfield Crest, and the city manager was requested to prepare a five-year budget for capital expenditures for presentation next August.

In a discussion of the Home Rule Bill, Solicitor Alton Tybout explained that under Home Rule, the city can write and adopt its own charter without state legislative approval, but the charter is subject to legislative disapproval. Tybout indicated discrepancies in the bill, and Coverdale cited the bill as "incomplete" and opposed by the Committee of 29.

Councilman Bing pointed out that Home Rule "has a good sound" and that the public might accept it on this basis.

Action was deferred pending review and restoration of the Home Rule Bill to the council agenda for the March 12 meeting.

Troop 255 received 57 out of a possible 61 nuggets to win second place in their first Klondike Derby participation.

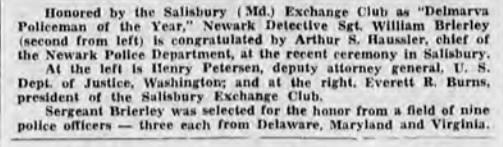
